A BILL FOR AN ACT ENTITLED: "AN ACT PROHIBITING THE CONFISCATION OF PRIVATELY OWNED FIREARMS WITHIN THE STATE FOLLOWING THE DECLARATION OF AN EMERGENCY OR DISASTER OR THE OCCURRENCE OF AN INCIDENT; PROVIDING CERTAIN RESTRICTIONS ON THE USE OF NONRESIDENT PEACE OFFICERS FOLLOWING THE DECLARATION OF AN EMERGENCY OR DISASTER OR THE OCCURRENCE OF AN INCIDENT; AND PROVIDING FOR ENFORCEMENT; AMENDING SECTIONS 7-32-302, 10-3-204, 10-3-207, 10-3-1001, 44-11-101, 44-11-302, 44-11-304, 44-11-306, AND 44-11-312, MCA; AND PROVIDING A RETROACTIVE APPLICABILITY DATE."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

~~NEW SECTION. Section 1. State policy on confiscation of private firearms -- definitions.~~ (1) It is the policy of the state of Montana that a person may not, following the declaration of an emergency or disaster or the occurrence of an incident pursuant to Title 10, chapter 3, and while purporting to act on behalf of the state or a political subdivision of the state, confiscate a privately owned firearm of another person except as provided in [sections 1 through 5].

~~(2) As used in [sections 1 through 5], the following definitions apply:~~

~~(a) (i) "Confiscation action" means the intentional deprivation by a person in Montana of a privately owned firearm.~~

~~(ii) The term does not include the taking of a firearm from a person:~~

~~(A) in self-defense;~~

~~(B) possessing a firearm while the person is committing a felony or misdemeanor; or~~

~~(C) who may not, under state or federal law, lawfully possess the firearm.~~

~~(b) "Disaster" has the meaning provided in 10-3-103.~~

~~(c) "Emergency" has the meaning provided in 10-3-103.~~

2 ~~_____ (e) "Interested party" includes the owner of the firearm confiscated or to be confiscated and a person~~
3 ~~otherwise with sufficient interest in the outcome of the issue to satisfy the constitutional prerequisites for legal~~
4 ~~standing for the purposes of the civil action authorized by [section 5].~~

5 ~~_____ (f) "Peace officer" means a peace officer as defined in 46-1-202.~~

7 **NEW SECTION. Section 1. Confiscation of firearm by government prohibited -- PRIVATE RIGHT OF**
8 **ACTION -- COSTS AND EXPENSES.** (1) Following a declaration of an emergency or disaster ~~or the occurrence of an~~
9 ~~incident~~ pursuant to Title 10, chapter 3, a peace officer or other person ACTING OR purporting to act on behalf of
10 the state or a political subdivision of the state may not take a confiscation action.

11 ~~_____ (2) The attorney general, a county attorney, or an interested party may enforce the provisions of this~~
12 ~~section as provided in [section 5].~~

13 (2) AFTER A VIOLATION OF SUBSECTION (1) HAS OCCURRED, THE PARTY INJURED BY A CONFISCATION ACTION
14 MAY BRING AN ACTION FOR DAMAGES IN A COURT HAVING JURISDICTION.

15 (3) A PARTY AWARDED DAMAGES PURSUANT TO THIS SECTION MUST ALSO BE AWARDED THE PARTY'S COSTS AND

 26 ~~by any other person purporting to act on behalf of the state or a political subdivision of the state following the~~

 4 officer or other person required by this subsection to take an oath who fails to take the oath required by this
 5 section forfeits the authority to act as a peace officer or to act on behalf of the state or a political subdivision of
 6 the state. A forfeiture is effective for the period of time that a declaration of disaster or emergency or an executive
 7 order pertaining to an incident is effective. _____

8 _____ (3) A resident or a nonresident peace officer or other person who takes the oath required by this section
 9 who engages in a confiscation action after taking the oath violates the oath and forfeits the officer's authority of
 10 and status as a peace officer in this state or, if the person is not a peace officer, forfeits whatever authority the
 11 person possesses to act on behalf of the state or a political subdivision of the state. A forfeiture is effective for
 12 the period of time that a declaration of disaster or emergency or an executive order pertaining to an incident is
 13 effective. _____

 15 _____ **NEW SECTION. Section 5. Action by attorney general or county attorney -- private right of action**
 16 **--civil penalty -- costs and attorney fees.** (1) At any time before a violation of [sections 1 through 5] occurs,
 17 the attorney general, a county attorney, or an interested party may bring a civil action in the district court for the
 18 county in which the violation may occur for appropriate relief as provided in Title 27, chapter 19.

19 _____ (2) After a violation of [sections 1 through 5] has occurred, an interested party injured by a confiscation
 20 action in violation of [sections 1 through 5] may bring an action for damages in a court otherwise having
 21 jurisdiction in the maximum amount of \$10,000, a penalty as provided in this section, or both damages and a
 22 penalty.

23 _____ (3) An interested party, in an action brought pursuant to this section, may collect and retain a civil penalty
 24 in the maximum amount of \$1,000 to be collected from a person violating [sections 1 through 5] in the same way
 25 other civil monetary judgments are levied.

26 _____ (4) A nongovernmental plaintiff substantially prevailing in an action to enjoin a violation of [sections 1
 27 through 5], collect damages, collect a penalty, or any of those actions, must be awarded the plaintiff's costs and
 28 reasonable attorney fees, including costs and fees on appeal.

29 INTERSTATE MUTUAL AID COMPACT

30 Article I



1 ~~—————The purpose of this compact is to provide voluntary assistance among participating states in responding~~
 2 ~~to any disaster or imminent disaster that overextends the ability of local and state governments to reduce,~~
 3 ~~counteract, or remove the danger. Assistance may include but is not limited to rescue, fire, police, medical,~~
 4 ~~communication, and transportation services and facilities to cope with problems which require use of special~~
 5 ~~equipment, trained personnel, or personnel in large numbers not locally available.~~

6 ~~Article II~~

7 ~~—————Article I, section 10, of the Constitution of the United States permits a state to enter into an agreement~~
 8 ~~or compact with another state, subject to the consent of congress. Congress, through enactment of 50 U.S.C.~~
 9 ~~2281(g) and 2283 (now repealed) and the executive branch, by issuance of Executive Orders No. 10186 of~~
 10 ~~December 1, 1950, encourages the states to enter into emergency, disaster, and civil defense mutual aid~~
 11 ~~agreements or pacts.~~

13 ~~—————It is agreed by participating states that the following conditions will guide implementation of the compact:~~

14 ~~—————(1) Participating states through their designated officials are authorized to request and receive assistance~~
 15 ~~from a participating state. Requests will be granted only if the requesting state is committed to the mitigation of~~
 16 ~~the emergency and other resources are not immediately available.~~

17 ~~—————(2) Requests for assistance may be verbal or in writing. If the request is made by other than written~~
 18 ~~communication, it must be confirmed in writing as soon as practical after the request. A written request shall~~
 19 ~~provide an itemization of equipment and operators, types of expertise, and personnel or other resources needed.~~
 20 ~~Each request must be signed by an authorized official.~~

21 ~~—————(3) Personnel and equipment of the aiding state made available to the requesting state shall, whenever~~
 22 ~~possible, remain under the control and direction of the aiding state. The activities of personnel and equipment~~
 23 ~~of the aiding state must be coordinated by the requesting state.~~

24 ~~—————(4) An aiding state has the right to withdraw some or all of its personnel and equipment whenever the~~
 25 ~~personnel and equipment are needed by that state. Notice of intention to withdraw should be communicated to~~

9 ~~———(1) All privileges and immunities from liability, exemptions from law, ordinances, and rules and all
10 pension, disability relief, workers' compensation, and other benefits that apply to the activity of officers, agents,
11 or employees when performing their respective functions within the territorial limits of their respective political
12 subdivisions apply to them to the same extent while engaged in the performance of any of their functions and
13 duties extraterritorially under the provisions of this compact.~~

14 ~~———(2) All privileges and immunities from liability, exemptions from law, ordinances, and rules and workers'
15 compensation and other benefits that apply to duly enrolled or registered volunteers when performing their
16 respective functions at the request of their state and within its territorial limits apply to the same extent while
17 performing their functions extraterritorially under the provisions of this compact. Volunteers may include but are
18 not limited to physicians, surgeons, nurses, dentists, structural engineers, and trained search and rescue
19 volunteers.~~

20 ~~———(3) The signatory states, their political subdivisions, municipal corporations, and other public agencies
21 shall hold harmless the corresponding entities and personnel thereof of these entities from the other state with
22 respect to the acts and omissions of its own agents and employees that occur while providing assistance
23 pursuant to the common plan.~~

24 ~~———(4) Nothing in this This arrangement may not be construed as repealing or impairing any existing
25 interstate mutual aid agreements.~~

26 ~~———(5) Upon enactment of this compact by two or more states, and annually by each January 1 thereafter,
27 the participating states will exchange with each other the names of officials designated to request and provide
28 services under this arrangement. In accordance with the cooperative nature of this arrangement, it is permissible
29 and desirable for the states to exchange operational procedures to be followed in requesting assistance and
30 reimbursing expenses.~~

 2 ~~into law by any two states. Thereafter, this compact becomes effective and binding as to any other state upon~~

17 ~~———— (b) "States" means the several states, the Commonwealth of Puerto Rico, the District of Columbia, and~~

19 ~~———— (2) This compact is made and entered into by and between the participating party states that enact this~~

21 ~~———— (3) The purpose of this compact is to provide for mutual assistance between the party states in managing~~
 22 ~~any emergency or disaster that is declared by the governor of an affected state, whether arising from natural~~
 23 ~~disaster, technological hazard, human-caused disaster, civil emergency aspects of resources shortages,~~
 24 ~~community disorders, insurgency, or enemy attack.~~

25 ~~———— (4) This compact also provides for mutual cooperation in emergency-related exercises, testing, or other~~
 26 ~~training activities using equipment and personnel simulating performance of any aspect of the giving and~~
 27 ~~receiving of aid by party states or subdivisions of party states during emergencies, those actions occurring outside~~
 28 ~~actual declared emergency periods. Mutual assistance in this compact may include the use of the states' national~~
 29 ~~guard forces, either in accordance with the National Guard Mutual Assistance Compact or by mutual agreement~~
 30 ~~between party states.~~

Article II - General Implementation

~~(1) Each party state recognizes that many emergencies transcend political jurisdictional boundaries and that intergovernmental coordination is essential in managing these and other emergencies under this compact. Each party state further recognizes that there will be emergencies that require immediate access and present procedures to apply outside resources to make a prompt and effective response to an emergency. This is because few, if any, individual states have all the resources that they may need in all types of emergencies or the capability of delivering resources to areas where emergencies exist.~~

~~(2) The prompt, full, and effective utilization of resources of the participating states, including any resources on hand or available from the federal government or any other source, that are essential to the safety, care, and welfare of the people in the event of any emergency or disaster declared by a party state is the underlying principle on which all articles of this compact must be understood.~~

~~(3) On behalf of the governor of each party state, the legally designated state official who is assigned responsibility for emergency management is responsible for formulation of the appropriate interstate mutual aid plans and procedures necessary to implement this compact.~~

Article III - Party State Responsibilities

~~(1) It is the responsibility of each party state to formulate procedural plans and programs for interstate cooperation in the performance of the responsibilities listed in this article. In formulating those plans and in carrying them out, the party states, insofar as practical, shall:~~

~~(a) review individual party state hazards analyses and, to the extent reasonably possible, determine all those potential emergencies that the party states might jointly suffer, whether because of natural disaster, technological hazard, human-caused disaster, emergency aspects of resource shortages, civil disorders, insurgency, or enemy attack;~~

~~(b) review party states' individual emergency plans and develop a plan that will determine the mechanism for the interstate management and provision of assistance concerning any potential emergency;~~

~~(c) develop interstate procedures to fill any identified gaps and to resolve any identified inconsistencies or overlaps in existing or developed plans;~~

~~(d) assist in warning communities adjacent to or crossing the state boundaries;~~

~~(e) protect and ensure uninterrupted delivery of services, medicines, water, food, energy and fuel, search and rescue, and critical lifeline equipment, services, and resources, both human and material;~~

~~(f) inventory and set procedures for the interstate loan and delivery of human and material resources;~~

1 together with procedures for reimbursement or forgiveness; and
 2 ~~—— (g) provide, to the extent authorized by law, for temporary suspension of any statutes.~~
 3 ~~—— (2) The authorized representative of a party state may request assistance of another party state by~~
 4 ~~contacting the authorized representative of that state. The provisions of this agreement apply only to requests~~
 5 ~~for assistance made by and to authorized representatives. Requests may be verbal or in writing. If a request is~~
 6 ~~verbal, the request must be confirmed in writing within 30 days of the verbal request. Requests must provide the~~
 7 ~~following information:~~
 8 ~~—— (a) a description of the emergency service function for which assistance is needed, such as fire services,~~
 9 ~~law enforcement, emergency medical, transportation, communications, public works and engineering, building~~
 10 ~~inspection, planning and information assistance, mass care, resource support, health and medical services, and~~
 11 ~~search and rescue;~~
 12 ~~—— (b) the amount and type of personnel, equipment, materials, and supplies needed and a reasonable~~
 13 ~~estimate of the length of time that will be needed; and~~

 16 ~~—— (3) There must be frequent consultation between state officials who have assigned emergency~~

Article IV - Limitations

21 ~~—— A party state requested to render mutual aid or to conduct exercises and training for mutual aid shall take~~
 22 ~~action necessary to provide and make available the resources covered by this compact in accordance with the~~
 23 ~~terms of this compact. However, it is understood that the state rendering aid may withhold resources to the extent~~
 24 ~~necessary to provide reasonable protection for that state. Each party state shall afford to the emergency forces~~
 25 ~~of any party state, while operating within its state limits under the terms and conditions of this compact, the same~~
 26 ~~powers, except the power of arrest unless specifically authorized by the receiving state, duties, rights, and~~
 27 ~~privileges as are afforded forces of the party state in which they are performing emergency services. Emergency~~
 28 ~~forces shall continue under the command and control of their regular leaders, but the organizational units shall~~
 29 ~~come under the operational control of the emergency services authorities of the state receiving assistance. These~~
 30 ~~conditions may be activated, as needed, only subsequent to a declaration of a state of emergency or disaster by~~

1 the governor of the party state that is to receive assistance or subsequent to commencement of exercises or
 2 training for mutual aid and must continue so long as the exercises or training for mutual aid is in progress, the
 3 state of emergency or disaster remains in effect, or loaned resources remain in the receiving state, whichever
 4 is longer.

6 ~~———— If a person holding a license, certificate, or other permit issued by a party state evidencing the meeting~~
 7 ~~of qualifications for professional, mechanical, or other skills is requested for assistance by the receiving party~~
 8 ~~state, that person is considered licensed, certified, or permitted by the party state requesting assistance to render~~
 9 ~~aid involving that skill to meet a declared emergency or disaster. However, the person holding the license,~~
