22 WHEREAS, Montana has a rich heritage of working farms and ranches and possesses unmatched 23 natural wealth and recreational opportunities in the form of forests, mountains, waters, wildlife habitat, and other 24 natural resources; and

WHEREAS, Montanans are increasingly supportive of efforts to conserve the state's working forests,
ranches, farms, and watersheds and wildlife habitats; and

WHEREAS, the Legislature recognizes the value of pursuing cooperative partnerships among state agencies, federal agencies, political subdivisions, tribal governments, and nonprofit organizations to maximize land conservation opportunities; and

WHEREAS, the Legislature seeks to establish a program to protect Montana's working forests, ranches,

3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

5	NEW SECTION. Section 1. Short title. [Sections 1 though 11] may be cited as the "Montana Working			
6	Forests, Ranches, Farms, and Watersheds Act".			
7				
8	NEW SECTION. Section 2. Definitions. As used in [sections 1 through 11], unless the context requires			
9	otherwise, the following definitions apply:			
10	(1) "Acquire" or "acquisition" means the purchase from a willing seller of the fee simple or less than fee			
11	simple interests in real property that satisfies the criteria established in [section 7]. Less than fee simple interests			
12	in real property may include but are not limited to options, rights of first refusal, conservation easements, leases,			
13	and mineral rights.			
14	(2) "Commission" means the Montana working forests, ranches, farms, and watersheds commission			
15	established in [section 4].			
16	(3) "Conservation" or "conserve" means protecting or maintaining working lands. The term includes			
17	traditional forest MANAGEMENT uses, traditional agricultural uses, and recreational uses that comply with the terms			
18	of an approved management plan.			
19	(4) "Department" means the department of natural resources and conservation provided for in 2-15-3301.			
20	(5) "Nonprofit organization" means a private organization:			
21	(a) that qualifies and holds a general tax exemption under the Internal Revenue Code, section 501(c);			
22	and			
23	(b) whose organization purposes are designed to emphasize land conservation.			
24	(6) "Political subdivision" means a county, consolidated municipal-county government, city, town, or			
25	special improvement district or other political subdivision of state government.			
26	(7) "Program" means the Montana working forests, ranches, farms, and watersheds program established			
27	in [section 3].			
28	(8) "RANCHES" AND "FARMS" MEAN AGRICULTURAL LANDS AS PROVIDED FOR IN 15-7-202.			
29	(8)(9) "Tribal government" means the governing body of a federally recognized Indian tribe located in			
30	Montana.

1	(9)(10) "Working" means managed to produce a long-term and sustainable flow of forest and <u>PRODUCTS</u>				
2	AND CONTINUED GENERATION OF agricultural products and other attributes, such as wildlife habitat, biodiversity,				
3	water filtration, nutrient production and storage, and recreational opportunities.

5	NEW SECTION. Section 3. Montana working forests, ranches, farms, and watersheds program				
6	establishment purpose. (1) The department shall establish a working forests, ranches, farms, and				
7	watersheds program. The program must:				
8	(a) implement the provisions of [sections 1 through 11];				
9	(B) PROMOTE HISTORICAL USES OF PROPERTY, INCLUDING COMMON RANCHING, FARMING, AND TIMBER HARVEST				
10	ACTIVITIES;				
11	(b)(C) promote statewide conservation of working forests, ranches, farms, and watersheds; and				
12	(c)(D) be directed by and receive oversight from the commission.				
13	(2) The purpose of the program is to:				
14	(a) promote cooperation and communication among entities engaged in activities that protect and				
15	maintain Montana forests, ranches, farms, and watersheds in a working condition;				
16	(b) assist with funding to enable state agencies or political subdivisions to purchase a fee simple or				
17	lesser interest in real property for the purpose of maintaining a land use that is conducive to conserving Montana's				
18	natural resources. Historical uses of property, including common farming and ranching activities and timber				
19	harvest, are important management alternatives that must be considered when determining the most appropriate				
20	conservation methods to be applied to a piece of property.

22	NEW SECTION. Section 4. Montana working forests, ranches, farms, and watersheds				
23	commission composition. (1) There is a Montana working forests, ranches, farms, and watersheds				
24	commission. Subject to subsection (2), the commission shall consist of seven Montana citizens appointed by the				
25	governor.				
26	(2) The commission membership must include:

A vacancy on the commission must be filled in the same manner as the original appointment, including 6 7 geographic representation. 23	administration must be kept to a minimum.

27	NEW SECTION. Section 7. Montana working forests, ranches, farms, and watersheds projects				
28	minimum criteria. (1) Projects eligible for funding under the program include acquisitions that conserve

30	(2) A project is not eligible for funding unless the project meets the provisions of Title 76, part 6, and the

14	(H) PROVISION FOR LOST PROPERTY TAX REVENUE FOR AFFECTED POLITICAL SUBDIVISIONS;			
15	(h)(I) potential for leveraging additional funding sources; and			
16	(i)(J) statewide distribution of funded projects.			
17	(4) Expenditure of funds from the Montana working forests, ranches, farms, and watersheds account			
18	provided for in [section 6] must be made in the following order of priority:			
19	(a) loans;			
20	(b) matching grants; and			
21	(c) full project grants.			
22	(5) (a) Each application to the commission for funding for acquisition of land through the program must			
23	include, in a manner and form prescribed by the commission, a management plan that demonstrates how the land			
24	will be maintained long-term or permanently as a working forest, ranch, farm, or watershed.			
25	(b) Acceptable management plans include department forest stewardship plans, United States			
26	department of agriculture land conservation plans, or equivalent management plans as determined by the			
27	commission.			
28	(6) The public must be provided with access to land that is acquired in fee simple.			
29	(7) Easements held by the state and secured using any funding from the program, if authorized by the			
30	state, may be enforced by a nonprofit organization.
