6	LEGISLATURE BY A CERTAIN PERCENTAGE; REQUIRING THE STATE TREASURER TO CERTIFY INCOME		
7	TAX COLLECTIONS FOR THE PURPOSE OF TAX RATE REDUCTIONS; AMENDING SECTIONS 15-30-101		
8	AND 15-30-103, MCA; AND PROVIDING A DELAYED EFFECTIVE DATE."

10	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:		
11			
12	Section 1. Section 15-30-101, MCA, is amended to read:		
13	"15-30-101. Definitions. For the purpose of this chapter, unless otherwise required by the context, the		
14	following definitions apply:		
15	(1) "Base year structure" means the following elements of the income tax structure:		
16	(a) the tax brackets established in 15-30-103, but unadjusted by 15-30-103 (2)(3) , in effect on June 30		
17	of the taxable <u>tax</u> year;		
18	(b) the exemptions contained in 15-30-112, but unadjusted by 15-30-112(6), in effect on June 30 of the		
19	taxable <u>tax</u> year;		
20	(c) the maximum standard deduction provided in 15-30-122, but unadjusted by 15-30-122(2), in effect		
21	on June 30 of the taxable <u>tax</u> year.		
22	(2) "Consumer price index" means the consumer price index, United States city average, for all items,		
23	for all urban consumers (CPI-U), using the 1982-84 base of 100, as published by the bureau of labor statistics		
24	of the U.S. department of labor.		
25	(3) "Corporation" or "C. corporation" means a corporation, limited liability company, or other entity:		
26	(a) that is treated as an association for federal income tax purposes;		
27	(b) for which a valid election under section 1362 of the Internal Revenue Code <u>, (</u> 26 U.S.C. 1362), is not		
28	in effect; and		
29	(c) that is not a disregarded entity.		
30	(4) "Department" means the department of revenue.

1 (5) "Disregarded entity" means a business entity: 2 (a) a business entity that is disregarded as an entity separate from its owner for federal tax purposes, 3 as provided in United States treasury regulations 301.7701-2 or 301.7701-3, 26 CFR 301.7701-2 or 26 CFR 4 301.7701-3, or as those regulations may be labeled or amended; or 5 (b) that is a qualified subchapter S. subsidiary that is not treated as a separate corporation, as provided 6 in section 1361(b)(3) of the Internal Revenue Code, (26 U.S.C. 1361(b)(3)). 7 (6) "Dividend" means: 8 (a) any distribution made by a C. corporation out of its earnings and profits to its shareholders or 9 members, whether in cash or in other property or in stock of the corporation, other than stock dividends; and 10 (b) any distribution made by an S. corporation treated as a dividend for federal income tax purposes. 11 (7) "Fiduciary" means a guardian, trustee, executor, administrator, receiver, conservator, or any person, 12 whether individual or corporate, acting in any fiduciary capacity for any person, trust, or estate. 13 (8) "Foreign C. corporation" means a corporation that is not engaged in or doing business in Montana, 14 as provided in 15-31-101. 15 (9) "Foreign government" means any jurisdiction other than the one embraced within the United States, 16 its territories, and its possessions. 17 (10) "Gross income" means the taxpayer's gross income for federal income tax purposes as defined in 18 section 61 of the Internal Revenue Code, (26 U.S.C. 61) or as that section may be labeled or amended, excluding 19 unemployment compensation included in federal gross income under the provisions of section 85 of the Internal 20 Revenue Code, (26 U.S.C. 85) as amended. 21 (11) "Inflation factor" means a number determined for each tax year by dividing the consumer price index 22 for June of the tax year by the consumer price index for June 2005. 23 (12) "Information agents" includes all individuals and entities acting in whatever capacity, including 24 lessees or mortgagors of real or personal property, fiduciaries, brokers, real estate brokers, employers, and all 25 officers and employees of the state or of any municipal corporation or political subdivision of the state, having the

control, receipt, custody, disposal, or payment of interest, rent, salaries, wages, premiums, annuities,
compensations, remunerations, emoluments, or other fixed or determinable annual or periodical gains, profits,
and income with respect to which any person or fiduciary is taxable under this chapter.

(13) "Internal Revenue Code" means the Internal Revenue Code of 1986, as amended, or as it may be
 labeled or further amended. References to specific provisions of the Internal Revenue Code mean those

provisions as they may be otherwise labeled or further amended. (14) "Knowingly" is as defined has the meaning provided in 45-2-101. (15) "Limited liability company" means a limited liability company, domestic limited liability company, or a foreign limited liability company as defined has the meaning provided in 35-8-102. (16) "Limited liability partnership" means a limited liability partnership as defined in 35-10-102. (17) "Lottery winnings" means income paid either in lump sum or in periodic payments to: (a) a resident taxpayer on a lottery ticket; or (b) a nonresident taxpayer on a lottery ticket purchased in Montana. (18) (a) "Montana source income" means: (i) wages, salary, tips, and other compensation for services performed in the state or while a resident of the state: (ii) gain attributable to the sale or other transfer of tangible property located in the state, sold or otherwise transferred while a resident of the state, or used or held in connection with a trade, business, or occupation carried on in the state; (iii) gain attributable to the sale or other transfer of intangible property received or accrued while a resident of the state: (iv) interest received or accrued while a resident of the state or from an installment sale of real property or tangible commercial or business personal property located in the state; (v) dividends received or accrued while a resident of the state; (vi) net income or loss derived from a trade, business, profession, or occupation carried on in the state or while a resident of the state; (vii) net income or loss derived from farming activities carried on in the state or while a resident of the state: (viii) net rents from real property and tangible personal property located in the state or received or accrued while a resident of the state; (ix) net royalties from real property and from tangible real property to the extent the property is used in the state or the net royalties are received or accrued while a resident of the state. The extent of use in the state is determined by multiplying the royalties by a fraction, the numerator of which is the number of days of physical location of the property in the state during the royalty period in the tax year and the denominator of which is the number of days of physical location of the property everywhere during all royalty periods in the tax year. 3 (19) "Net income" means the adjusted gross income of a taxpayer less the deductions allowed by this4 chapter.

(20) "Nonresident" means a natural person who is not a resident.

6 (21) "Paid", for the purposes of the deductions and credits under this chapter, means paid or accrued
7 or paid or incurred, and the terms "paid or accrued" and "paid or incurred" must be construed according to the
8 method of accounting upon the basis of which the taxable income is computed under this chapter.

9 (22) "Partner" means a member of a partnership or a manager or member of any other entity, if treated
10 as a partner for federal income tax purposes.

(23) "Partnership" means a general or limited partnership, limited liability partnership, limited liability
 company, or other entity, if treated as a partnership for federal income tax purposes.

13 (24) "Pass-through entity" means a partnership, an S. corporation, or a disregarded entity.

14 (25) "Pension and annuity income" means:

(a) systematic payments of a definitely determinable amount from a qualified pension plan, as that term
is used in section 401 of the Internal Revenue Code, (26 U.S.C. 401), or systematic payments received as the
result of contributions made to a qualified pension plan that are paid to the recipient or recipient's beneficiary upon
the cessation of employment;

(b) payments received as the result of past service and cessation of employment in the uniformedservices of the United States;

(c) lump-sum distributions from pension or profit-sharing plans to the extent that the distributions are
 included in federal adjusted gross income;

(d) distributions from individual retirement, deferred compensation, and self-employed retirement plans
 recognized under sections 401 through 408 of the Internal Revenue Code, (26 U.S.C. 401 through 408), to the
 extent that the distributions are not considered to be premature distributions for federal income tax purposes; or
 (e) amounts received from fully matured, privately purchased annuity contracts after cessation of regular

27 employment.

28 (26) "Purposely" is as defined has the meaning provided in 45-2-101.

(27) "Received", for the purpose of computation of taxable income under this chapter, means received
 or accrued, and the term "received or accrued" must be construed according to the method of accounting upon



1 the basis of which the taxable income is computed under this chapter.

2 (28) "Resident" applies only to means a natural persons person and includes, for the purpose of 3 determining liability to the tax imposed by this chapter with reference to the income of any taxable tax year, any 4 person domiciled in the state of Montana and any other person who maintains a permanent place of abode 5 residence within the state even though temporarily absent from the state and who has not established a residence 6 elsewhere.

7 (29) "S. corporation" means an incorporated entity for which a valid election under section 1362 of the
8 Internal Revenue Code, (26 U.S.C. 1362), is in effect.

9 (30) "Stock dividends" means new stock issued, for surplus or profits capitalized, to shareholders in
10 proportion to their previous holdings.

11 (31) "Tax year" means the taxpayer's taxable tax year for federal income tax purposes.

(32) "Taxable income" means the adjusted gross income of a taxpayer less the deductions and
 exemptions provided for in this chapter.

(33) (a) "Taxpayer" includes any means a person, entity, or fiduciary, resident or nonresident, subject to
 a tax or other obligation imposed by this chapter.

(b) and unless otherwise specifically provided <u>The term</u> does not include a C. corporation <u>unless</u>
 <u>otherwise specifically provided by this chapter</u>."

19 Section 2. Section 15-30-103, MCA, is amended to read:

"15-30-103. Rate of tax <u>-- contingent tax rate reduction</u>. (1) There must be levied, collected, and paid
 for each tax year upon the taxable income of each taxpayer subject to this tax, after making allowance for
 exemptions and deductions as provided in this chapter, a tax on the brackets of taxable income as follows:

23 (a) on the first \$2,300 of taxable income or any part of that income, 1%;

24 (b) on the next \$1,800 of taxable income or any part of that income, 2%;

25 (c) on the next \$2,100 of taxable income or any part of that income, 3%;

26 (d) on the next \$2,200 of taxable income or any part of that income, 4%;

27 (e) on the next \$2,400 of taxable income or any part of that income, 5%;

28 (f) on the next \$3,100 of taxable income or any part of that income, 6%;

29 (g) on any taxable income in excess of \$13,900 or any part of that income, 6.9%.

30 (2) If, in any fiscal year beginning with fiscal year 2008, individual income tax collections, excluding



1 amended returns and audit collections attributable to a tax year that began before the tax year in which the fiscal 2 year began, are at least 3% more than estimated by the legislature, as provided in 5-5-227, exclusive of the 3 amount attributable to audit collections, then beginning January 1 of the calendar year immediately following the 4 end of that fiscal year, the tax rates in effect under subsection (1) during the prior tax year must be reduced by 5 the percentage amount that individual income tax collections for that fiscal year exceeded the amount estimated 6 by the legislature. The amount estimated by the legislature includes the adjustment made by the state treasurer 7 under [section 3]. 8 (2)(3) By November 1 of each year, the department shall multiply the bracket amount contained in 9 subsection (1) by the inflation factor for that tax year and round the cumulative brackets to the nearest \$100. The 10 resulting adjusted brackets are effective for that tax year and must be used as the basis for imposition of the tax 11 in subsection (1) of this section as modified under subsection (2)." 12 13 <u>NEW SECTION.</u> Section 3. State treasurer to determine excess of individual income tax 14 collections over legislative estimate. For the purposes of 15-30-103, beginning with the fiscal year that ends 15 June 30, 2008, and for each fiscal year thereafter, the state treasurer shall certify the amount by which individual 16 income tax collections, exclusive of audit collections and amended returns attributable to a tax year that began 17 before the tax year in which the fiscal year begins, exceeds the amount of individual income tax collections, 18 exclusive of the amount attributable to audit collections, estimated by the legislature as provided in 5-5-227 and 19 as adjusted by the state treasurer for individual income tax legislation in effect for that fiscal year. The certification 20 must include the percentage amount by which actual individual income tax collections for that fiscal year are less 21 than or greater than the amount estimated by the legislature. The state treasurer shall notify the secretary of state, 22 the department of revenue, the code commissioner, and the legislative fiscal division of this certification. 23 24 NEW SECTION. Section 4. Codification instruction. [Section 3] is intended to be codified as an 25 integral part of Title 17, chapter 1, part 1, and the provisions of Title 17, chapter 1, part 1, apply to [section 3]. 26 27 NEW SECTION. Section 5. Effective date. [This act] is effective January 1, 2008. 28 - END -
