4	A JOINT RESOLUTION OF THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE STATE OF
5	MONTANA URGING THE U.S. CONGRESS TO REAUTHORIZE THE SECURE RURAL SCHOOLS AND
6	COMMUNITY SELF-DETERMINATION ACT AND WORK TOWARD A PERMANENT SOLUTION TO
7	COMPENSATE STATES AND LOCAL GOVERNMENTS FOR LOST TAX REVENUE ON FEDERAL LAND
8	WITHIN MONTANA.

10	WHEREAS, the stability of Montana's economy has historically been dependent on use of our abundant
11	natural resources; and
12	WHEREAS, the natural resource harvest has historically contributed billions of dollars to Montana's
13	economy by providing employment opportunities to members of our communities, supporting our business
14	communities, and contributing to the health of our schools; and
15	WHEREAS, revenue from industries related to the natural resource harvest has produced taxes for the
16	support of local and state governments; and
17	WHEREAS, the amount of money generated by national forests has dropped more than 85% between
18	1986 and 2005, creating a financial crisis for rural forest communities in Montana and around the country; and
19	WHEREAS, Congress passed the Secure Rural Schools and Community Self-Determination Act of 2000
20	to provide a safety net for these communities, and the purpose of the Act was to stabilize payments to states and
21	counties to help support roads and schools, provide projects that enhance forest ecosystem health, provide
22	employment opportunities, and improve cooperative relationships among federal land management agencies and
23	those who use and care about the lands that the agencies manage; and
24	WHEREAS, counties in Montana received more than \$14 million in the last year to maintain schools and
25	roads; and
26	WHEREAS, the Secure Rural Schools and Community Self-Determination Act has expired; and
27	WHEREAS, if the Act is not reauthorized, many counties will suffer severe financial impacts resulting in
28	significant reduction in services, including but not limited to public safety and education.

30	NOW, THEREFORE, BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE
