

### General

Upon submitting your reservation request you authorize the Companies to facilitate hotel reservations on your behalf, including making payment arrangements with hotel suppliers. The tax recovery charge on prepaid hotel transactions is an estimate and recovery of applicable transaction taxes (e.g. sales and use, occupancy, room tax, excise tax, value added tax, etc) that the Companies pay to the suppliers (e.g. hotels, other travel suppliers, etc.) in connection with your hotel reservations. The Companies do not collect and remit these taxes to the applicable tax authorities. The hotel suppliers bill all applicable taxes and the Companies remit such tax directly to the hotel suppliers. The Companies do not act as co-vendor with the supplier with whom we book or reserve our customer's travel arrangements. Taxability and the appropriate tax rate vary greatly by location. The actual tax amounts paid by the Companies to the hotel suppliers may vary from the tax recovery charge amounts, depending upon the rates, taxability, etc. in effect at the time of the actual use of the hotel, automobile, etc. by our customers. Our service fees are retained by the Companies as compensation in servicing your travel reservation. Our service fees vary based on the amount and type of hotel reservation.

You may cancel or change your prepaid hotel reservation, but you will be charged the cancellation or change fee indicated in the rules and restrictions for the hotel reservation. In addition, if you do not cancel or change your reservation before the cancellation policy period applicable to the hotel you reserved, which varies by hotel (usually 24 to 72 hours) prior to your date of arrival, you will be subject to a charge of applicable nightly rates, tax recovery charges and service fees. You must make refund requests for no-shows or early checkouts within 60 days after checkout. Any refund for checking out early or for no shows will be given at the sole discretion of the Companies. You agree to pay any cancellation or change fees that you incur.
