INFORMATION

The undersigned Deputy County Attorney of Yellowstone County, Montana, states: before the filing of this Information, the above-named Defendant, in Yellowstone County, Montana, on or about May 30, 2004, committed the offense of:

**AGGRAVATED ASSAULT (FELONY) (Weapon Enhanced Penalty)
(punishable by not less than 2 years or more than 20 years in state prison and a fine not to exceed \$50,000)**

The alleged facts constituting the offense are:

That the Defendant, STEVEN LEO MATZ (d.o.b. 06/23/1949), 2015 Lewis Avenue, Billings, Montana, purposely or knowingly caused serious bodily injury to another, to wit: during an altercation, the Defendant shot Steve Andersen (d.o.b. 06/03/1958) with a handgun, causing serious bodily injury to Andersen, all of which is in violation of Sections 45-5-202 Montana Code Annotated, punishable by not less than 2 years or more than 20

years in state prison and a fine not to exceed \$50,000, and 46-18-221, for use of a firearm, subjecting the Defendant to enhanced punishment of imprisonment from two to ten years consecutive to any other penalty imposed, and against the peace and dignity of the State of Montana.
