MY NAME IS HALE THOMAS AND I LIVE IN BOZEMAN, MONTANA. I MOVED TO BOZEMAN IN 2007 FROM MARYLAND AND I DID NOT EVEN KNOW THAT MEDICAL MARIJUANA HAD BEEN APPROVED BY THE MONTANA VOTERS UNTIL ABOUT EARLY 2009.

THE MOST SIGNIFICANT THING I REMEMBER ABOUT THE PRESENTATION

WAS THAT MARIJUANA VERY FREQUENTLY (PROBABLY ABOUT 75 PERCENT OF THE TIME) LEADS TO OTHER DRUG CRAVINGS FOR A HIGHER HIGH! THEN ~~THE~~ USER WANTS AND SEEKS OUT SOME HEROIN, OR SOME CRACK COCAINE, OR SOME METH, OR SOME OTHER TOTALLY DESTRUCTIVE DRUG. TOO OFTEN THEY THEN BECOME CRIMINALS TO SATISFY THEIR CRAVINGS. AND TOO OFTEN THEY COMMIT ACTS OF VIOLENCE OR COMMIT SUICIDE! I'M BETTING THAT YOUNG MAN IN TUCSON WHO COMMITTED THOSE HORRENDOUS MURDERS RECENTLY WAS A PRODUCT OF MARIJUANA USE AND ADDICTION.

I STAND BEFORE YOU HERE TODAY AND I PLEAD WITH YOU TO PLEASE PLEASE STOP THIS MEDICAL MARIJUANA BEAST IN ITS TRACKS RIGHT NOW BEFORE IT IS TOO LATE. IF YOU ALLOW MEDICAL MARIJUANA TO CONTINUE TO BE LEGAL, WE, ALL THE CITIZENS OF MONTANA (AND YOU TOO PERSONALLY) WILL BE ACCOUNTABLE AND WE WILL FOREVER REGRET THIS DECISION! MARK MY WORDS, AND I REPEAT THAT ALL OF US WILL DEEPLY REGRET IT IF WE CONTINUE TO ALLOW MEDICAL MARIJUANA TO POISON OUR PEOPLE, ESPECIALLY OUR YOUTH, AND OUR WHOLE STATE, AND OUR NATION. ALREADY CRIMES ARE BEING COMMITTED HERE IN MONTANA: FALSE APPLICATIONS, BURGLARIES, VIOLENCE AGAINST PERSONS, TEENS GETTING MARIJUANA EASIER THAN EVER, DRIVING UNDER ~~THE INFLUENCE OF THIS~~

INFLUENCE OF THIS DRUG—AND THE LIST GOES ON AND ON. JUST TALK TO SOME LAW ENFORCEMENT PEOPLE AND THEY ARE ALREADY SHUDDERING IN THEIR BOOTS ABOUT WHAT IS FACING THEM TO ENFORCE THE THIS MEDICAL MARIJUANA LAW AND ITS RELATED LAWS AND TO KEEP INNOCENT PEOPLE FROM BEING AFFECTED BY THIS PLAGUE (YES, I CALLED IT A PLAGUE BECAUSE THAT IS EXACTLY WHAT IT WILL BECOME).

I REPEAT: “MARK MY WORDS, WE WILL REGRET CONTINUING TO ALLOW MEDICAL MARIJUANA TO INFECT OUR STATE.” WE WILL REGRET THE LEGAL COSTS, THE REGULATION COSTS, THE MEDICAL COSTS FOR BOTH PHYSICAL AND MENTAL HEALTH, THE CRIMINAL ELEMENT IT WILL ATTRACT AND HAS ALREADY ATTRACTED, ETC. ETC. THE COSTS IN HUMAN LIVES AND HUMAN MISERY CANNOT BE CALCULATED IN DOLLAR TERMS! THIS BILL IS 34 PAGES AND I PREDICT IT WILL COST ONE MILLION DOLLARS PER PAGE PER YEAR WITH MANY OF THE ASSOCIATED HUMAN MISERY COSTS NOT CALCULABLE IN DOLLAR TERMS.

AGAIN, I REPEAT ‘MARK MY WORDS—THIS MEDICAL MARIJUANA THING MUST BE REPEALED RIGHT NOW AND PUT IN THE TRASH CAN NOW—RIGHT NOW—BEFORE IT IS FULLY IMPLEMENTED BECAUSE THEN IT WILL BE SUPER DIFFICULT TO GO BACK LATER AND TO REPEAL OR POSITIVELY CHANGE IT!

PLEASE "MARK MY WORDS" IN YOUR MEMORY BECAUSE THIS IS OUR GOLDEN OPPORTUNITY AND PROBABLY OUR ONLY OPPORTUNITY TO DO WHAT IS RIGHT FOR THE CITIZENS OF MONTANA. JUST BECAUSE 14 OTHER STATES HAVE APPROVED MEDICAL MARIJUANA DOES NOT MEAN MONTANA HAS TO DO IT ALSO. LETS STAND STRONG AGAINST THIS EVIL THING BECAUSE THAT IS WHAT MARIJUANA IS—IT IS AN EVIL DEATH DRUG. ALWAYS HAS BEEN AND ALWAYS WILL CONTINUE TO BE!
