Congressional Reform Act of 2011

1. Term Limits  
12 years only, one of the possible options below:
  - A. Two Six-year Senate terms
  - B. Six Two-year House terms
  - C. One Six-year Senate term and three Two-year House terms

2. No Tenure / No Pension

A Congressman collects a salary while in office and receives no pay when they are out of office.

3. Congress (past, present & future) participates in Social Security. All funds in the Congressional retirement fund move to the Social Security system immediately. All future funds flow into the Social Security system, and Congress participates with the American people.
4. Congress can purchase their own retirement plan, just as all Americans do.
5. Congress will no longer vote themselves a pay raise. Congressional pay will rise by the lower of CPI or 3%.
6. Congress loses their current health care system and participates in the same health care system as the American people.
7. Congress must equally abide by all laws they impose on the American people.
8. All contracts with past and present Congressmen are void effective 1/1/11.

The American people did not make this contract with Congressmen, Congressmen made all these contracts with themselves.

Serving in Congress is an honor, not a career. The Founding Fathers envisioned citizen legislators, serve their term(s), then go home and back to work.

9. Protect the Constitution! Say NO to a call for a National Constitutional Convention! A large number of leading constitutional scholars agree that an Article V constitutional convention cannot be restricted as to what amendments it would consider and ultimately propose (an example). After this Constitutional convention would "propose amendments," the amendment(s) would then be submitted to the states (either legislatures or special state conventions as specified by Congress according to the Constitution, but possibly some other bodies proposed by the constitutional convention itself following the precedent of our

original Constitutional Convention in specifying the means for the ratification of the Constitution) for ratification. Although 3/4s of the states would have to ratify an amendment for it to become part of the Constitution, there is still the all-too-real risk that a harmful amendment or series of amendments could be ratified due to the extraordinary influence exerted on American voters and their representatives by powerful elites in our news media, government, educational institutions, and foundations.

Please vote NO on any resolution in our state legislature that petitions Congress to call a constitutional convention as provided for by Article V, of the U.S. Constitution.

I've become aware of several organizations that are contacting all state legislators in the nation to promote resolutions petitioning Congress to convene a constitutional convention, so I'm sure this is the reason that this issue has come up in our state legislature.

Since leading constitutional scholars say that such a constitutional convention could not be restricted as to the amendments it could consider and propose, I am very concerned that such a convention could lead to proposing one or more amendments that could have a very harmful effect on our freedoms under the U.S. Constitution.
