- On or before the "Renew by" date on the front of this card:
 - RENEW ONLINE: <https://app.mt.gov/vrr>
 - RENEW BY MAIL: Mail this card (ok to fold) and check (not cash) payable to the county treasurer at the address on the other side of this card. Remember to add postage fee from front of card.
 - RENEW IN PERSON: Take this card (or your current registration receipt) to your county treasurer's office and pay fees in person.
- If personalized plates are not renewed by the "Renew by" date, plate logo may be issued to someone else.
- Montana law requires minimum vehicle liability insurance coverage in the amounts of \$25,000-\$50,000-\$10,000.
- Proof of insurance must be carried in the vehicle.
- If you do not intend to use this vehicle to visit Montana state parks and/or fishing access sites, you may opt-out of paying the State Park Fee by subtracting \$4.00 from the total. See, MCA 61-3-321(18).
