12	Section 1. Section 2-6-203, MCA, is amended to read:
13	"2-6-203. Secretary of state's powers and duties rulemaking authority. (1) In order to insure
14	ensure the proper management and safeguarding of public records, the secretary of state shall undertake the
15	following:
16	(a) establish guidelines for inventorying, cataloging, retaining, and transferring all public records of state
17	agencies;
18	(b) review and analyze all state agency filing systems and procedures and approve filing system
19	equipment requests;
20	(c) establish and operate the state records center, as authorized by appropriation, for the purpose of
21	storing and servicing public records not retained in office space;
22	(d) gather and disseminate information on all phases of records management, including current
23	practices, methods, procedures, and devices for the efficient and economical management of records;
24	(e) operate a central microfilm unit which that will microfilm, on a cost recovery basis, all records
25	approved for filming by the office of origin and the secretary of state; and
26	(f) approve microfilming projects and microfilm equipment purchases undertaken by all state agencies:

28	(g) adopt rules regarding the management of public records.
29	(2) Upon request, the secretary of state shall assist and advise in the establishment of records
30	management procedures in the legislative and judicial branches of state government and shall, as required by

1 them, provide services similar to those available to the executive branch." 2 3 Section 1. Section 2-15-1013, MCA, is amended to read: 4 "2-15-1013. Records committee -- composition and meetings. (1) There is a committee to be known 5 as the state records committee composed of representatives of: 6 (a) the department of administration; 7 (b) the legislative auditor; 8 (c) the attorney general; 9 (d) the secretary of state; and 10 (e) the Montana historical society. 11 (2) The representatives are to be designated by the head of the respective agencies, and their 12 appointments shall must be submitted in writing to the secretary of state. 13 (3) The committee shall meet at least quarterly. 14 (4) Committee members shall serve without additional salary but are entitled to reimbursement for travel 15 expense incurred while engaged in committee activities as provided for in 2-18-501 through 2-18-503.
