5 A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING THE LAWS RELATING TO ELECTIONS;

23 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

24

25 **Section 1.** Section 5-2-406, MCA, is amended to read:

26 **"5-2-406. Elections to fill vacancies in senate.** (1) Whenever a vacancy occurs 85 days or more before
27 the general election held during the second year of the term, an individual may be appointed, pursuant to 5-2-402,
28 if the legislature is called into special session. However, the appointment may run only until a person is elected
29 to complete the term at the upcoming general election and sworn into office. The election procedure to be used
30 to elect the successor is as follows:

1 (a) Whenever the vacancy occurs ~~75~~ 85 days or more prior to the primary election during the second
 2 year, the same procedure as is used for senators who will be elected to full 4-year terms at that general election
 3 must be utilized.

4 (b) Whenever the vacancy occurs on or after the ~~75th~~ 85th day prior to the primary election, any political
 5 party desiring to enter a candidate in the general election shall select a candidate as provided in 13-10-327 and
 6 13-38-204. A political party shall notify the secretary of state of the party nominee. A person desiring to be a
 7 candidate as an independent shall follow the procedures provided in 13-10-501 and 13-10-502. The petition for
 8 an independent candidate must be filed with the secretary of state on or before the 85th day prior to the general
 9 election.

10 (2) Whenever a vacancy occurs on or after the 85th day prior to the general election held during the
 11 second year of the term, the person appointed by the board under 5-2-402 shall serve until the end of the term."

12

13 **Section 2.** Section 13-1-106, MCA, is amended to read:

14 "**13-1-106. Time of opening and closing of polls for all elections -- exceptions.** (1) Except as
 15 provided in subsections (2) and (3), polling places must be open from 7 a.m. to 8 p.m.

16 (2) A polling place having fewer than 400 registered electors must be open from at least noon to 8 p.m.
 17 or until all registered electors in any precinct have voted, at which time that precinct in the polling place must be
 18 closed immediately.

19 (3) If an election held under 13-1-104(3) and a school election are conducted in the same polling place,
 20 the polling place must be opened and closed at the times set for the school election, as provided in 20-20-106."

21

22 **Section 3.** Section 13-1-108, MCA, is amended to read:

23 "**13-1-108. Notice of special elections.** Notice of any special election must be broadcast or published
 24 at least three times in the 4 weeks immediately preceding the ~~close of registration on radio or television as~~
 25 ~~provided in 2-3-105 through 2-3-107 or~~ election in a newspaper of general circulation in the jurisdiction where the
 26 election will be held or may be broadcast on radio or television as provided in 2-3-105 through 2-3-107, using the
 27 method the election administrator believes is best suited to reach the largest number of potential electors. The
 28 provisions of this section are fulfilled upon the third publication or broadcast of the notice."

29

30 **Section 4.** Section 13-1-303, MCA, is amended to read:

1 **"13-1-303. Disposition of ballots and other election materials.** (1) (a) Except for a federal election
2 and as provided in 13-15-301(2), the voted ballots, detached stubs, unvoted ballots, and unused ballots from an
3 election must be kept in the unopened packages received from the election judges for a period of 12 months. The
4 packages may be opened only when an order for opening is given by the proper official either for a recount
5 procedure or to process provisional ballots.

6 (b) The voted ballots, detached stubs, unvoted ballots, and unused ballots from a federal election must
7 be retained in the unopened packages received from the election judges for a period of 22 months. The packages
8 may be opened only as provided in subsection (1)(a) or for a postelection random-sample audit of vote-counting
9 machines.

10 (c) An election administrator may dispose of the ballots as provided in subsection (2) if after the time
11 periods provided for in this subsection (1), there is no:

12 (i) contest begun;

13 (ii) recount pending; or

14 (iii) appeal of a decision relating to a contest, a recount, or a postelection random-sample audit.

15 (2) Each election administrator shall prepare a plan for retention and destruction of election records in
16 the county according to the retention schedules established by the local government records committee provided
17 for in 2-6-402."

18

19 **Section 5.** Section 13-1-304, MCA, is amended to read:

20 **"13-1-304. Duties of officials when election not held.** If a scheduled election is not necessary or is
21 canceled for any reason specified in law, the governing body or official making the determination shall
22 immediately notify the election administrator in writing. If the election is not necessary because of the number of
23 candidates filed, the election administrator shall make the determination and notify the proper governing body."

24

25 **Section 6.** Section 13-2-108, MCA, is amended to read:

26 **"13-2-108. Rulemaking for statewide voter registration list.** (1) The secretary of state shall adopt
27 rules to implement the provisions of 42 U.S.C. 15483 and this chapter.

28 (2) The rules must include but are not limited to:

29 (a) a list of maintenance procedures, including new data entry, updates, registration transfers, and other
30 procedures for keeping information current and accurate;

- 1 (b) proper maintenance and use of active and inactive lists;
- 2 (c) proper maintenance and use of lists for legally registered electors and provisionally registered
3 electors;
- 4 ~~(d) procedures and timelines to be used by election administrators when providing the information~~
5 ~~required in 13-2-123;~~
- 6 ~~(e)(d)~~ technical security of the statewide voter registration database;
- 7 ~~(f)(e)~~ information security with respect to keeping from general public distribution driver's license
8 numbers, whole or partial social security numbers, and address information protected from general disclosure
9 pursuant to 13-2-115; and
- 10 ~~(g)(f)~~ quality control measures for the system and system users.
- 11 (3) The rules adopted by the secretary of state must reflect that an elector who was properly registered
12 prior to January 1, 2003, is considered a legally registered elector."
13

14 **Section 7.** Section 13-2-110, MCA, is amended to read:

15 **"13-2-110. Application for voter registration -- sufficiency and verification of information --**
16 **identifiers assigned for voting purposes.** (1) An individual may apply for voter registration in person or by mail,
17 postage paid, by completing and signing an application for voter registration and providing the application to the
18 election administrator in the county in which the elector resides.

19 ~~(2) An individual applying by mail shall send the application to the election administrator, postage paid,~~
20 ~~no later than 15 days after the date it is signed.~~

21 ~~(3)(2)~~ Each application for voter registration must be accepted and processed as provided in rules
22 adopted under 13-2-109.

23 ~~(4)(3)~~ Except as provided in subsection ~~(5)~~ (4):

24 (a) an applicant for voter registration shall provide the applicant's Montana driver's license number; or

25 (b) if the applicant does not have a Montana driver's license, the applicant shall provide the last four
26 digits of the applicant's social security number.

27 ~~(5)(4)~~ (a) If an applicant does not have a Montana driver's license or social security number, the applicant
28 shall provide as an alternative form of identification:

29 (i) a current and valid photo identification, including but not limited to a school district or postsecondary
30 education photo identification or a tribal photo identification, with the individual's name; or

1 (ii) a current utility bill, bank statement, paycheck, government check, or other government document that
2 shows the individual's name and current address.

3 (b) The alternative form of identification must be:

4 (i) an original version presented to the election administrator if the applicant is applying in person; or

5 (ii) a copy of any of the required documents, which must be enclosed with the application, if the applicant
6 is applying by mail.

7 ~~(6)~~(5) (a) If information provided on an application for voter registration is sufficient to be accepted and
8 processed and is verified pursuant to rules adopted under 13-2-109, the election administrator shall register the
9 elector as a legally registered elector.

10 (b) If information provided on an application for voter registration was sufficient to be accepted but the
11 applicant failed to provide the information required in subsection ~~(4)~~ (3) or ~~(5)~~ (4) or if the information provided
12 was incorrect or insufficient to verify the individual's identity or eligibility to vote, the election administrator shall
13 register the applicant as a provisionally registered elector.

14 ~~(7)~~(6) Each applicant for voter registration must be notified of the elector's registration status pursuant
15 to rules adopted under 13-2-109.

16 ~~(8)~~(7) The secretary of state shall assign to each elector whose application was accepted a unique
17 identification number for voting purposes and shall establish a statewide uniform method to allow the secretary
18 of state and local election officials to distinguish legally registered electors from provisionally registered electors.

19 ~~(9)~~(8) The provisions of this section may not be interpreted to conflict with voter registration
20 accomplished under 13-2-221, 13-21-201, 13-21-203, and 61-5-107 and as provided for in federal law."
21

22 **Section 8.** Section 13-2-112, MCA, is amended to read:

23 **"13-2-112. Register of electors to be kept.** Each election administrator shall keep an official register
24 of electors in the ~~manner that the administrator considers most efficient~~ statewide voter registration database.
25 The original signed registration form for each elector must be ~~filed alphabetically in a separate file for each~~
26 ~~precinct~~ scanned, and the scanned copy must be retained in the statewide voter registration database. The
27 original paper copy must be kept according to the state records retention schedule for such records. Additional
28 ~~files and records may be established for convenience.~~ The information recorded in the official register of electors
29 and the design of the registration forms must be prescribed by the secretary of state in the statewide voter
30 registration database."

2 **Section 9.** Section 13-2-115, MCA, is amended to read:

3 **"13-2-115. Certification of statewide voter registration list -- local lists to be prepared.** (1)

4 ~~Immediately after regular registration is closed under 13-2-301, the secretary of state shall certify the official~~
 5 ~~statewide voter registration list. No later than 5 working days after the deadline prescribed in 13-2-301(3), election~~
 6 ~~administrators shall enter all voter registration applications that were submitted within the deadline for regular~~
 7 ~~registration into the statewide voter registration database.~~

8 (2) The secretary of state shall certify the official statewide voter registration list by utilizing the
 9 information in the statewide voter registration database.

10 ~~(2)(3)~~ Each election administrator shall have printed from the certified statewide voter registration
 11 database lists of all registered electors in each precinct in the county. Except as provided in subsections ~~(5)~~ (6)
 12 and ~~(6)~~ (7), names of electors must be listed alphabetically, with their residence address or with a mailing address
 13 if located where street numbers are not used.

14 ~~(3)(4)~~ A copy of the list of registered electors in a precinct must be displayed at the precinct's polling
 15 place. Extra copies of the lists must be retained by the election administrator and furnished to an elector upon
 16 request.

17 ~~(4)(5)~~ Lists of registered electors need not be printed if the election will not be held.

18 ~~(5)(6)~~ If a law enforcement officer or reserve officer, as defined in 7-32-201, requests in writing that, for
 19 security reasons, the officer's and the officer's spouse's residential address, if the same as the officer's, not be
 20 disclosed, the secretary of state or an election administrator may not include the address on any generally
 21 available list of registered electors but may list only the electors' names.

22 ~~(6)(7)~~ (a) Upon the request of an individual, the secretary of state or an election administrator may not
 23 include the individual's residential address on any generally available list of registered electors but may list only
 24 the elector's name if the individual:

25 (i) proves to the election administrator, as provided in subsection ~~(6)(b)~~ (7)(b), that the individual, or a
 26 minor in the custody of the individual, has been the victim of partner or family member assault, stalking, custodial
 27 interference, or other offense involving bodily harm or threat of bodily harm to the individual or minor; or

28 (ii) proves to the election administrator, as provided in subsection ~~(6)(e)~~ (7)(c), that a temporary
 29 restraining order or injunction has been issued by a judge or magistrate to restrain another person's access to
 30 the individual or minor.

1 (b) Proof of the victimization is conclusive upon exhibition to the election administrator of a criminal
 2 judgment, information and judgment, or affidavit of a county attorney clearly indicating the conviction and the
 3 identity of the victim.

4 (c) Proof of the issuance of a temporary restraining order or injunction is conclusive upon exhibition to
 5 the election administrator of the temporary restraining order or injunction."
 6

7 **Section 10.** Section 13-2-122, MCA, is amended to read:

8 **"13-2-122. Charges for registers, elector lists, and mailing labels made available to public.** (1)

9 Except as provided in subsection (2), upon ~~written~~ request, the secretary of state ~~or a local election administrator~~
 10 shall furnish to any ~~elector individual~~, for noncommercial use, ~~a copy of the official precinct registers, a current~~
 11 ~~list of legally registered electors, or mailing labels for registered electors~~ available extracts and reports from the
 12 statewide voter registration database. Upon request, a local election administrator shall furnish to an individual,
 13 for noncommercial use, a copy of the official precinct registers, a current list of legally registered electors, mailing
 14 labels for registered electors, or other available extracts and reports. Upon delivery, the secretary of state or the
 15 local election administrator may collect a charge not to exceed the actual cost of the register, list, ~~or~~ mailing
 16 labels, or available extracts and reports.

17 (2) For an elector whose address information is protected from general distribution under 13-2-115~~(5)~~
 18 ~~or~~(6) or (7), the secretary of state or a local election administrator may not include the elector's residential
 19 address on any register, list, ~~or~~ mailing labels, or available extracts and reports but may list only the elector's
 20 name."
 21

22 **Section 11.** Section 13-2-220, MCA, is amended to read:

23 **"13-2-220. Maintenance of active and inactive voter registration lists for elections -- rules by**
 24 **secretary of state.** (1) The rules adopted by the secretary of state under 13-2-108 must include the following
 25 procedures, at least one of which an election administrator shall follow in every odd-numbered year:

26 (a) compare the entire list of registered electors against the national change of address files and provide
 27 appropriate confirmation notice to those individuals whose addresses have apparently changed;

28 (b) mail a nonforwardable, first-class, "return if undeliverable--address correction requested" notice to
 29 all registered electors of each jurisdiction to confirm their addresses and provide the appropriate confirmation
 30 notice to those individuals who return the notices;

1 (c) mail a targeted mailing to electors who failed to vote in the preceding federal general election,
 2 applicants who failed to provide required information on registration cards, and provisionally registered electors
 3 by:

4 (i) sending the list of nonvoters a nonforwardable notice, followed by the appropriate forwardable
 5 confirmation notice to those electors who appear to have moved from their addresses of record;

6 (ii) comparing the list of nonvoters against the national change of address files, followed by the
 7 appropriate confirmation notices to those electors who appear to have moved from their addresses of record;

8 (iii) sending forwardable confirmation notices; or

9 (iv) making a door-to-door canvass.

10 (2) An individual who submits an application for an absentee ballot for a federal general election or who
 11 completes and returns the address confirmation notice specified in 13-13-212(4) during the calendar year in which
 12 a federal general election is held is not subject to the procedure in subsection (1)(c) unless the individual's ballot
 13 for a federal general election is returned as undeliverable and the election administrator is not able to contact the
 14 elector through the most expedient means available to resolve the issue.

15 ~~(2)~~(3) Any notices returned as undeliverable to the election administrator or any notices to which the
 16 elector fails to respond after using the election administrator uses the procedures provided in subsection (1) must
 17 be followed within 30 days by an appropriate confirmation notice that is a forwardable, first-class, postage-paid,
 18 self-addressed, return notice. If the elector fails to respond within 30 days of the final confirmation notice, the
 19 election administrator shall move the elector to the inactive list.

20 ~~(3)~~(4) A procedure used by an election administrator pursuant to this section must be completed at least
 21 90 days before a primary or general election for federal office.

22 ~~(4)~~(5) An elector's registration may be reactivated pursuant to 13-2-222 or may be canceled pursuant
 23 to 13-2-402."
 24

25 **Section 12.** Section 13-2-222, MCA, is amended to read:

26 **"13-2-222. Reactivation of elector.** (1) The name of an elector must be moved by an election
 27 administrator from the inactive list to the active list of a county if an elector meets the requirements for registration
 28 provided in this chapter and:

29 (a) appears at a polling place in order to vote, ~~votes~~ submits an application to vote by absentee ballot
 30 in a polling place election or mail ballot election, or votes in a mail ballot election conducted under Title 13,

1 chapter 19;

2 (b) notifies the county election administrator in writing of the elector's current residence, which must be
3 in that county; or

4 (c) completes a reactivation form provided by the county election administrator that provides current
5 address information in that county.

6 (2) After an elector has complied with subsection (1)(a), (1)(b), or (1)(c), the county election administrator
7 shall place the elector's name on the active voting list for that county.

8 (3) An elector reactivated pursuant to subsection (1)(a) is a legally registered elector for purposes of the
9 election in which the elector voted."

10

11 **Section 13.** Section 13-2-304, MCA, is amended to read:

12 **"13-2-304. Late registration -- late changes -- nonapplicability for school elections.** (1) Except as
13 provided in subsections (2) and (3), the following provisions apply:

14 (a) An elector may register or change the elector's voter registration information after the close of regular
15 registration in 13-2-301 and vote in the election if the election administrator in the county where the elector
16 resides receives and verifies the elector's voter registration information prior to the close of the polls on election
17 day.

18 (b) Late registration is closed from noon to 5 p.m. on the day before the election.

19 (c) Except as provided in 13-2-514(2)(a), an elector who registers or changes the elector's voter
20 information pursuant to this section may vote in the election only if the elector obtains the ballot from and returns
21 it to the location designated by the county election administrator.

22 (2) If an elector has already been ~~sent an absentee~~ issued a ballot for the election, the elector may
23 change the elector's voter registration information only ~~with respect to the next election~~ if the original voted ballot
24 has not been received at the county election office and if the original ballot that was issued is marked by the
25 issuing county as void in the statewide voter registration database prior to the change.

26 (3) The provisions of subsection (1) do not apply with respect to an elector's registration to vote in a
27 school election held pursuant to Title 20."

28

29 **Section 14.** Section 13-2-511, MCA, is amended to read:

30 **"13-2-511. Transferring registration or changing name.** An elector shall notify the election

1 administrator in a written communication signed by the elector of a change in residence within the county or a
 2 change in name ~~by using a transfer form provided by the election administrator or by completing the changed~~
 3 ~~information on a registration or mail registration form. The form must be signed and affirmed or verified as~~
 4 ~~required on the form. If a registration or mail registration form is used, it must be clearly marked "for transfer of~~
 5 ~~address" or "for change of name" in a space provided on the form for that purpose.~~"

6

7 **Section 15.** Section 13-2-512, MCA, is amended to read:

8 **"13-2-512. Right to vote when precinct or name changed -- change of status.** (1) An elector who
 9 has changed residence to a different precinct within the same county and has failed to notify the election
 10 administrator of the change by a transfer or new registration form may vote in the precinct at the polling place or
 11 by absentee or mail ballot in the precinct where the elector is registered at the first election at which the elector
 12 offers to vote after the change or at a central location designated by the election administrator unless the elector's
 13 registration has been canceled as provided in 13-2-402.

14 (2) An elector who still resides in the same precinct where registered, whose name has changed, and
 15 who has failed to notify the election administrator of the change by a new registration form may vote under the
 16 elector's former name at the first election at which the elector offers to vote after the change unless the elector's
 17 registration has been canceled as provided in 13-2-402.

18 (3) The elector shall state the elector's correct residence address and name when offering to vote and
 19 shall complete a transfer form or new registration form to make the necessary correction before being allowed
 20 to ~~sign the precinct register and~~ vote in a polling place election or by absentee or mail ballot."

21

22 **Section 16.** Section 13-3-105, MCA, is amended to read:

23 **"13-3-105. Designation of polling place.** (1) The county governing body shall designate the polling
 24 place for each precinct no later than 30 days before a primary election. The same polling place must be used for
 25 both the primary and general election if at all possible. Changes may be made by the governing body in
 26 designated polling places up to 10 days before an election if a designated polling place is not available. Polling
 27 places may be located outside the boundaries of a precinct.

28 (2) Not more than 10 days or less than 2 days before an election, the election administrator shall publish
 29 in a newspaper of general circulation in the county a statement of the locations of the precinct polling places. The
 30 election administrator shall include in the published notice the accessibility designation for each polling place

1 according to the classification in 13-3-207. Notice may also be given as provided in 2-3-105 through 2-3-107.

2 (3) An election administrator may make changes in the location of a polling place if an emergency occurs
3 10 days or less before an election. Notice must be posted at both the old and new polling places, and other notice
4 may be given by whatever means available.

5 (4) Any ~~publicly owned~~ building may be used as a polling place. The building must be furnished at no
6 charge as long as no structural changes are required in order to use the building as a polling place.

7 (5) The exterior of the voting systems, or of the booths in which they are placed, and every part of the
8 polling place must be in plain view of the election judges."
9

10 **Section 17.** Section 13-4-102, MCA, is amended to read:

11 **"13-4-102. Manner of choosing election judges.** (1) Subject to 13-4-107, election judges must be
12 chosen from lists of qualified registered electors for each precinct in the county, submitted at least 45 days before
13 the primary election in even-numbered years by the county central committees of the political parties eligible to
14 nominate candidates in the primary.

15 (2) The list of each party may contain more names than the number of election judges to be appointed.
16 The names of those not appointed as election judges must be given to the election administrator for use in
17 making appointments to fill vacancies.

18 (3) Each board of election judges must include judges representing all parties that have submitted lists
19 as provided in subsection (1). No more than the number of election judges needed to obtain a simple majority
20 may be appointed from the list of one political party in each precinct. If any of the political parties entitled to do
21 so fail to submit a list meeting the requirements of this section, the governing body shall, to the extent possible,
22 appoint judges so that all parties eligible to participate in the primary are represented on each board.

23 (4) The election administrator shall make appointments to fill vacancies from the list provided for in
24 subsection (2). If the list is insufficient or if one or more of the eligible political parties fails to submit a list meeting
25 the requirements of this section, the election administrator may select enough people meeting the qualifications
26 of 13-4-107 to fill election judge vacancies in all precincts.

27 (5) An elector chosen to potentially serve as an election judge must be notified of selection at least 30
28 days before the primary election in even-numbered years. Each elector who agrees to serve as an election judge
29 shall attend a training class conducted under 13-4-203 and shall continue to serve as provided in 13-4-103."
30

1 **Section 18.** Section 13-4-207, MCA, is amended to read:

2 **"13-4-207. Judges to remain at polls -- emergency provisions -- part-time service.** (1) Election
3 judges may not leave the premises on which the polling place is located during the hours they are assigned to
4 work unless permission to leave is given by the chief election judge for that precinct. Permission may be granted
5 only for illness or a family emergency.

6 (2) A chief election judge must obtain the permission of the election administrator to leave the polling
7 place premises because of illness or an emergency. If the chief judge is excused, the election administrator shall
8 appoint one of the other judges to act as chief election judge.

9 (3) The time of departure and reason for leaving shall be entered near the oath form subscribed by the
10 election judge or on a form provided by the election administrator. The chief election judge shall sign the entry.

24 (3) Except as provided in subsection (4), the names of candidates for precinct committee representative
 25 of each political party must appear on the party ticket in the same manner as other candidates and are voted for
 26 in the same manner as other candidates.

27 (4) If only one person of each sex has been nominated to fill a ~~precinct's~~ party's precinct positions, the
 28 election administrator may decline to include that ~~precinct's~~ party's precinct election in the primary election. If a
 29 ~~precinct's~~ party's precinct election is not held during the primary election pursuant to this subsection, the county
 30 governing body shall declare elected by acclamation the candidates nominated for that ~~precinct's~~ party's precinct

1 committee representative positions.

2 (5) Write-in votes for committee precinct representatives may be counted as specified in 13-15-206(5)
3 only if the individual whose name is written in has filed a declaration of intent as a write-in candidate by the
4 deadline prescribed in 13-10-211(1)."

6 **Section 76.** Section 13-38-202, MCA, is amended to read:

7 **"13-38-202. Committee representatives as party representatives -- county and city central**
8 **committees.** (1) Each committee representative shall represent the representative's political party for the precinct
9 in all ward or subdivision committees formed.

10 (2) The committee representatives in each precinct constitute the county central committee of the
11 respective political parties.

12 (3) Committee representatives who reside within the limits of a city are ex officio the city central
13 committee of their respective political parties and have the power to make their own rules not inconsistent with
14 those of the county central committee. However, the county central committee has the power to fill vacancies in
15 the city central committee.

16 (4) Each precinct committee representative serves a term of 2 years ~~from the date of~~ beginning on the
17 first Monday of January following the election.

18 (5) If a vacancy occurs, the remaining members of the county committee may select a precinct resident
19 to fill the vacancy."
