4 A BILL FOR AN ACT ENTITLED: "AN ACT REVISING LAWS RELATED TO THE MAINTENANCE OF LANDS
5 OWNED OR ACQUIRED BY THE DEPARTMENT OF FISH, WILDLIFE, AND PARKS; ELIMINATING THE
6 STATUTORY APPROPRIATION OF THE MAINTENANCE ACCOUNT; PRIORITIZING THE USE OF CERTAIN
7 MAINTENANCE ACCOUNT MONEY FOR WILDLIFE MANAGEMENT AREAS; REQUIRING REPORTING;
8 DEDICATING A PORTION OF NONRESIDENT WOLF AND GRIZZLY BEAR LICENSE REVENUE TO
9 WILDLIFE HABITAT FUNDING; AMENDING SECTIONS 17-7-502, 87-1-230, AND 87-1-242, MCA; AMENDING
10 SECTION 8, CHAPTER 427, LAWS OF 2009; AND PROVIDING EFFECTIVE DATES AND A TERMINATION

13 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

15 **Section 1.** Section 17-7-502, MCA, is amended to read:

16 **"17-7-502. Statutory appropriations -- definition -- requisites for validity.** (1) A statutory
17 appropriation is an appropriation made by permanent law that authorizes spending by a state agency without the
18 need for a biennial legislative appropriation or budget amendment.

19 (2) Except as provided in subsection (4), to be effective, a statutory appropriation must comply with both
20 of the following provisions:

21 (a) The law containing the statutory authority must be listed in subsection (3).

22 (b) The law or portion of the law making a statutory appropriation must specifically state that a statutory
23 appropriation is made as provided in this section.

4 (4) There is a statutory appropriation to pay the principal, interest, premiums, and costs of issuing,
 5 paying, and securing all bonds, notes, or other obligations, as due, that have been authorized and issued
 6 pursuant to the laws of Montana. Agencies that have entered into agreements authorized by the laws of Montana
 7 to pay the state treasurer, for deposit in accordance with 17-2-101 through 17-2-107, as determined by the state
 8 treasurer, an amount sufficient to pay the principal and interest as due on the bonds or notes have statutory
 9 appropriation authority for the payments. (In subsection (3): pursuant to sec. 10, Ch. 360, L. 1999, the inclusion
 10 of 19-20-604 terminates when the amortization period for the teachers' retirement system's unfunded liability is
 11 10 years or less; pursuant to sec. 10, Ch. 10, Sp. L. May 2000, secs. 3 and 6, Ch. 481, L. 2003, and sec. 2, Ch.
 12 459, L. 2009, the inclusion of 15-35-108 terminates June 30, 2019; pursuant to sec. 17, Ch. 593, L. 2005, and
 13 sec. 1, Ch. 186, L. 2009, the inclusion of 15-31-906 terminates January 1, 2015; pursuant to sec. 73, Ch. 44, L.
 14 2007, the inclusion of 19-6-410 terminates upon the death of the last recipient eligible under 19-6-709(2) for the
 15 supplemental benefit provided by 19-6-709; pursuant to sec. 14, Ch. 374, L. 2009, the inclusion of 53-9-113

19 **Section 2.** Section 87-1-230, MCA, is amended to read:

20 **"87-1-230. (Temporary) Maintenance account -- annual report.** (1) There is a maintenance account
 21 in the state special revenue fund. In addition to the funds set aside for maintenance of land or water acquired by
 22 the department pursuant to 87-1-209(1), the department shall also deposit into the maintenance account:

23 (a) funds dedicated for development and maintenance of real property used for wildlife habitat under
 24 87-1-242(4)~~(a)~~;

25 (b) interest earned on the account; and

26 (c) any other money that the department considers appropriate or necessary for maintenance of the
 27 department's land or water.

28 (2) Funds deposited in the account ~~are statutorily appropriated, as provided in 17-7-502, to the~~
 29 ~~department and~~ may be used only for maintenance of any land or water acquired by the department. The
 30 department shall give priority to using funds deposited pursuant to subsection (1)(a) for wildlife habitat

12 ~~**"87-1-242. (Temporary) Funding for wildlife habitat.** (1) The amount of money specified in this
 13 subsection from the sale of each hunting license or permit listed must be used exclusively by the commission to
 14 secure, develop, and maintain wildlife habitat, subject to appropriation by the legislature:~~

15 ~~—— (a) Class B-10, nonresident combination, \$77;~~

16 ~~—— (b) Nonresident antelope, \$20;~~

17 ~~—— (c) Nonresident moose, \$20;~~

18 ~~—— (d) Nonresident mountain goat, \$20;~~

19 ~~—— (e) Nonresident mountain sheep, \$20;~~

20 ~~—— (f) Class D-1, nonresident mountain lion, \$20;~~

21 ~~—— (g) Nonresident black bear, \$20;~~

 8 commission to secure, develop, and maintain wildlife habitat, subject to appropriation by the legislature:

10 (b) Nonresident antelope, \$20;

11 (c) Nonresident moose, \$20;

12 (d) Nonresident mountain goat, \$20;

13 (e) Nonresident mountain sheep, \$20;

14 (f) Class D-1, nonresident mountain lion, \$20;

15 (g) Nonresident black bear, \$20;

16 (h) Nonresident wild turkey, \$10;

17 (i) Class AAA, combination sports, \$7;

18 (j) Class B-11 nonresident deer combination, \$200;

19 (k) Class E-2 nonresident wolf, \$20;

20 (l) Nonresident grizzly bear, \$20.

21 (2) Twenty percent of any increase in the fee for the Class B-7 license or any license or permit listed in
 22 subsection (1) must be allocated for use as provided in subsection (1).

23 (3) ~~Eighty Fifty percent~~ TWO-THIRDS FIFTY PERCENT of the money allocated by this section, together with
 24 the interest and income from the money, must be used to secure wildlife habitat pursuant to 87-1-209.

25 (4) ~~Twenty Fifty percent~~ ONE-THIRD FIFTY PERCENT of the money allocated by this section must be
 26 deposited in the maintenance account established in 87-1-230 and used as follows:

27 ~~—— (a) up to 50% a year may be used for development and maintenance of real property used for wildlife~~

29 ~~—— (b) the remainder and any money not allocated for development and maintenance under subsection~~
