4 A BILL FOR AN ACT ENTITLED: "AN ACT PROVIDING FOR THE OPERATION OF ELECTRIC VEHICLES BY
5 DISABLED PERSONS; CREATING A LOW-SPEED RESTRICTED DRIVER'S LICENSE; DEFINING
6 "LOW-SPEED ELECTRIC VEHICLE" AND "GOLF CART"; PROHIBITING THE OPERATION OF A LOW-SPEED
7 ELECTRIC VEHICLE ON CERTAIN HIGHWAYS; PROVIDING FOR PERMANENT REGISTRATION OF A
8 LOW-SPEED ELECTRIC VEHICLE; PROVIDING FOR THE REGISTRATION OF A LOW-SPEED ELECTRIC
9 VEHICLE AND A GOLF CART OPERATED BY A PERSON WITH A LOW-SPEED RESTRICTED DRIVER'S
10 LICENSE; ALLOWING FOR OPERATION OF A LOW-SPEED ELECTRIC VEHICLE WITHOUT A
11 MOTORCYCLE ENDORSEMENT; REQUIRING CERTAIN EQUIPMENT ON A LOW-SPEED ELECTRIC
12 VEHICLE; AMENDING SECTIONS ~~61-1-101, 61-3-562,~~ 10-3-1307, 23-1-105, 61-1-101, 61-3-201, 61-3-301,
13 61-3-312, 61-3-321, 61-3-332, 61-5-102, 61-9-220, AND 61-9-432, MCA; AND PROVIDING A DELAYED
14 EFFECTIVE DATE."

16 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

18 ~~NEW SECTION. Section 1. Low-speed electric vehicle -- operating requirements. (1) A low-speed~~
19 ~~electric vehicle may be operated only by a disabled person and only on a highway for which the posted speed~~
20 ~~limit does not exceed 25 miles per hour.~~
21 ~~(2) A person is considered disabled for purposes of this section if the person is eligible for a special~~
22 ~~parking permit as provided in 49-4-301.~~
23 ~~(3) Except as provided in subsection (1), the provisions of this chapter apply to the operator of a~~
24 ~~low-speed electric vehicle.~~

26 NEW SECTION. SECTION 1. LOW-SPEED ELECTRIC VEHICLE -- GOLF CART OPERATED BY PERSON WITH
27 LOW-SPEED RESTRICTED DRIVER'S LICENSE -- OPERATING REQUIREMENTS. (1) A LOW-SPEED ELECTRIC VEHICLE MAY BE
28 OPERATED ONLY BY A PERSON WITH A LOW-SPEED RESTRICTED DRIVER'S LICENSE.

29 (2) A LOW-SPEED ELECTRIC VEHICLE OR GOLF CART OPERATED BY A PERSON WITH A LOW-SPEED RESTRICTED
30 DRIVER'S LICENSE MAY BE OPERATED ONLY ON A HIGHWAY FOR WHICH THE POSTED SPEED LIMIT DOES NOT EXCEED 25

1 MILES PER HOUR.

2 (3) A LOW-SPEED ELECTRIC VEHICLE OR GOLF CART OPERATED BY A PERSON WITH A LOW-SPEED RESTRICTED
3 DRIVER'S LICENSE MAY NOT CROSS A HIGHWAY WITH A POSTED SPEED LIMIT OF GREATER THAN 45 MILES PER HOUR.

4 (4) EXCEPT AS PROVIDED IN SUBSECTIONS (1) THROUGH (3), THE PROVISIONS OF THIS CHAPTER APPLY TO A
5 LOW-SPEED ELECTRIC VEHICLE OR GOLF CART OPERATED BY A PERSON WITH A LOW-SPEED RESTRICTED DRIVER'S
6 LICENSE.

7
8 NEW SECTION. SECTION 2. LOW-SPEED RESTRICTED DRIVER'S LICENSE. (1) THE DEPARTMENT MAY ISSUE
9 A LOW-SPEED RESTRICTED DRIVER'S LICENSE TO A PERSON WHO IS PHYSICALLY OR OTHERWISE IMPAIRED IN A MANNER
10 AND DEGREE THAT PREVENT THE PERSON FROM SAFELY OPERATING A MOTOR VEHICLE ACROSS THE RANGE OF SPEEDS
11 PERMITTED OR REQUIRED ON A PUBLIC HIGHWAY.

12 (2) (A) TO QUALIFY FOR A LOW-SPEED RESTRICTED DRIVER'S LICENSE, AN APPLICANT SHALL SUBMIT TO THE
13 DEPARTMENT A MEDICAL EVALUATION OR STATEMENT FROM A TREATING PHYSICIAN THAT ATTESTS TO THE PERSON'S
14 IMPAIRMENT AND RESULTING INABILITY TO SAFELY OPERATE A MOTOR VEHICLE ACROSS THE RANGE OF SPEEDS PERMITTED
15 OR REQUIRED ON A PUBLIC HIGHWAY.

16 (B) THE APPLICANT MUST BE OTHERWISE QUALIFIED FOR A DRIVER'S LICENSE UNDER THIS CHAPTER AND SHALL
17 APPLY FOR A DRIVER'S LICENSE UNDER 61-5-107, PAY THE FEES REQUIRED IN 61-5-111, AND PASS THE VISION TEST, THE
18 KNOWLEDGE TEST, AND THE ROAD TEST REQUIRED UNDER 61-5-110. THE ROAD TEST MUST BE MODIFIED TO CONFORM
19 TO THE OPERATIONAL LIMITATIONS OF THE VEHICLE.

20 (3) THE DEPARTMENT MAY ISSUE A LOW-SPEED RESTRICTED INSTRUCTION PERMIT, VALID FOR 30 DAYS FROM
21 THE DATE OF ISSUANCE, TO A PERSON WHO QUALIFIES FOR A LOW-SPEED RESTRICTED DRIVER'S LICENSE UNDER THIS
22 SECTION AND WHO PASSES THE VISION TEST AND KNOWLEDGE TEST REQUIRED IN 61-5-110. A PERMITHOLDER MAY
23 OPERATE A LOW-SPEED ELECTRIC VEHICLE OR GOLF CART PURSUANT TO [SECTION 1] WHILE IN THE IMMEDIATE
24 POSSESSION OF THE PERMIT AND ACCOMPANIED BY A LICENSED DRIVER SEATED BESIDE THE PERMITHOLDER."

25
26 SECTION 3. SECTION 10-3-1307, MCA, IS AMENDED TO READ:

27 **"10-3-1307. Responsibilities of department of transportation -- assessment and collection of fees**
28 **-- issuance of permits -- inspection of motor carriers.** (1) After receiving notification from the person or entity
29 that plans to ship high-level radioactive waste or transuranic waste through the state, the department of
30 transportation shall assess fees according to the following schedule:

- 1 (a) a fee of \$2,500 must be assessed for each cask designed for transport by truck; and
- 2 (b) a fee of \$4,500 must be assessed for the first cask designed for transport by rail and a fee of \$3,000
- 3 for each additional cask designed for transport by rail that is shipped by the same person or entity in the same
- 4 shipment.
- 5 (2) Payment of the fees provided in subsection (1) is the responsibility of the person or entity who owns
- 6 the waste.
- 7 (3) Upon receipt of the fees provided in subsection (1), the department of transportation shall issue to
- 8 the owner of the waste a permit that must be carried with the waste as it is traveling through the state.
- 9 (4) The department of transportation shall deposit all of the fees collected under this section in the
- 10 radioactive waste transportation monitoring, emergency response, and training account created in 10-3-1304.
- 11 (5) If the waste is to be transported through the state by motor carrier, the department of transportation
- 12 shall coordinate with the highway patrol on the inspection of the motor carrier by the motor carrier services
- 13 division.
- 14 (6) This section does not exempt the operator of a motor carrier from any of the provisions of Title 61,
- 15 chapter 10, from Title 69, chapter 12, or from any other law that applies to the operation of motor vehicles in
- 16 Montana.
- 17 (7) Fees under this section must be assessed regardless of ownership, and ~~61-3-321(13)~~ 61-3-321(14)
- 18 and 61-10-127 do not apply."

20 **SECTION 4. SECTION 23-1-105, MCA, IS AMENDED TO READ:**

21 **"23-1-105. Fees and charges.** (1) The department may levy and collect reasonable fees or other

22 charges for the use of privileges and conveniences that may be provided and to grant concessions that it

23 considers advisable, except as provided in subsections (2) and (6). All money derived from the activities of the

24 department, except as provided in subsection (5), must be deposited in the state treasury in a state special

25 revenue fund to the credit of the department.

26 (2) Overnight camping fees established by the department under subsection (1) must be discounted 50%

27 for a campsite rented by a person who is a resident of Montana, as defined in 87-2-102, and either 62 years of

28 age or older or certified as disabled in accordance with rules adopted by the department.

29 (3) For a violation of any fee collection rule involving a vehicle, the registered owner of the vehicle at the

30 time of the violation is personally responsible if an adult is not in the vehicle at the time the violation is discovered

1 by an authorized officer. A defense that the vehicle was driven into the fee area by another person is not
2 allowable unless it is shown that at that time, the vehicle was being used without the consent of the registered
3 owner.

4 (4) Money received from the collection of fees and charges is subject to the deposit requirements of
5 17-6-105(6) unless the department has submitted and received approval for a modified deposit schedule pursuant
6 to 17-6-105(8).

7 (5) There is a fund of the enterprise fund type, as defined in 17-2-102(2)(a), for the purpose of managing
8 state park visitor services revenue. The fund is to be used by the department to serve the recreating public by
9 providing for the obtaining of inventory through purchase, production, or donation and for the sale of educational,
10 commemorative, and interpretive merchandise and other related goods and services at department sites and
11 facilities. The fund consists of money from the sale of educational, commemorative, and interpretive merchandise
12 and other related goods and services and from donations. Gross revenue from the sale of educational,
13 commemorative, and interpretive merchandise and other related goods and services must be deposited in the
14 fund. All interest and earnings on money deposited in the fund must be credited to the fund for use as provided
15 in this subsection.

16 (6) In recognition of the fact that individuals support state parks through the payment of certain motor
17 vehicle registration fees, persons who pay the fee provided for in ~~61-3-321(18)(a)~~ 61-3-321(19)(a) may not be
18 required to pay a day-use fee for access to state parks. Other fees for the use of state parks and fishing access
19 sites, such as overnight camping fees, are still chargeable and may be collected by the department."
20

21 **Section 5.** Section 61-1-101, MCA, is amended to read:

22 **"61-1-101. Definitions.** As used in this title, unless the context indicates otherwise, the following
23 definitions apply:

24 (1) (a) "Authorized agent" means a person who has executed a written agreement with the department
25 and is specifically authorized by the department to electronically access and update the department's motor
26 vehicle titling, registration, or driver records, using an approved automated interface, for specific functions or
27 purposes upon behalf of a third party.

28 (b) For purposes of this subsection (1), "person" means an individual, corporation, partnership, limited
29 partnership, limited liability company, association, joint venture, state agency, local government unit, another state
30 government, the United States, a political subdivision of this or another state, or any other legal or commercial

1 entity.

2 (2) "Authorized agent agreement" means the written agreement executed between an authorized agent
3 and the department that sets the technical and operational program standards, compliance criteria, payment
4 options, and service expectations by which the authorized agent is required to operate in performing specific
5 motor vehicle or driver-related record functions.

6 (3) "Bus" means a motor vehicle designed for carrying more than 10 passengers and used for the
7 transportation of persons and any other motor vehicle, other than a taxicab, designed and used for the
8 transportation of persons for compensation.

9 (4) (a) "Business entity" means a corporation, association, partnership, limited liability partnership, limited
10 liability company, or other legal entity recognized under state law.

11 (b) The term does not include an individual.

12 (5) (a) "Camper" means a structure designed to be mounted in the cargo area of a truck or attached to
13 an incomplete vehicle for the purpose of providing shelter for persons. The term includes but is not limited to a
14 cab-over, half cab-over, noncab-over, telescopic, and telescopic cab-over.

15 (b) The term does not include a truck canopy cover or topper.

16 (6) "Certificate of title" means the paper record issued by the department or by the appropriate agency
17 of another jurisdiction that establishes a verifiable record of ownership between an identified person or persons
18 and the motor vehicle specifically described in the record and that provides notice of a perfected security interest
19 in the motor vehicle.

20 (7) "Commercial driver's license" means:

21 (a) a driver's license issued under or granted by the laws of this state that authorizes a person to operate
22 a class of commercial motor vehicle; and

23 (b) the privilege of a person to drive a commercial motor vehicle, whether or not the person holds a valid
24 commercial driver's license.

25 (8) (a) "Commercial motor vehicle" means a motor vehicle or combination of motor vehicles used in
26 commerce to transport passengers or property if the vehicle:

27 (i) has a gross combination weight rating or a gross combination weight of 26,001 pounds or more,
28 whichever is greater, inclusive of a towed unit with a gross vehicle weight rating of more than 10,000 pounds;

29 (ii) has a gross vehicle weight rating or a gross vehicle weight of 26,001 pounds or more, whichever is
30 greater;

- 1 (iii) is designed to transport at least 16 passengers, including the driver;
- 2 (iv) is a school bus; or
- 3 (v) is of any size and is used in the transportation of hazardous materials as defined in 61-8-801.
- 4 (b) The following vehicles are not commercial motor vehicles:
- 5 (i) an authorized emergency service vehicle:
- 6 (A) equipped with audible and visual signals as required under 61-9-401 and 61-9-402; and
- 7 (B) entitled to the exemptions granted under 61-8-107;
- 8 (ii) a vehicle:
- 9 (A) controlled and operated by a farmer, family member of the farmer, or person employed by the farmer;
- 10 (B) used to transport farm products, farm machinery, or farm supplies to or from the farm within Montana
- 11 within 150 miles of the farm or, if there is a reciprocity agreement with a state adjoining Montana, within 150 miles
- 12 of the farm, including any area within that perimeter that is in the adjoining state; and
- 13 (C) not used to transport goods for compensation or for hire; or
- 14 (iii) a vehicle operated for military purposes by active duty military personnel, a member of the military
- 15 reserves, a member of the national guard on active duty, including personnel on full-time national guard duty,
- 16 personnel in part-time national guard training, and national guard military technicians, or active duty United States
- 17 coast guard personnel.
- 18 (c) For purposes of this subsection (8):
- 19 (i) "farmer" means a person who operates a farm or who is directly involved in the cultivation of land or
- 20 crops or the raising of livestock owned by or under the direct control of that person;
- 21 (ii) "gross combination weight rating" means the value specified by the manufacturer as the loaded weight
- 22 of a combination or articulated vehicle;
- 23 (iii) "gross vehicle weight rating" means the value specified by the manufacturer as the loaded weight of
- 24 a single vehicle; and
- 25 (iv) "school bus" has the meaning provided in 49 CFR 383.5.
- 26 (9) "Commission" means the state transportation commission.
- 27 (10) "Custom-built motorcycle" means a motorcycle that is equipped with:
- 28 (a) an engine that was manufactured 20 years prior to the current calendar year and that has been
- 29 altered from the manufacturer's original design;
- 30 (b) an engine that was manufactured to resemble an engine 20 or more years old and that has been

1 constructed in whole or in part from nonoriginal materials.

2 (11) "Custom vehicle" means a motor vehicle other than a motorcycle that:

3 (a) (i) was manufactured with a model year after 1948 and that is at least 25 years old; or

4 (ii) was built to resemble a vehicle manufactured after 1948 and at least 25 years before the current
5 calendar year, including a kit vehicle intended to resemble a vehicle manufactured after 1948 and that is at least
6 25 years old; and

7 (b) has been altered from the manufacturer's original design or has a body constructed from nonoriginal
8 materials.

9 (12) "Customer identification number" means:

10 (a) a driver's license or identification card number when the customer is an individual who has been
11 issued a driver's license or identification card by a state driver licensing authority;

12 (b) a federal employer or tax identification number when the customer is a business entity that has been
13 issued a federal employer or tax identification number;

14 (c) the identification number assigned by the secretary of state to a business entity authorized to do
15 business in this state under Title 35 if the customer is a business entity that does not have a federal employer
16 or tax identification number other than a social security number; or

17 (d) if the customer has not been issued one of the numbers described in subsections (12)(a) through
18 (12)(c), a number assigned to the customer by the department when a transaction is initiated under this title.

19 (13) (a) "Dealer" means a person that, for commission or profit, engages in whole or in part in the
20 business of buying, selling, exchanging, or accepting on consignment new or used motor vehicles, trailers,
21 semitrailers, pole trailers, travel trailers, motorboats, sailboats, snowmobiles, off-highway vehicles, or special
22 mobile equipment that is not registered in the name of the person.

23 (b) The term does not include the following:

24 (i) receivers, trustees, administrators, executors, guardians, or other persons appointed by or acting
25 under a judgment or order of any court of competent jurisdiction;

26 (ii) employees of the persons included in subsection (13)(b)(i) when engaged in the specific performance
27 of their duties as employees; or

28 (iii) public officers while performing or in the operation of their duties.

29 (14) "Declared weight" means the total unladen weight of a vehicle plus the weight of the maximum load
30 to be carried on the vehicle as stated by the registrant in the application for registration.

1 (15) "Department" means the department of justice acting directly or through its duly authorized officers
2 or agents.

3 (16) "Dolly or converter gear" means a device consisting of one or two axles with a fifth wheel and trailer
4 tongue used to support the forward end of a semitrailer, converting a semitrailer into a trailer.

5 (17) "Domiciled" means a place where:

6 (a) an individual establishes residence;

7 (b) a business entity maintains its principal place of business;

8 (c) the business entity's registered agent maintains an address; or

9 (d) a business entity most frequently uses, dispatches, or controls a motor vehicle, trailer, semitrailer,
10 or pole trailer that it owns or leases.

11 (18) "Driver" means a person who drives or is in actual physical control of a vehicle.

12 (19) "Driver's license" means a license or permit to operate a motor vehicle issued under or granted by
13 the laws of this state, including:

14 (a) any temporary license or instruction permit;

15 (b) the privilege of any person to drive a motor vehicle, whether or not the person holds a valid license;

16 (c) any nonresident's driving privilege;

17 (d) a motorcycle endorsement; or

18 (e) a commercial driver's license.

19 (20) "Electric personal assistive mobility device" means a device that has two nontandem wheels, is
20 self-balancing, and is designed to transport only one person with an electric propulsion system that limits the
21 maximum speed of the device to 12 1/2 miles an hour.

22 (21) "For hire" means an action performed for remuneration of any kind, whether paid or promised, either
23 directly or indirectly, or received or obtained through leasing, brokering, or buy-and-sell arrangements from which
24 a remuneration is obtained or derived for transportation service.

25 (22) (A) "GOLF CART" MEANS A MOTOR VEHICLE THAT IS DESIGNED FOR USE ON A GOLF COURSE TO CARRY A
26 PERSON OR PERSONS AND GOLF EQUIPMENT AND THAT HAS AN AVERAGE SPEED OF LESS THAN 15 MILES PER HOUR.

27 (B) EXCEPT AS PROVIDED IN 61-3-201, A GOLF CART IS EXEMPT FROM TITLING, REGISTRATION, AND MANDATORY
28 LIABILITY INSURANCE REQUIREMENTS UNDER THIS TITLE.

29 ~~(22)~~(23) "Gross vehicle weight" means the weight of a vehicle without load plus the weight of any load
30 on the vehicle.

1 ~~(23)~~(24) "Highway" or "public highway" means the entire width between the boundary lines of every
 2 publicly maintained way when any part of the publicly maintained way is open to the use of the public for purposes
 3 of vehicular travel.

4 ~~(24)~~(25) "Highway patrol officer" means a state officer authorized to direct or regulate traffic or to make
 5 arrests for violations of traffic regulations.

6 ~~(25)~~(26) "Implement of husbandry" means a vehicle that is designed for agricultural purposes and
 7 exclusively used by the owner of the vehicle in the conduct of the owner's agricultural operations.

8 ~~(26)~~(27) "Kit vehicle" is a motor vehicle assembled from a manufactured kit either as:

9 (a) a complete kit, consisting of a prefabricated body and chassis, to construct a new motor vehicle; or

10 (b) a kit with a prefabricated body to be mounted to an existing motor vehicle chassis and drivetrain,
 11 commonly referred to as a donor vehicle.

12 ~~(27)~~(28) "Light vehicle" means a motor vehicle commonly referred to as an automobile, van, sport utility
 13 vehicle, or truck having a manufacturer's rated capacity of 1 ton or less.

14 ~~(28)~~(29) ~~(a)~~ "Low-speed electric vehicle" means a motor vehicle, upon or by which a person may be
 15 transported, that:

16 ~~(i)~~(A) has four wheels;

17 ~~(ii)~~(B) has a maximum speed of AT LEAST 20 MILES AN HOUR AND NO GREATER THAN 25 miles an hour as
 18 certified by the manufacturer;

19 ~~(iii)~~(C) is propelled by its own power, using an electric motor or other device that transforms stored
 20 electrical energy into the motion of the vehicle;

21 ~~(iv)~~(D) stores electricity in batteries, ultracapacitors, or similar devices, which are charged from the power
 22 grid or from renewable electrical energy sources;

23 ~~(v)~~(E) has a wheelbase of 40 inches or greater and a wheel diameter of 10 inches or greater;

24 ~~(vi)~~(F) exhibits a manufacturer's compliance with 49 CFR, part 565, or displays a 17-character vehicle
 25 identification number as provided in 49 CFR, part 565; and

26 ~~(vii)~~(G) is equipped as provided in 61-9-432.

27 ~~(b) A low-speed electric vehicle must be treated as a light vehicle for purposes of titling and registration~~
 28 ~~under Title 61, chapter 3.~~

29 ~~(30) "LOW-SPEED RESTRICTED DRIVER'S LICENSE" MEANS A LICENSE OR PERMIT LIMITED TO THE OPERATION OF~~
 30 ~~A LOW-SPEED ELECTRIC VEHICLE OR A GOLF CART ISSUED UNDER OR GRANTED BY THE LAWS OF THIS STATE, INCLUDING:~~

- 1 (A) A TEMPORARY LICENSE OR INSTRUCTION PERMIT;
- 2 (B) THE PRIVILEGE OF A PERSON TO DRIVE A LOW-SPEED ELECTRIC VEHICLE OR GOLF CART UNDER THE
 3 AUTHORITY OF [SECTION 2], WHETHER OR NOT THE PERSON HOLDS A VALID DRIVER'S LICENSE; AND
- 4 (C) A NONRESIDENT'S SIMILARLY RESTRICTED DRIVING PRIVILEGE.
- 5 ~~(28)(29)~~(31) "Manufactured home" has the meaning provided in 15-24-201.
- 6 ~~(29)(30)~~(32) "Manufacturer" includes any person engaged in the manufacture of motor vehicles, trailers,
 7 semitrailers, pole trailers, travel trailers, motorboats, sailboats, snowmobiles, or off-highway vehicles as a regular
 8 business.
- 9 ~~(30)(31)~~(33) "Manufacturer's certificate of origin" means the original paper record produced and issued
 10 by the manufacturer of a vehicle or, if in a medium authorized by the department, an electronic record created
 11 and transmitted by the manufacturer of a vehicle to the manufacturer's agent or a licensed dealer. The record
 12 must establish the origin of the vehicle specifically described in the record and, upon assignment, transfers of
 13 ownership of the vehicle to the person or persons named in the certificate.
- 14 ~~(31)(32)~~(34) (a) "Medium-speed electric vehicle" is a motor vehicle, upon or by which a person may be
 15 transported, that:
- 16 (i) has a maximum speed of 45 miles an hour as certified by the manufacturer;
- 17 (ii) is propelled by its own power, using an electric motor or other device that transforms stored electrical
 18 energy into the motion of the vehicle;
- 19 (iii) stores electricity in batteries, ultracapacitors, or similar devices, which are charged from the power
 20 grid or from renewable electrical energy sources;
- 21 (iv) is fully enclosed and includes at least one door for entry;
- 22 (v) has a wheelbase of 40 inches or greater and a wheel diameter of 10 inches or greater;
- 23 (vi) exhibits a manufacturer's compliance with 49 CFR, part 565, or displays a 17-character vehicle
 24 identification number as provided in 49 CFR, part 565;
- 25 (vii) bears a sticker, affixed by the manufacturer or dealer, on the left side of the rear window that
 26 indicates the vehicle's maximum speed rating; and
- 27 (viii) as certified by the manufacturer, is equipped as provided in 61-9-432.
- 28 (b) A medium-speed electric vehicle must be treated as a light vehicle for purposes of titling and
 29 registration under Title 61, chapter 3.

4 motor vehicle, trailer, semitrailer, pole trailer, or travel trailer. A license plate must be securely fastened to prevent
5 it from swinging and may not be obstructed from plain view.

6 (b) A motorcycle, quadricycle, trailer, semitrailer, pole trailer, or travel trailer must have a single license
7 plate displayed on the rear of the vehicle. A custom vehicle or street rod registered under 61-3-320(1)(b) or
8 (1)(c)(iii) may display a single license plate firmly attached to the rear exterior of the custom vehicle or street rod.
9 All other motor vehicles must have one license plate displayed on the front and one license plate displayed on
10 the rear of the motor vehicle.

11 (c) A person may not display on a motor vehicle, trailer, semitrailer, pole trailer, or travel trailer at the
12 same time a number assigned to it under any motor vehicle law except as provided in this chapter.

13 (d) A low-speed electric vehicle or a golf cart operated by a person with a low-speed restricted driver's
14 license must have special license plates, as provided in 61-3-332(9), displayed on the front and rear of the
15 vehicle.

16 (2) A person may not purchase or display on a motor vehicle, trailer, semitrailer, pole trailer, or travel
17 trailer a license plate bearing the number assigned to any county, as provided in 61-3-332, other than the county
18 where the vehicle is domiciled or the county where the trailer, semitrailer, pole trailer, or travel trailer is domiciled
19 at the time of application for registration.

20 (3) It is unlawful to:

21 (a) display license plates issued to one motor vehicle, trailer, semitrailer, pole trailer, or travel trailer on
22 any other motor vehicle, trailer, semitrailer, pole trailer, or travel trailer unless legally transferred as provided by
23 statute;

24 (b) repaint old license plates to resemble current license plates; or

25 (c) display a prior design of standard license plates including military, veteran, and amateur radio license
26 plates, or any license plates that have been issued for 5 or more years after the replacement of the license plates
27 is required under 61-3-332(3)(a), except as provided in 61-3-332(3)(c) and (3)(d), 61-3-448, or 61-3-468.

28 (4) For the purposes of this section, "conspicuously displayed" means that the required license plates
29 are obviously visible and firmly attached to:

30 (a) the front bumper and the rear bumper of a motor vehicle equipped with front and rear bumpers,

1 except for a custom vehicle or street rod as provided in subsection (1)(b); or

2 (b) a clearly visible location on the rear of a trailer, semitrailer, pole trailer, or travel trailer."

4 **SECTION 8. SECTION 61-3-312, MCA, IS AMENDED TO READ:**

5 **"61-3-312. Renewal of registration -- exceptions -- grace period.** (1) Except as provided in 61-3-313
6 and 61-3-721, the registration of a motor vehicle under this chapter must be renewed on or before the last day
7 of the month of the motor vehicle's registration period following the expiration of the motor vehicle's registration.

8 (2) Except as provided in subsection (4), a person may renew a motor vehicle's registration by submitting
9 full payment for the fees or taxes required under 61-3-303 and ~~61-3-321(12)~~ 61-3-321(13) to the department, an
10 authorized agent, or a county treasurer in any county of this state.

11 (3) The department, an authorized agent, or a county treasurer may use the online motor vehicle liability
12 insurance verification system provided in 61-6-157 to verify proof of compliance with 61-6-301.

13 (4) Beginning July 1, 2011, and except when the verification system is temporarily unavailable, a
14 registration may not be renewed when compliance with 61-6-301 cannot be determined using the verification
15 system.

16 (5) Except as provided in 61-3-315, the registration period originally assigned under 61-3-311 must be
17 retained and the duration of the renewed registration is determined in accordance with 61-3-311. A registration
18 receipt is valid for the registration period for which it is issued.

19 (6) The owner of a motor vehicle subject to registration renewal under the provisions of this section is
20 considered to have renewed the motor vehicle's registration in a timely manner if the owner submits full payment
21 for the required fees or taxes, as prescribed in the mail renewal notice from the department, to the department,
22 an authorized agent, or a county treasurer on or before the last day of the month of the motor vehicle's
23 registration period and if, beginning July 1, 2011, the department, authorized agent, or county treasurer
24 determines the owner is in compliance with 61-6-301 using the verification system provided in 61-6-157.

25 (7) The department, an authorized agent, or a county treasurer may not renew the registration of a motor
26 vehicle for which ownership has been transferred and that was originally registered without being titled under the
27 provisions of 61-3-303(3)(b) unless:

28 (a) the previously issued certificate of title has been surrendered to the department, an authorized agent,
29 or the county treasurer and the process for issuing a certificate of title has been completed; or

30 (b) the person to whom ownership of the motor vehicle has been transferred presents an affidavit and

1 bond in support of the application for a certificate of title as permitted in 61-3-208."

3 **SECTION 9. SECTION 61-3-321, MCA, IS AMENDED TO READ:**

4 **"61-3-321. Registration fees of vehicles and vessels -- certain vehicles exempt from registration**
5 **fees -- disposition of fees.** (1) Except as otherwise provided in this section, registration fees must be paid upon
6 registration or, if applicable, renewal of registration of motor vehicles, snowmobiles, watercraft, trailers,
7 semitrailers, and pole trailers as provided in subsections (2) through ~~(19)~~ (20):

8 (2) Unless a light vehicle is permanently registered under 61-3-562, the annual registration fee for light
9 vehicles, trucks and buses under 1 ton, and logging trucks less than 1 ton is as follows:

10 (a) if the vehicle is 4 or less years old, \$217;

11 (b) if the vehicle is 5 through 10 years old, \$87; and

12 (c) if the vehicle is 11 or more years old, \$28.

13 (3) Except as provided in subsection ~~(14)~~ (15), the one-time registration fee based on the declared
14 weight of a trailer, semitrailer, or pole trailer is as follows:

15 (a) if the declared weight is less than 6,000 pounds, \$61.25; or

16 (b) if the declared weight is 6,000 pounds or more, \$148.25.

17 (4) Except as provided in subsection ~~(14)~~ (15), the one-time registration fee for motor vehicles owned
18 and operated solely as collector's items pursuant to 61-3-411, based on the weight of the vehicle, is as follows:

19 (a) 2,850 pounds and over, \$10; and

20 (b) under 2,850 pounds, \$5.

21 (5) Except as provided in subsection ~~(14)~~ (15), the one-time registration fee for off-highway vehicles other
22 than a quadricycle or motorcycle is \$61.25.

23 (6) The annual registration fee for heavy trucks, buses, and logging trucks in excess of 1 ton is \$22.75.

24 (7) (a) The annual registration fee for a motor home, based on the age of the motor home, is as follows:

25 (i) less than 2 years old, \$282.50;

26 (ii) 2 years old and less than 5 years old, \$224.25;

27 (iii) 5 years old and less than 8 years old, \$132.50; and

28 (iv) 8 years old and older, \$97.50.

29 (b) The owner of a motor home that is 11 years old or older and that is subject to the registration fee
30 under this section may permanently register the motor home upon payment of:

- 1 (i) a one-time registration fee of \$237.50;
- 2 (ii) unless a new set of license plates is being issued, an insurance verification fee of \$5, which must be
3 deposited in the account established under 61-6-158; and
- 4 (iii) if applicable, five times the renewal fees for personalized license plates under 61-3-406.
- 5 (8) (a) Except as provided in subsection ~~(14)~~ (15), the one-time registration fee for motorcycles and
6 quadricycles registered for use on public highways is \$53.25, and the one-time registration fee for motorcycles
7 and quadricycles registered for both off-road use and for use on the public highways is \$114.50.
- 8 (b) An additional fee of \$16 must be collected for the registration of each motorcycle or quadricycle as
9 a safety fee, which must be deposited in the state motorcycle safety account provided for in 20-25-1002.
- 10 (9) Except as provided in subsection ~~(14)~~ (15), the one-time registration fee for travel trailers, based on
11 the length of the travel trailer, is as follows:
- 12 (a) under 16 feet in length, \$72; and
- 13 (b) 16 feet in length or longer, \$152.
- 14 (10) Except as provided in subsection ~~(14)~~ (15), the one-time registration fee for a motorboat, sailboat,
15 personal watercraft, or motorized pontoon required to be numbered under 23-2-512 is as follows:
- 16 (a) for a personal watercraft or a motorboat, sailboat, or motorized pontoon less than 16 feet in length,
17 \$65.50;
- 18 (b) for a motorboat, sailboat, or motorized pontoon at least 16 feet in length but less than 19 feet in
19 length, \$125.50; and
- 20 (c) for a motorboat, sailboat, or motorized pontoon 19 feet in length or longer, \$295.50.
- 21 (11) (a) Except as provided in subsections (11)(b) and ~~(14)~~ (15), the one-time registration fee for a
22 snowmobile is \$60.50.
- 23 (b) (i) A snowmobile that is licensed by a Montana business and is owned exclusively for the purpose
24 of daily rental to customers is assessed:
- 25 (A) a fee of \$40.50 in the first year of registration; and
- 26 (B) if the business reregisters the snowmobile for a second year, a fee of \$20.
- 27 (ii) If the business reregisters the snowmobile for a third year, the snowmobile must be permanently
28 registered and the business is assessed the registration fee imposed in subsection (11)(a).
- 29 (12) (a) The one-time registration fee for a low-speed electric vehicle is \$53.25.
- 30 (b) The one-time registration fee for a golf cart that is owned by a person who has or is applying for a

1 low-speed restricted driver's license is \$53.25.

2 ~~(12)~~(13) (a) Except as provided in subsection ~~(12)~~(b) (13)(b), a fee of \$10 must be collected when a new
3 set of standard license plates, a new single standard license plate, or a replacement set of special license plates
4 required under 61-3-332 is issued. The \$10 fee imposed under this subsection does not apply when previously
5 issued license plates are transferred under 61-3-335. All registration fees imposed under this section must be
6 paid if the vehicle to which the plates are transferred is not currently registered.

7 (b) Until January 1, 2015, an additional fee of \$15 must be collected if a vehicle owner elects to keep
8 the same license plate number from license plates issued on or after January 1, 2006, but before January 1,
9 2010, when replacement of those plates is required under 61-3-332(3).

10 (c) The fees imposed in this subsection ~~(12)~~ (13) must be deposited in the account established under
11 61-6-158, except that \$2 of the fee imposed in subsection ~~(12)~~(a) (13)(a) must be deposited in the state general
12 fund.

13 ~~(13)~~(14) The provisions of this part with respect to the payment of registration fees do not apply to and
14 are not binding upon motor vehicles, trailers, semitrailers, snowmobiles, watercraft, or tractors owned or
15 controlled by the United States of America or any state, county, city, or special district, as defined in 18-8-202,
16 or to a vehicle or vessel that meets the description of property exempt from taxation under 15-6-201(1)(a), (1)(c),
17 (1)(d), (1)(e), (1)(f), (1)(g), (1)(i), (1)(j), (1)(l), or (1)(m), 15-6-203, or 15-6-215, except as provided in 61-3-520.

18 ~~(14)~~(15) Whenever ownership of a trailer, semitrailer, pole trailer, off-highway vehicle, motorcycle,
19 quadricycle, travel trailer, motor home, motorboat, sailboat, personal watercraft, motorized pontoon, snowmobile,
20 ~~or~~ motor vehicle owned and operated solely as a collector's item pursuant to 61-3-411, or low-speed electric
21 vehicle is transferred, the new owner shall title and register the vehicle or vessel as required by this chapter and
22 pay the fees imposed under this section.

23 ~~(15)~~(16) A person eligible for a waiver under 61-3-460 is exempt from the fees required under this
24 section.

25 ~~(16)~~(17) Except as otherwise provided in this section, revenue collected under this section must be
26 deposited in the state general fund.

27 ~~(17)~~(18) The fees imposed by subsections (2) through ~~(14)~~ (12) are not required to be paid by a dealer
28 for the enumerated vehicles or vessels that constitute inventory of the dealership.

29 ~~(18)~~(19) (a) Unless a person exercises the option in subsection ~~(18)~~(b) (19)(b), an additional fee of \$4
30 must be collected for each light vehicle registered under this part. This fee must be accounted for and transmitted

1 separately from the registration fee. The fee must be deposited in an account in the state special revenue fund
 2 to be used for state parks, for fishing access sites, and for the operation of state-owned facilities. Of the \$4 fee,
 3 the department of fish, wildlife, and parks shall use \$3.50 for state parks, 25 cents for fishing access sites, and
 4 25 cents for the operation of state-owned facilities at Virginia City and Nevada City.

12 ~~(20)(21)~~ This section does not apply to a motor vehicle, trailer, semitrailer, or pole trailer that is governed
 13 by 61-3-721."

15 **SECTION 10. SECTION 61-3-332, MCA, IS AMENDED TO READ:**

16 **"61-3-332. Standard license plates.** (1) In addition to special license plates, collegiate license plates,
 17 generic specialty license plates, and fleet license plates authorized under this chapter, a separate series of
 18 standard license plates must be issued for motor vehicles, quadricycles, travel trailers, trailers, semitrailers, and
 19 pole trailers registered in this state or offered for sale by a vehicle dealer licensed in this state. Standard license
 20 plates issued to licensed vehicle dealers must be readily distinguishable from license plates issued to vehicles
 21 owned by other persons.

22 (2) (a) Except as provided in 61-3-479 and subsections (2)(b), (3)(b), and (3)(c) of this section, all
 23 standard license plates for motor vehicles, trailers, semitrailers, or pole trailers must bear a distinctive marking,
 24 as determined by the department, and be furnished by the department. In years when standard license plates
 25 are not reissued for a vehicle, the department shall provide a registration decal that must be affixed to the rear
 26 license plate of the vehicle.

27 (b) For light vehicles that are permanently registered as provided in 61-3-562 and motor vehicles
 28 described in 61-3-303(9) that are permanently registered, the department shall provide a distinctive registration
 29 decal indicating that the motor vehicle is permanently registered. The registration decal must be affixed to the rear
 30 license plate of the permanently registered motor vehicle.

1 (c) For a travel trailer, motorcycle, quadricycle, trailer, semitrailer, or pole trailer that is permanently
2 registered as provided in 61-3-313(2), the department may use the word or an abbreviation for the word
3 "permanent" on the plate in lieu of issuing a registration decal for the plate.

4 (3) (a) (i) Beginning January 1, 2010, and every 5 years after that date, the department shall design
5 standard license plates to replace previously issued standard license plates. For the purposes of this subsection
6 (3), all military, veteran, and amateur radio license plates and any license plate with a wheelchair design,
7 excluding collegiate or generic specialty plates with a wheelchair design, are treated as standard license plates.

8 (ii) License plates issued on or after January 1, 2010, must be replaced with the most recent design of
9 standard license plates or a new replacement collegiate or generic speciality license plate if, upon renewal of
10 registration under ~~61-3-332~~ this section, the license plates are 5 or more years old or will become older than 5
11 years during the registration period.

12 (iii) License plates issued on or before January 1, 2010, must be replaced with the most recent design
13 of standard license plates or a new replacement collegiate or generic specialty license plate in accordance with
14 the implementation schedule adopted by the department under 61-3-315. Until January 1, 2015, and upon
15 payment of the fee required in ~~61-3-321(12)(b)~~ 61-3-321(13)(b), a vehicle owner may elect to keep the same
16 license plate number from license plates issued on or after January 1, 2006, but before January 1, 2010, when
17 replacement of those plates is required under this subsection.

18 (b) A motor vehicle that is registered for a 13-month to a 24-month period, as provided in 61-3-311, may
19 display the license plate and plate design in effect at the time of registration for the entire registration period.

20 (c) A light vehicle described in subsection (2)(b) or a motor home that is permanently registered may
21 display the license plate and plate design in effect at the time of registration for the entire period that the light
22 vehicle or motor home is permanently registered.

23 (d) The provisions of this subsection (3) do not apply to a travel trailer, motorcycle, quadricycle, trailer,
24 semitrailer, or pole trailer.

25 (e) The requirements of this subsection (3) apply to collegiate license plates authorized under 61-3-461
26 through 61-3-468, generic specialty license plates authorized under 61-3-472 through 61-3-481, commemorative
27 centennial license plates authorized under 61-3-448, and special military or veteran license plates authorized
28 under 61-3-458.

29 (4) For trailers and motor vehicles, other than motorcycles and quadricycles, plates must be of metal 6
30 inches wide and 12 inches in length. Except for generic specialty license plates, the outline of the state of

1 Montana must be used as a distinctive border on all license plates, and the word "Montana" must be placed on
2 each license plate. All license plates must be treated with a reflectorized background material according to
3 specifications prescribed by the department.

4 (5) The distinctive registration numbers for standard license plates must begin with a number one or with
5 a letter-number combination, such as "A 1" or "AA 1", or any other similar combination of letters and numbers.
6 Except for special license plates, collegiate license plates, generic specialty license plates, and fleet license
7 plates, the distinctive registration number or letter-number combination assigned to the motor vehicle must appear
8 on the plate preceded by the number of the county and appearing in horizontal order on the same horizontal
9 baseline. The county number must be separated from the distinctive registration number by a separation mark
10 unless a letter-number combination is used. The dimensions of the numerals and letters must be determined by
11 the department, and all county and registration numbers must be of equal height.

12 (6) For the use of exempt motor vehicles, trailers, semitrailers, or pole trailers and motor vehicles,
13 trailers, semitrailers, or pole trailers that are exempt from the registration fee as provided in 61-3-321, in addition
14 to the markings provided in this section, standard license plates must bear the following distinctive markings:

15 (a) For motor vehicles, trailers, semitrailers, or pole trailers owned by the state, the department may
16 designate the prefix number for the various state departments. All numbered plates issued to state departments
17 must bear the words "State Owned", and a year number may not be indicated on the plates because these
18 numbered plates are of a permanent nature and will be replaced by the department only when the physical
19 condition of numbered plates requires it.

20 (b) For motor vehicles, trailers, semitrailers, or pole trailers that are owned by the counties,
21 municipalities, and special districts, as defined in 18-8-202, organized under the laws of Montana and not
22 operating for profit, and that are used and operated by officials and employees in the line of duty and for motor
23 vehicles on loan from the United States government or the state of Montana to, or owned by, the civil air patrol
24 and used and operated by officials and employees in the line of duty, there must be placed on the standard
25 license plates assigned, in a position that the department may designate, the letter "X" or the word "EXEMPT".
26 Distinctive registration numbers for plates assigned to motor vehicles, trailers, semitrailers, or pole trailers of each
27 of the counties in the state and those of the municipalities and special districts that obtain plates within each
28 county must begin with number one and be numbered consecutively. Because these standard license plates are
29 of a permanent nature, they are subject to replacement by the department only when the physical condition of
30 the license plates requires it and a year number may not be displayed on the plates.

1 (7) For the purpose of this chapter, the several counties of the state are assigned numbers as follows:
2 Silver Bow, 1; Cascade, 2; Yellowstone, 3; Missoula, 4; Lewis and Clark, 5; Gallatin, 6; Flathead, 7; Fergus, 8;

5 Pondera, 26; Richland, 27; Powell, 28; Rosebud, 29; Deer Lodge, 30; Teton, 31; Stillwater, 32; Treasure, 33;

10 (8) Each type of special license plate approved by the legislature, except collegiate license plates
11 authorized in 61-3-463 and generic specialty license plates authorized in 61-3-472 through 61-3-481, must be
12 a separate series of plates, numbered as provided in subsection (5), except that the county number must be
13 replaced by a design that distinguishes each separate plate series. Unless otherwise specifically stated in this
14 section, the special plates are subject to the same rules and laws as govern the issuance of standard license
15 plates, must be placed or mounted on a motor vehicle, trailer, semitrailer, or pole trailer owned by the person who
16 is eligible to receive them, with the registration decal affixed to the rear license plate of the motor vehicle, trailer,
17 semitrailer, or pole trailer, and must be removed upon sale or other disposition of the motor vehicle, trailer,
18 semitrailer, or pole trailer.

19 (9) (a) A Montana resident who is eligible to receive a special parking permit under 49-4-301 may and
20 a low-speed electric vehicle or golf cart operated by a person with a low-speed restricted driver's license as
21 provided in [section 2] must, upon written application on a form prescribed by the department, be issued a special
22 license plate with a design or decal bearing a representation of a wheelchair as the symbol of a person with a
23 disability.

24 (b) If the motor vehicle to which the license plate is attached is permanently registered, the owner of the
25 motor vehicle shall provide, upon request of a person authorized to enforce special parking laws or ordinances
26 in this or any state, evidence of continued eligibility to use the license plate in the form of a valid special parking
27 permit issued to or renewed by the vehicle owner under 49-4-304 and 49-4-305.

28 (c) A person with a permanent condition, as provided in 49-4-301(2)(b), who has been issued a special
29 license plate upon written application, as provided in this subsection (9), is not required to reapply upon
30 reregistration of the motor vehicle.

1 (10) The provisions of this section do not apply to a motor vehicle, trailer, semitrailer, or pole trailer that
2 is registered as part of a fleet, as defined in 61-3-712, and that is subject to the provisions of 61-3-711 through
3 61-3-733."

5 **Section 11.** Section 61-5-102, MCA, is amended to read:

6 **"61-5-102. Drivers to be licensed -- penalties.** (1) (a) Except as provided in 61-5-104, a person may
7 not drive a motor vehicle upon a highway in this state unless the person has a valid Montana driver's license. A
8 person may not receive a Montana driver's license until the person surrenders to the department all valid driver's
9 licenses issued by any other jurisdiction. A person may not have in the person's possession or under the person's
10 control more than one valid Montana driver's license at any time.

11 (b) Except as provided in subsection (1)(c), the penalty for a first violation of this section is a fine of not
12 more than \$500, imprisonment for not more than 6 months, or both a fine and imprisonment. The penalty for
13 second and subsequent violations of this section is a fine of not more than \$500 and imprisonment for not less
14 than 2 days or more than 6 months.

15 (c) A person who is eligible to hold a driver's license and has obtained a valid driver's license but has
16 not renewed the license as provided in 61-5-111(3)(c) is not subject to the penalties in subsection (1)(b).

17 (2) (a) (i) Except as provided in subsection (2)(a)(ii), a license is not valid for the operation of a
18 motorcycle unless the holder of the license has completed the requirements of 61-5-110 and the license has been
19 clearly marked with the words "motorcycle endorsement".

20 (ii) A motorcycle endorsement is not required for the operation of a low-speed electric vehicle or a
21 motorcycle that is propelled by an electric motor or other device that transforms stored electrical energy into the
22 motion of the vehicle, has a fully enclosed cab, is equipped with three wheels in contact with the ground, and is
23 equipped with a seat and seatbelts.

24 (b) A license is not valid for the operation of a commercial motor vehicle unless the holder of the license
25 has completed the requirements of 61-5-110, the license has been clearly marked with the words "commercial
26 driver's license", and the license bears the proper endorsement for:

27 (i) the specific vehicle type or types being operated; or

28 (ii) the passengers or type or types of cargo being transported.

29 (3) A LOW-SPEED RESTRICTED DRIVER'S LICENSE IS NOT VALID FOR THE OPERATION OF A MOTOR VEHICLE OTHER
30 THAN A LOW-SPEED ELECTRIC VEHICLE OR A GOLF CART.

1 ~~(3)~~(4) When a city or town requires a licensed driver to obtain a local driving license or permit, a license
2 or permit may not be issued unless the applicant presents a state driver's license valid under the provisions of
3 this chapter."

5 **Section 12.** Section 61-9-220, MCA, is amended to read:

6 "**61-9-220. Multiple-beam road-lighting equipment.** Except as provided in this part, the headlamps
7 or the auxiliary driving lamps or combination of both on a motor vehicle other than a motorcycle, quadricycle, or
8 motor-driven cycle, or low-speed electric vehicle, must be ~~so~~ arranged so that the driver may select between
9 distributions of light projected to different elevations. The selection can be made automatically, subject to the
10 following limitations:

11 (1) There must be an uppermost distribution of light, or composite beam, capable of revealing persons
12 and vehicles at a distance of at least 350 feet ahead for all conditions of loading.

13 (2) There must be a lowermost distribution of light, or composite beam, capable of revealing persons and
14 vehicles at a distance of at least 100 feet ahead. On a straight level road under any condition of loading the
15 high-intensity portion of the beam may not be directed to strike the eyes of an approaching driver.

16 (3) A motor vehicle, other than a motorcycle, quadricycle, or motor-driven cycle, or low-speed electric
17 vehicle, manufactured after January 1, 1956, that has multiple-beam road-lighting equipment must be equipped
18 with a beam indicator that must be lighted whenever the uppermost distribution of light from the headlamps is in
19 use, and may not otherwise be lighted. The indicator must be readily visible without glare to the driver of the
20 vehicle."

25 in 61-1-101, must be equipped with:

26 ~~(1)~~(a) headlamps, front and rear turn signal lamps, taillamps, and stop lamps;

27 ~~(2)~~(b) three red reflectors, two of which must be placed on each side as far to the rear of the vehicle as
28 practicable, and one of which must be placed on the rear of the vehicle;

29 ~~(3)~~(c) an exterior mirror mounted on the driver's side of the vehicle and either an exterior mirror mounted
30 on the passenger's side of the vehicle or an interior mirror;

- 7 design."

18 REGISTRATION PROVISION AS A LIGHT VEHICLE OR QUADRICYCLE PRIOR TO [THE EFFECTIVE DATE OF THIS ACT] IS

19 CONSIDERED LEGALLY TITLED AND REGISTERED IF OPERATED BY A PERSON WITH A LOW-SPEED RESTRICTED DRIVER'S

20 LICENSE.
