4 A BILL FOR AN ACT ENTITLED: "AN ACT REVISING TRANSFERS FROM THE STATE GENERAL FUND;  
5 REDUCING TRANSFERS TO CERTAIN ACCOUNTS, ENTITIES, AND RECIPIENTS; AMENDING ~~SECTIONS~~  
6 SECTION 15-1-122, 17-1-511, 77-1-108, 87-2-801, AND 87-2-803, MCA; AND PROVIDING AN EFFECTIVE  
7 DATE AND A TERMINATION DATE."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

10  
11 **Section 1.** Section 15-1-122, MCA, is amended to read:

12 **"15-1-122. Fund transfers.** (1) There is transferred from the state general fund to the adoption services  
13 account, provided for in 42-2-105, a base amount of \$59,209, and the amount of the transfer must be increased  
14 by 10% in each succeeding fiscal year.

15 (2) For each fiscal year, there is transferred from the state general fund to the accounts, entities, or  
16 recipients indicated the following amounts:

28 (3) For the purposes of this section, "motor vehicle revenue deposited in the state general fund" means

29 revenue received from:

30 (a) fees for issuing a motor vehicle title paid pursuant to 61-3-203;

1 (b) fees, fees in lieu of taxes, and taxes for vehicles, vessels, and snowmobiles registered or reregistered  
2 pursuant to 61-3-321 and 61-3-562;

3 (c) GVW fees for vehicles registered for licensing pursuant to Title 61, chapter 3, part 3; and

4 (d) all money collected pursuant to 15-1-504(3).

5 (4) The amounts transferred from the general fund to the designated recipient ~~must be appropriated~~ are  
6 subject to appropriation as state special revenue in the general appropriations act for the designated purposes."

8 ~~Section 2.~~ Section 17-1-511, MCA, is amended to read:

9 ~~"17-1-511. General fund transfer.~~ (1) By November 1, 2008, the department of revenue shall determine  
10 the total amount of the tax credit claimed under 15-30-2369 through 15-30-2372 that was taken by physicians  
11 practicing in rural areas for tax years 2006 and 2007 and calculate the average of those amounts. The  
12 department of revenue shall report the average amount determined under this subsection to the state treasurer.

13 ~~(2) (a) For the fiscal year beginning July 1, 2008, the state treasurer shall transfer 25% of the amount~~  
14 ~~reported under subsection (1) from the general fund to the state special revenue account created in 20-26-1501.~~

26 ~~"77-1-108. Trust land administration account -- administrative costs -- appropriation.~~ (1) There is  
27 a trust land administration account in the state special revenue fund. Money in the account is available to the  
28 department by appropriation and must be used to pay the costs of administering state trust lands. This includes  
29 the cost of managing assets, including but not limited to real property and monetary assets.

30 ~~(2) Appropriations from the account for each fiscal year may not exceed an amount equal to 25% of the~~

1 distributable revenue, as defined in 77-1-101, generated in the fiscal year completed prior to the legislative  
2 session that will appropriate money for the next biennium. This excludes revenue generated by the forest  
3 improvement fee provided for in 77-5-204.

4 ~~———— (3) (a) Pursuant to subsection (1), the administrative costs must be determined for each land trust. The~~  
5 ~~department may adopt rules regarding the calculation of administrative costs as necessary.~~

7 ~~"87-2-801. Residents over sixty-two years of age -- resident or nonresident legion of valor~~  
 8 ~~members -- purple heart awardees.~~ (1) A resident, as defined in 87-2-102, who is 62 years of age or older is  
 9 entitled to fish and hunt game birds, not including wild turkeys, with a conservation license issued by the  
 10 department. The form of the license must be prescribed by the department.

11 ~~(2) A resident who is 62 years of age or older is also entitled to purchase a Class A-3 deer A tag for \$10~~  
 12 ~~and a Class A-5 elk tag for \$12.~~

13 ~~(3) Regardless of age, a resident, as defined in 87-2-102, or a nonresident who is a legion of valor~~  
 14 ~~member is entitled to fish with a conservation license issued by the department.~~

15 ~~(4) Regardless of age, a resident, as defined in 87-2-102, who has been awarded a purple heart for~~  
 16 ~~service in the armed forces of the United States is entitled to fish and hunt game birds, not including wild turkeys,~~  
 17 ~~with a conservation license issued by the department.~~

18 ~~(5) Regardless of age, a nonresident who has been awarded a purple heart for service in the armed~~  
 19 ~~forces of the United States is entitled to fish and hunt game birds, not including wild turkeys, with a conservation~~  
 20 ~~license issued by the department during expeditions arranged for the nonresident by a nonprofit organization that~~  
 21 ~~uses fishing and hunting as part of the rehabilitation of disabled veterans.~~

22 ~~(6) The department's general license account must be reimbursed by a quarterly transfer of funds from~~

27 ~~Section 5.~~ Section 87-2-803, MCA, is amended to read:

28 ~~"87-2-803. Persons with disabilities -- service members -- definitions.~~ (1) Persons with disabilities  
 29 are entitled to fish and to hunt game birds, not including turkeys, with only a conservation license if they are  
 30 residents of Montana not residing in an institution and are certified as disabled as prescribed by departmental

1 rule. A person who has purchased a conservation license and a resident fishing license or game bird license for  
2 a particular license year and who is subsequently certified as disabled is entitled to a refund for the fishing license  
3 or game bird license previously purchased for that license year. A person who is certified as disabled pursuant  
4 to subsection (3) and who was issued a permit to hunt from a vehicle for license year 2000 or a subsequent  
5 license year is automatically entitled to a permit to hunt from a vehicle for subsequent license years if the criteria  
6 for obtaining a permit does not change.

7 ~~———— (2) A resident of Montana who is certified as disabled by the department and who is not residing in an  
8 institution may purchase a Class A-3 deer A tag for \$6.50 and a Class A-5 elk tag for \$8. A person who has  
9 purchased a conservation license and a resident deer license or resident elk license for a particular license year  
10 and who is subsequently certified as disabled is entitled to a refund for the deer license or elk license previously  
11 purchased and reissuance of the license for that license year at the rate established in this subsection.~~

13 on a form prescribed by the department, if the person establishes one or more of the disabilities pursuant to

16 (4) as a permitholder, may hunt by shooting a firearm from:~~

12 rule. An applicant for a license under this subsection need not obtain a wildlife conservation license as a  
13 prerequisite to licensure.~~

15 be issued regular resident deer and elk licenses, in the manner provided in subsection (2) of this section, and

8 NEW SECTION. Section 2. Severability. If a part of [this act] is invalid, all valid parts that are severable  
9 from the invalid part remain in effect. If a part of [this act] is invalid in one or more of its applications, the part  
10 remains in effect in all valid applications that are severable from the invalid applications.

12 NEW SECTION. Section 3. Effective date. [This act] is effective July 1, 2011.
