- 4 (3) "Telephone directory" means a publication listing:

 - (b) the names, addresses, and telephone numbers of individuals or local businesses in alphabetical order.
 - (4) "Telephone directory company" means a business involved in the production and delivery of telephone directories to residents in Montana.

- NEW SECTION. Section 4. Telephone directory distribution. (1) Telephone directory companies shall:
- (a) develop an opt-out database that includes the names and addresses of residents who wish to opt out of receiving telephone directories;
- (b) maintain a toll-free phone number and a website that residents may use to join the opt-out database; and
- (c) publish in clear print on either the inside or outside of the front or rear cover of a telephone directory delivered after [the effective date of this act] the procedure for joining the opt-out database.
- (2) (a) After August 31, 2011, telephone directory companies may not deliver telephone directories to residents who have joined an opt-out database for 5 years from the date the individual signed up for the opt-out database.
- (b) Upon direct request from a resident at the address, the telephone directory company may remove the address from the opt-out database before the expiration of the 5-year period.
- (3) The number of telephone directories delivered to a multifamily housing development by a telephone directory company may not exceed the total number of units in the building minus the number of units in the building listed in the opt-out database.

29 NEW SECTION. Section 5. Violations. (1) A telephone directory company that violates [section 4] is subject to a civil penalty of not more than \$500.

(2) The department of environmental quality or the county attorney of the county in which the violation occurred may petition the district court to impose the civil penalty. Venue for an action to collect a civil penalty pursuant to this section is in the county in which the violation occurred or in the first judicial district.

(3) A civil penalty collected under this section must be deposited in the solid waste management account provided for in 75-10-117.

NEW SECTION. Section 6. Codification instruction. [Sections 2 through 5] are intended to be codified as an integral part of Title 30, chapter 14, and the provisions of Title 30, chapter 14, apply to [sections 2 through 5].

NEW SECTION. Section 7. Effective date. [This act] is effective on passage and approval.
