4	A BILL FOR AN ACT ENTITLED: "AN ACT REQUIRING COMPLIANCE WITH THE UNITED STATES						
5	CONSTITUTION REGARDING FEDERALLY OWNED LANDS IN MONTANA; DIRECTING THE BOARD (

9	WHEREAS, the United States Constitution gives the federal government only the powers enumerated						
10	by the United States Constitution; and						
11	WHEREAS, Article I, section 8, paragraph 17, of the United States Constitution gives the federa						
12	government very limited powers in acquiring or regulating land within the states; and						
13	WHEREAS, Article IV, section 3, paragraph 2, of the United States Constitution gives the federa						
14	government broad powers over land within the states retained by the federal government as territory when states						
15	were formed.

17	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

19	NEW SECTION. Section 1. Legislative findings board of land commissioners duty. (1) The						
20	legislature finds that:						
21	(a) Article I, section 8, paragraph 17, of the United States constitution states that congress has authority						
22	"over all places purchased by the consent of the legislature of the state in which the same shall be, for the						
23	erection of forts, magazines, arsenals, dock-yards, and other needful buildings"; and						
24	(b) there are lands in Montana that have been acquired by and are now controlled by the federa						
25	government for which the legislature has not given its consent or that are being used for purposes not consistent						
26	with subsection (1)(a).						
27	(2) If within 90 days of [the effective date of this act] the United States government has not obtained a						
28	ruling from the United States supreme court demonstrating which lands within Montana acquired by the federa						
29	government are in accordance with Article I, section 8, paragraph 17, of the United States constitution and which						
30	are not, the board shall begin any proceedings allowed by law to have federally controlled lands that are not in

(3) All future attempts by the federal government to acquire or regulate land within Montana are subject to the provisions of this section and Article I, section 8, paragraph 17, of the United States constitution.

(4) This section does not apply to lands retained by the federal government upon the formation of the state of Montana.
