4	A BILL FOR AN ACT ENTITLED: "AN ACT PROVIDING FOR THE REVIEW BY THE STATE ADMINISTRATION
5	AND VETERANS' AFFAIRS INTERIM COMMITTEE OR A COMMISSION APPOINTED BY THE GOVERNOR
6	OF CERTAIN CONTRACTS FOR THE PROCUREMENT OF THE SERVICES OF PRIVATE ATTORNEYS BY
7	STATE AGENCIES; AMENDING SECTIONS 5-5-228 AND 18-4-302, MCA; AND PROVIDING AN
8	APPLICABILITY DATE."

10	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:
11	
12	NEW SECTION. Section 1. Review of agency contracts for private attorney services. (1) A contract
13	for procurement of the services of a private attorney may not be entered into by an agency unless the agency has
14	complied with the requirements of this section.
15	(2) Subject to [section 2], when the state administration and veterans' affairs interim committee receives
16	a proposed contract for procurement of the services of a private attorney by an agency pursuant to [section 3],
17	the committee shall:
18	(a) hold a public hearing on the contract referred from the agency at which the terms of the contract are
19	subject to public comment;
20	(b) conduct an analysis of the proposed contract in light of the terms of the contract, the public comment
21	received, and the requirements of state law; and
22	(c) issue a report to the agency containing the results of the analysis required by subsection (1)(b) and
23	any changes to the contract that the committee recommends to the language or terms of the contract in light of
24	that analysis.
25	(3) The committee report must be issued within 60 days from the committee's public hearing on the
26	contract. If the committee report recommends no changes to the language or terms of the contract, the agency
27	may enter into the proposed contract. If the committee recommends changes to the contract, the agency shall
28	make changes responsive to the committee report, file a statement with the committee as provided for in
29	subsection (3), or both, as appropriate. The agency shall respond to the report of the committee within 14 days
30	after receiving the report.

1 (4) If the committee report recommends changes to the contract that the agency chooses not to adopt, 2 the agency shall return the unrevised contract to the committee with a statement addressing the reason why the 3 agency chose not to adopt the committee's recommendation for changes. Upon receipt of the statement and 4 contract from the agency, the committee may, within 60 days, hold an additional public hearing on the contract 5 proposed by the agency, including any changes to the language of the contract agreed to by the agency, and may issue an additional report in the same manner as the first report. Except as provided in subsection (4), if the 6 7 committee determines not to hold a hearing or at the end of the 60-day period provided for in this subsection, the 8 agency may enter into the contract in compliance with Title 18, chapter 4, part 3.

9 (5) Any revised contract containing terms not previously reviewed or recommended by the committee 10 that can reasonably be expected to increase the fees and expenses to be paid by the agency must be treated 11 as a new contract and must be filed and reviewed in accordance with subsections (1) through (3).

(6) Terms used in this section are defined in [section 3].

14 NEW SECTION. Section 2. Governor to create commission to review contracts for procurement 15 of private attorney services -- commission duties. (1) The governor shall create a commission to review 16 contracts for the procurement of the services of private attorneys by state agencies if the state administration and 17 veterans' affairs interim committee is unable to review a proposed contract pursuant to [section 1] for the first time 18 within 60 days from its receipt by the committee. The commission is composed of five members of the legislature 19 composed of one member to be appointed by the governor and one member to be appointed by each of the 20 majority and minority leaders of the house of representatives and the senate. The members of the commission 21 serve without pay but must be reimbursed for their expenses as provided in 2-18-501 through 2-18-503.

(2) If the state administration and veterans' affairs interim committee is unable to review a proposed
 contract within the time period provided in subsection (1), the commission shall review the proposed contract
 under the same procedure and subject to the same time periods that apply to the state administration and
 veterans' affairs interim committee under [section 1].

(3) If the state agency files a statement with the governor that time exigencies require the employment
of a private attorney before the schedule provided for in subsection (1) and (2) may be complied with, the
commission shall negotiate a time schedule for the review of the proposed contract as provided in subsections
(1) and (2) on an expedited schedule mutually agreed upon by the agency and the commission.

1	(a) "Agency" means a department, division, office, commission, committee, or any other entity of the
2	executive branch of state government.
3	(b) "Attorney" means one or more individual attorneys or a group of attorneys practicing as one or more
4	law firms.
5	(c) "Fee" includes any form of compensation for legal services, whether paid as an hourly rate, a flat
6	charge, or a contingency charge in which the attorney receives nothing if the agency does not prevail.

8	Section 4. Section 5-5-228, MCA, is amended to read:
9	"5-5-228. State administration and veterans' affairs interim committee. (1) The state administration
10	and veterans' affairs interim committee has administrative rule review, draft legislation review, program
11	evaluation, and monitoring functions for the public employee retirement plans and for the following executive
12	branch agencies and the entities attached to the agencies for administrative purposes:
13	(a) department of administration;
14	(b) department of military affairs; and
15	(c) office of the secretary of state.
16	(2) The committee shall:
17	(a) consider the actuarial and fiscal soundness of the state's public employee retirement systems, based
18	on reports from the teachers' retirement board, the public employees' retirement board, and the board of
19	investments, and study and evaluate the equity and benefit structure of the state's public employee retirement
20	systems;
21	(b) establish principles of sound fiscal and public policy as guidelines;
22	(c) as necessary, develop legislation to keep the retirement systems consistent with sound policy

Section 18-4-302, MCA, is amended to read: 15 "18-4-302. Methods of source selection -- authorization for alternative procurement methods. (1) 16 Unless otherwise authorized by law and except as provided in [section 3], all state contracts for supplies and 17 services must be awarded by a source selection method provided for in this title. Supplies or services offered for 18 sale, lease, or rental by public utilities are exempt from this requirement if the prices of the supplies or services 19 are regulated by the public service commission or other governmental authority. 20 (2) When the department or another agency opens bids or proposals, if a supplier's current publicly 21 advertised or established catalog price is received at or before the time that the bids or proposals are opened and 22 is less than the bid of the lowest responsible and responsive bidder or offeror or improves upon the conditions 23 for the best proposal received using the same factors and weights included in the proposal, the department or 24 agency may reject all bids and purchase the supply from that supplier without meeting the requirements of 25 18-4-303 through 18-4-306. 26 (3) An office supply procured by the department's central stores program may be purchased by an 27 agency, without meeting the requirements of 18-4-303 through 18-4-306, from a supplier whose publicly 28 advertised price, established catalog price, or discount price offered to the agency is less than the price offered 29 by the central stores program if the office supply conforms in all material respects to the terms, conditions, and 30 quality offered by the central stores program. A state office supply term contract must include a provision by which

1 the contracting parties acknowledge and agree to the provisions of this subsection. 2 (4) (a) Under rules adopted by the department, an agency may request from the department 3 authorization for an alternative procurement method. 4 (b) A request for authorization must specify: 5 (i) the problem to be solved: 6 (ii) the proposed alternative procurement method; 7 (iii) the reasons why the alternative procurement method may be more appropriate than a method 8 authorized by law; and 9 (iv) how competition and fairness will be achieved by the alternative procurement method. 10 (c) Within 30 days after receiving the request, the department shall: 11 (i) evaluate the request; 12 (ii) approve or deny the request; and 13 (iii) issue a written statement providing the reasons for its decision. 14 (d) Whenever the department approves a request submitted under this section, the department: 15 (i) may authorize the alternative procurement method on a trial basis; and 16 (ii) if the alternative procurement method is employed, shall make a written determination as to the 17 success of the method. 18 (e) If the department determines that the alternative procurement method is successful and should be 19 an alternative that is generally available, it shall promulgate rules that establish the use of the alternative 20 procurement method as an additional source selection method. The rules promulgated by the department under 21 this subsection must reflect the purposes described in 18-4-122." 22 23 NEW SECTION. Section 6. Codification instruction. (1) [Section 1] is intended to be codified as an 24 integral part of Title 5, chapter 5, part 2, and the provisions of Title 5, chapter 5, part 2, apply to [section 1]. 25 (2) [Section 2] is intended to be codified as an integral part of Title 2, chapter 15, part 2, and the 26 provisions of Title 2, chapter 15, part 2, apply to [section 2]. 27 (3) [Section 3] is intended to be codified as an integral part of Title 18, chapter 4, part 3, and the 28 provisions of Title 18, chapter 4, part 3, apply to [section 3]. 29 30 NEW SECTION. Section 7. Severability. If a part of [this act] is invalid, all valid parts that are severable



1	from the invalid part remain in effect. If a part of [this act] is invalid in one or more of its applications, the part
2	remains in effect in all valid applications that are severable from the invalid applications.

4	NEW SECTION. Section 8. Applicability. [This act] applies to contracts for procurement of the services
5	of a private attorney by a state agency proposed for agreement after October 1, 2011.
