12	WHEREAS, on March 5, 2010, the Montana Attorney General issued a draft opinion stating that section
13	76-3-204, MCA, which exempts certain actions from the requirements of the Montana Subdivision and Platting
14	Act, "does not apply to the construction or conveyance of more than one building, structure, or improvement on
15	a single tract of record"; and
16	WHEREAS, limiting the exemption in section 76-3-204, MCA, to a single building or structure places an
17	undue burden on private property owners and an unreasonable restriction on the free use of property; and
18	WHEREAS, it is the intent of the Legislature to clarify that section 76-3-204, MCA, extends to more than
19	one building or structure in certain circumstances.
20	
21	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:
22	
23	NEW SECTION. Section 1. Proposed rent or lease of certain buildings or structures. (1) The
24	proposed rent or lease of buildings or structures or parts of buildings or structures that are not exempt from review
25	under 76-2-204 must be considered a subdivision and must be reviewed as provided in this section.
26	(2) The governing body shall approve, conditionally approve, or deny a subdivision application under this
27	section within 35 working days of a determination by the reviewing agent or agency that the application contains
28	required elements and sufficient information for review. The determination and notification to the subdivider must
29	be made in the same manner as provided in 76-3-604(1) through (3).
30	(3) The following requirements do not apply to subdivisions reviewed pursuant to this section:

Section 76-3-201, MCA, is amended to read: 21 "76-3-201. Exemption for certain divisions of land -- fees for examination of division. (1) Unless 22 the method of disposition is adopted for the purpose of evading this chapter, the requirements of this chapter may 23 not apply to any division of land that: 24 (a) is created by order of any court of record in this state or by operation of law or that, in the absence 25 of agreement between the parties to the sale, could be created by an order of any court in this state pursuant to 26 the law of eminent domain, Title 70, chapter 30; 27 (b) subject to subsection (3), is created to provide security for mortgages, liens, or trust indentures for 28 the purpose of construction, improvements to the land being divided, or refinancing purposes; 29 (c) creates an interest in oil, gas, minerals, or water that is severed from the surface ownership of real 30 property;

If, during the review of the application, the agent or agency designated by the governing body contacts a public utility, agency, or other entity that was not included on the list originally made available to the subdivider, the agent or agency shall notify the subdivider of the contact and the timeframe for response.

(iv) requires that a preapplication meeting take place no more than 30 days from the date that the
 authorized agent or agency receives a written request for a preapplication meeting from the subdivider; and

(v) establishes a time limit after a preapplication meeting by which an application must be submitted as
provided in 76-3-604;

(r) requires that the written decision required by 76-3-620 must be provided to the applicant within 30
working days following a decision by the governing body to approve, conditionally approve, or deny a subdivision.
