6	A JOINT RESOLUTION OF THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE STATE OF
7	MONTANA REQUESTING AN INTERIM STUDY OF LOCAL FIRE PROTECTION AND EMERGENCY SERVICE
8	ENTITIES AND FIREFIGHTER AND EMERGENCY MEDICAL TECHNICIAN BENEFITS.
9	
10	WHEREAS, the Montana Legislature recognizes the invaluable public service provided by Montana's paid
11	and volunteer firefighters and emergency medical technicians; and
12	WHEREAS, numerous bills have been introduced during the 62nd Legislature that would affect
13	qualifications, duties, and benefits for paid and volunteer firefighters and emergency medical technicians; and
14	WHEREAS, legislation has also been introduced that would affect the powers and duties of fire
15	departments, fire districts, fire service areas, and fire companies;
16	WHEREAS, the Department of Natural Resources and Conservation requires that counties provide
17	workers' compensation insurance coverage for operators of firefighting apparatus provided to counties and
18	assigned to fire agencies in the counties pursuant to agreements entered into as part of the State-County
19	Cooperative Fire Protection Program; and
20	WHEREAS, many fire districts, fire service areas, and fire companies do not have the financial resources
21	to comply with this requirement; and
22	WHEREAS, the powers, duties, and jurisdictions of local government fire agencies are varied and
23	complex and warrant thorough analysis and understanding by the Legislature; and
24	WHEREAS, the House Local Government committee recognizes that a comprehensive review of local
25	fire protection, emergency services, and firefighter and emergency medical technician benefits is necessary to
26	identify problems and consider potential solutions for providing adequate, consistent, and coordinated local fire
27	protection and emergency services and adequate, consistent, and coordinated benefits to paid and volunteer
28	firefighters and emergency medical technicians who serve local governments and their citizens.

30	NOW, THEREFORE, BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE

1 STATE OF MONTANA: 2 That the Legislative Council be requested to designate an appropriate interim or statutory committee, 3 pursuant to section 5-5-217, MCA, to conduct a comprehensive study of local fire protection and emergency 4 services, how those services are paid for, and benefits provided to paid and volunteer firefighters and emergency 5 medical technicians, including workers' compensation, disability, and retirement. 6 BE IT FURTHER RESOLVED, that the committee conducting the study: 7 (1) review the current structure and function of local fire protection agencies and emergency services, including municipal fire departments, rural fire districts, fire service areas, fire companies, and emergency medical 8 9 technician services; 10 (2) examine how local governments pay for the various fire protection and emergency services in their 11 jurisdictions; 12 (3) review the current benefits provided to paid and volunteer firefighters and emergency medical 13 technicians by local governments and the financial capacity of the local governments to provide those benefits; 14 (4) review legislation introduced during the 62nd Legislature intended to modify local fire protection and 15 emergency services and firefighter and emergency medical technician duties, qualifications, and benefits, the 16 reasons for the legislation, and the outcome of the legislation; 17 (5) examine the Department of Natural Resources and Conservation's State-County Cooperative Fire 18 Protection Program, the agreements entered into between the state and counties, and the coordination between 19 the state and local governments for wildland fire protection; 20 (6) examine the services that local government firefighters and emergency medical technicians provide 21 and how those services are reimbursed by citizens, insurance companies, and state and federal agencies; 22 (7) examine the viability, necessity, and jurisdiction of the various local government fire protection entities 23 provided for in state statute; and 24 (8) determine whether modifications to statutes or state or local policies are warranted to achieve 25 adequacy, consistency, and coordination in local government fire protection and emergency services and in the 26 benefits provided to paid and volunteer firefighters and emergency medical technicians. 27 BE IT FURTHER RESOLVED, that the committee solicit participation and input from local governments, 28 paid firefighters, volunteer firefighters, representatives of firefighter organizations, representatives of the Montana 29 Public Employees' Retirement Administration, the Department of Natural Resources and Conservation, the 30 Department of Labor and Industry, and any other entity that the committee considers to be appropriate.
