4 A BILL FOR AN ACT ENTITLED: "AN ACT REVISING THE SIZE OF TRAILER LICENSE PLATES;
5 ESTABLISHING THE SIZE OF MOTORCYCLE AND QUADRICYCLE LICENSE PLATES; AMENDING SECTION
6 61-3-332, MCA; AND PROVIDING A DELAYED EFFECTIVE DATE."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

10 **Section 1.** Section 61-3-332, MCA, is amended to read:

11 **"61-3-332. Standard license plates.** (1) In addition to special license plates, collegiate license plates,
12 generic specialty license plates, and fleet license plates authorized under this chapter, a separate series of
13 standard license plates must be issued for motor vehicles, quadricycles, travel trailers, trailers, semitrailers, and
14 pole trailers registered in this state or offered for sale by a vehicle dealer licensed in this state. Standard license
15 plates issued to licensed vehicle dealers must be readily distinguishable from license plates issued to vehicles
16 owned by other persons.

17 (2) (a) Except as provided in 61-3-479 and subsections (2)(b), (3)(b), and (3)(c) of this section, all
18 standard license plates for motor vehicles, trailers, semitrailers, or pole trailers must bear a distinctive marking,
19 as determined by the department, and be furnished by the department. In years when standard license plates
20 are not reissued for a vehicle, the department shall provide a registration decal that must be affixed to the rear
21 license plate of the vehicle.

22 (b) For light vehicles that are permanently registered as provided in 61-3-562 and motor vehicles
23 described in 61-3-303(9) that are permanently registered, the department shall provide a distinctive registration
24 decal indicating that the motor vehicle is permanently registered. The registration decal must be affixed to the rear
25 license plate of the permanently registered motor vehicle.

26 (c) For a travel trailer, motorcycle, quadricycle, trailer, semitrailer, or pole trailer that is permanently
27 registered as provided in 61-3-313(2), the department may use the word or an abbreviation for the word
28 "permanent" on the plate in lieu of issuing a registration decal for the plate.

29 (3) (a) (i) Beginning January 1, 2010, and every 5 years after that date, the department shall design
30 standard license plates to replace previously issued standard license plates. For the purposes of this subsection

1 (3), all military, veteran, and amateur radio license plates and any license plate with a wheelchair design,
2 excluding collegiate or generic specialty plates with a wheelchair design, are treated as standard license plates.

3 (ii) License plates issued on or after January 1, 2010, must be replaced with the most recent design of
4 standard license plates or a new replacement collegiate or generic speciality license plate if, upon renewal of
5 registration under ~~61-3-332~~ this section, the license plates are 5 or more years old or will become older than 5
6 years during the registration period.

7 (iii) License plates issued on or before January 1, 2010, must be replaced with the most recent design
8 of standard license plates or a new replacement collegiate or generic specialty license plate in accordance with
9 the implementation schedule adopted by the department under 61-3-315. Until January 1, 2015, and upon
10 payment of the fee required in 61-3-321(12)(b), a vehicle owner may elect to keep the same license plate number
11 from license plates issued on or after January 1, 2006, but before January 1, 2010, when replacement of those
12 plates is required under this subsection.

13 (b) A motor vehicle that is registered for a 13-month to a 24-month period, as provided in 61-3-311, may
14 display the license plate and plate design in effect at the time of registration for the entire registration period.

15 (c) A light vehicle described in subsection (2)(b) or a motor home that is permanently registered may
16 display the license plate and plate design in effect at the time of registration for the entire period that the light
17 vehicle or motor home is permanently registered.

18 (d) The provisions of this subsection (3) do not apply to a travel trailer, motorcycle, quadricycle, trailer,
19 semitrailer, or pole trailer.

20 (e) The requirements of this subsection (3) apply to collegiate license plates authorized under 61-3-461
21 through 61-3-468, generic specialty license plates authorized under 61-3-472 through 61-3-481, commemorative
22 centennial license plates authorized under 61-3-448, and special military or veteran license plates authorized
23 under 61-3-458.

24 (4) (a) For trailers semitrailers, travel trailers, pole trailers, and motor vehicles, other than motorcycles
25 and quadricycles, plates must be of metal 6 inches wide and 12 inches in length. Except for generic specialty
26 license plates, the outline of the state of Montana must be used as a distinctive border on all license plates, and
27 the word "Montana" must be placed on each license plate. All license plates must be treated with a reflectorized
28 background material according to specifications prescribed by the department.

29 (b) For trailers, motorcycles, and quadricycles, plates must be of metal 4 inches wide and 7 inches in
30 length.

1 (5) The distinctive registration numbers for standard license plates must begin with a number one or with
2 a letter-number combination, such as "A 1" or "AA 1", or any other similar combination of letters and numbers.
3 Except for special license plates, collegiate license plates, generic specialty license plates, and fleet license
4 plates, the distinctive registration number or letter-number combination assigned to the motor vehicle must appear
5 on the plate preceded by the number of the county and appearing in horizontal order on the same horizontal
6 baseline. The county number must be separated from the distinctive registration number by a separation mark
7 unless a letter-number combination is used. The dimensions of the numerals and letters must be determined by
8 the department, and all county and registration numbers must be of equal height.

9 (6) For the use of exempt motor vehicles, trailers, semitrailers, or pole trailers and motor vehicles,
10 trailers, semitrailers, or pole trailers that are exempt from the registration fee as provided in 61-3-321, in addition
11 to the markings provided in this section, standard license plates must bear the following distinctive markings:

12 (a) For motor vehicles, trailers, semitrailers, or pole trailers owned by the state, the department may
13 designate the prefix number for the various state departments. All numbered plates issued to state departments
14 must bear the words "State Owned", and a year number may not be indicated on the plates because these
15 numbered plates are of a permanent nature and will be replaced by the department only when the physical
16 condition of numbered plates requires it.

17 (b) For motor vehicles, trailers, semitrailers, or pole trailers that are owned by the counties,
18 municipalities, and special districts, as defined in 18-8-202, organized under the laws of Montana and not
19 operating for profit, and that are used and operated by officials and employees in the line of duty and for motor
20 vehicles on loan from the United States government or the state of Montana to, or owned by, the civil air patrol
21 and used and operated by officials and employees in the line of duty, there must be placed on the standard
22 license plates assigned, in a position that the department may designate, the letter "X" or the word "EXEMPT".
23 Distinctive registration numbers for plates assigned to motor vehicles, trailers, semitrailers, or pole trailers of each
24 of the counties in the state and those of the municipalities and special districts that obtain plates within each
25 county must begin with number one and be numbered consecutively. Because these standard license plates are
26 of a permanent nature, they are subject to replacement by the department only when the physical condition of
27 the license plates requires it and a year number may not be displayed on the plates.

28 (7) For the purpose of this chapter, the several counties of the state are assigned numbers as follows:
29 Silver Bow, 1; Cascade, 2; Yellowstone, 3; Missoula, 4; Lewis and Clark, 5; Gallatin, 6; Flathead, 7; Fergus, 8;
30 Powder River, 9; Carbon, 10; Phillips, 11; Hill, 12; Ravalli, 13; Custer, 14; Lake, 15; Dawson, 16; Roosevelt, 17;

1 Beaverhead, 18; Chouteau, 19; Valley, 20; Toole, 21; Big Horn, 22; Musselshell, 23; Blaine, 24; Madison, 25;
2 Pondera, 26; Richland, 27; Powell, 28; Rosebud, 29; Deer Lodge, 30; Teton, 31; Stillwater, 32; Treasure, 33;
3 Sheridan, 34; Sanders, 35; Judith Basin, 36; Daniels, 37; Glacier, 38; Fallon, 39; Sweet Grass, 40; McCone, 41;
4 Carter, 42; Broadwater, 43; Wheatland, 44; Prairie, 45; Granite, 46; Meagher, 47; Liberty, 48; Park, 49; Garfield,
5 50; Jefferson, 51; Wibaux, 52; Golden Valley, 53; Mineral, 54; Petroleum, 55; Lincoln, 56. Any new counties must
6 be assigned numbers by the department as they are formed, beginning with the number 57.

7 (8) Each type of special license plate approved by the legislature, except collegiate license plates
8 authorized in 61-3-463 and generic specialty license plates authorized in 61-3-472 through 61-3-481, must be
9 a separate series of plates, numbered as provided in subsection (5), except that the county number must be
10 replaced by a design that distinguishes each separate plate series. Unless otherwise specifically stated in this
11 section, the special plates are subject to the same rules and laws as govern the issuance of standard license
12 plates, must be placed or mounted on a motor vehicle, trailer, semitrailer, or pole trailer owned by the person who
13 is eligible to receive them, with the registration decal affixed to the rear license plate of the motor vehicle, trailer,
14 semitrailer, or pole trailer, and must be removed upon sale or other disposition of the motor vehicle, trailer,
15 semitrailer, or pole trailer.

16 (9) (a) A Montana resident who is eligible to receive a special parking permit under 49-4-301 may, upon
17 written application on a form prescribed by the department, be issued a special license plate with a design or
18 decal bearing a representation of a wheelchair as the symbol of a person with a disability.

19 (b) If the motor vehicle to which the license plate is attached is permanently registered, the owner of the
20 motor vehicle shall provide, upon request of a person authorized to enforce special parking laws or ordinances
21 in this or any state, evidence of continued eligibility to use the license plate in the form of a valid special parking
22 permit issued to or renewed by the vehicle owner under 49-4-304 and 49-4-305.

23 (c) A person with a permanent condition, as provided in 49-4-301(2)(b), who has been issued a special
24 license plate upon written application, as provided in this subsection (9), is not required to reapply upon
25 reregistration of the motor vehicle.

26 (10) The provisions of this section do not apply to a motor vehicle, trailer, semitrailer, or pole trailer that
27 is registered as part of a fleet, as defined in 61-3-712, and that is subject to the provisions of 61-3-711 through
28 61-3-733."
