8	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:
9	
10	NEW SECTION. Section 1. Supply service prohibited. Except as provided in 69-5-104, a utility may
11	not provide electricity supply service to premises in another utility's service territory. AN ELECTRICITY SUPPLIER MAY
12	PROVIDE ELECTRICITY SUPPLY SERVICE IN THE SERVICE TERRITORY OF A PUBLIC UTILITY AS PROVIDED IN 69-8-411.
13	
14	Section 2. Section 69-5-102, MCA, is amended to read:
15	"69-5-102. Definitions. When used in this part, the following definitions apply:
16	(1) "Agreement" means a written agreement between two or more electric facilities providers that
17	identifies the geographical area to be served exclusively by each electric facilities provider that is a party to the
18	agreement and any terms and conditions pertinent to the agreement.
19	(2) "Cost" means the gross cost of constructing new electric service facilities to the premises, using new
20	materials and similar design standards required to meet the load, from a point where there is existing electrical
21	capacity to serve.
22	(3) "Distribution facilities" means those facilities by and through which electricity is received from a
23	transmission services provider and distributed to the customer that are controlled or operated by a distribution
24	<u>utility.</u>
25	(4) "Distribution service" means the function of delivering electricity to the public by a distribution utility.
26	(5) "Distribution utility" means a utility owning distribution facilities for distribution of electricity to the
27	public.
28	(3)(6) "Electric facilities provider" means any utility that provides electric service facilities to the public.
29	(4)(7) "Electric service facilities" means any distribution or transmission system or related facility
30	necessary to provide electricity to the premises, including lines.

7	utility's affiliates.
8	(3) Public utilities shall file tariffs for transmission and distribution services regulated by the federal
9	energy regulatory commission and the commission implementing subsections (1) and (2)."

11	NEW SECTION. Section 4. Codification instruction. [Section 1] is intended to be codified as an
12	integral part of Title 69, chapter 5, part 1, and the provisions of Title 69, chapter 5, part 1, apply to [section 1].
13	
14	NEW SECTION. Section 5. Effective date. [This act] is effective on passage and approval.
