| 10 | "7-33-4107. Qualifications of firefighters. The state of Montana determines that age is a valid, bona              |
| 11 | fide occupational qualification for the position of firefighter because of the rigorous physical demands of        |
| 12 | qualifications for the firefighting profession must recognize the rigorous physical demands placed on firefighters |
| 13 | and the expectation of many years of emergency service. The qualifications of firefighters shall be that they To   |
| 14 | qualify as a firefighter, an applicant:  |
| 15 | (1) shall not be more than 34 years of age at the time of original appointment;                                    |
| 16 | (2) shall have passed a physical examination by a practicing physician duly authorized to practice in this         |
| 17 | state; and   |
| 18 | (3) at the option of said city or town, shall be qualified voters of the city or town                              |
| 19 | (1) must be a citizen of the United States;  |
| 20 | (2) must be at least 18 years of age;  |
| 21 | (3) must be a high school graduate or have passed the general educational development test and have                |
| 22 | been issued an equivalency certificate by the superintendent of public instruction or by an appropriate issuing    |
| 23 | agency of another state or of the federal government;  |
| 24 | (4) must possess or be eligible for a valid Montana driver's license;  |
| 25 | (5) shall pass a physical examination by a practicing QUALIFIED physician, PHYSICIAN ASSISTANT, OR                 |
| 26 | ADVANCED PRACTICE REGISTERED NURSE, who is not the applicant's personal physician, PHYSICIAN ASSISTANT, OR         |
| 27 | ADVANCED PRACTICE REGISTERED NURSE, appointed by the employing authority to determine if the applicant is free     |
| 28 | from any mental or physical condition that might adversely affect the applicant's performance of the duties of a   |
| 29 | firefighter;   |
| 30 | (6) must be fingerprinted and a search must be made of the local, state, and national fingerprint files to         |
