

1 SENATE BILL NO. 303

2 INTRODUCED BY J. BRENDEN

4 A BILL FOR AN ACT ENTITLED: "AN ACT REQUIRING APPROVAL OF THE BOARD OF LAND
5 COMMISSIONERS FOR LAND PURCHASES; PROVIDING THAT TO THE EXTENT PRACTICAL AND
6 CONSISTENT WITH THE BOARD OF LAND COMMISSIONERS' POWERS AND DUTIES, LAND PURCHASES
7 MAY NOT RESULT IN A NET GAIN IN LAND OWNERSHIP BY THE STATE; PROVIDING AN EXEMPTION FOR
8 CERTAIN FISHING ACCESS SITES; AMENDING SECTIONS 2-17-101, 10-1-108, 18-2-105, 18-2-111,
9 20-25-307, 22-3-1003, 23-1-102, 67-2-301, 75-15-223, 76-12-107, 77-1-202, 77-1-214, 77-2-364, 82-4-239,
10 82-4-371, 82-4-445, 85-1-209, 87-1-209, 87-1-285, AND 87-1-703, MCA; AND PROVIDING AN IMMEDIATE
11 EFFECTIVE DATE."

13 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:
14

15 **Section 1.** Section 2-17-101, MCA, is amended to read:

16 **"2-17-101. Allocation of space -- leasing -- definition.** (1) The department of administration shall
17 determine the space required by state agencies other than the university system and shall allocate space in
18 buildings owned or leased by the state, based on each agency's need. To efficiently and effectively allocate
19 space, the department shall identify the amount, location, and nature of space used by each agency, including
20 summary information on average cost per square foot for each municipality, and report this to the office of budget
21 and program planning and to the legislative fiscal analyst by September 1 of each even-numbered year.

22 (2) An agency requiring additional space shall notify the department. The department, in consultation
23 with the agency, shall determine the amount and nature of the space needed and locate space within a building
24 owned or leased by the state, including buildings in Helena and in other areas, to meet the agency's
25 requirements. If space is not available in a building owned or leased by the state, the department shall locate
26 space to be leased in an appropriate existing building or a build-to-lease building, including buildings in Helena
27 and in other areas, or recommend alternatives to leasing, such as remodeling or exchanging space with another
28 agency. A state agency may not lease, rent, or purchase real property without prior approval of the department.

29 (3) (a) The location of the chambers for the house of representatives must be determined in the sole
30 discretion of the house of representatives. The location of the chambers for the senate must be determined in

1 the sole discretion of the senate.

2 (b) Subject to 2-17-108, the department, with the advice of the legislative council, shall allocate other
3 space for the use of the legislature, including but not limited to space for committee rooms and legislative offices.

4 (4) The department shall consolidate the offices of state agencies in a single, central location within a
5 municipality whenever the consolidation would result in a cost savings to the state while permitting sufficient
6 space and facilities for the agencies. The department may purchase, lease, or acquire, by exchange or otherwise,
7 land and buildings in a municipality to achieve consolidation. Land purchases must be approved by the board of
8 land commissioners. To the extent practical and consistent with the board of land commissioners' powers and
9 duties pursuant to 77-1-202, land purchases may not result in a net gain in land owned by the state on [the
10 effective date of this act]. Offices of the law enforcement services division and motor vehicle division of the
11 department of justice are exempted from consolidation.

12 (5) Any lease for more than 40,000 square feet or for a term of more than 20 years must be submitted
13 as part of the long-range building program and approved by the legislature before the department of
14 administration may proceed with the lease. Multiple leases in the same building entered into within any 60-day
15 period are to be aggregated for purposes of this threshold calculation. When immediate relocation of agency
16 employees is required due to a public exigency, the requirements of this subsection do not apply, but the new
17 lease must be reported as required by subsection (1).

18 (6) The department shall include language in every lease providing that if funds are not appropriated or
19 otherwise made available to support continued performance of the lease in subsequent fiscal periods, the lease
20 must be canceled.

21 (7) "Public exigency" means that due to unforeseen circumstances a facility occupied by state employees
22 is uninhabitable due to immediate conditions that adversely impact the health or safety of the occupants of the
23 facility."
24

25 **Section 2.** Section 10-1-108, MCA, is amended to read:

26 **"10-1-108. Armories -- acquisition and sale -- proceeds -- account.** (1) A county, city, or town may
27 convey or lease real property to the state for armories or other military facilities.

28 (2) A county, city, or town in which a unit of the national guard is organized and regularly stationed may
29 provide any part of the funds to build an armory. The armory must be of sufficient size and suitable for the drill
30 of the unit.

1 (3) (a) There is a Montana national guard land purchase account in the state special revenue fund. If
2 the state sells an armory, the money from the sale must be deposited in the account.

3 (b) Money in the account is statutorily appropriated, as provided in 17-7-502, for the purposes described
4 in subsection (4).

5 (c) Any interest and income accruing on the account must be deposited in the state general fund.

6 (4) Money in the account may be used only for preparations to purchase or the purchase of land
7 necessary for the Montana national guard's mission and is expendable solely upon the authorization of the
8 governor.

9 (5) Land purchases must be approved by the board of land commissioners. To the extent practical and
10 consistent with the board of land commissioners' powers and duties pursuant to 77-1-202, land purchases may
11 not result in a net gain in land owned by the state on [the effective date of this act]."
12

13 **Section 3.** Section 18-2-105, MCA, is amended to read:

14 **"18-2-105. General powers and duties of department of administration.** (1) In carrying out powers
15 relating to the construction of buildings, the department of administration may:

16 ~~(1)~~(a) inspect buildings not under construction;

17 ~~(2)~~(b) contract with the federal government for advance planning funds;

18 ~~(3)~~(c) transfer funds and authority to agencies and accept funds and authority from agencies;

19 ~~(4)~~(d) subject to 2-17-135 and subsection (2) of this section, purchase, lease, and acquire by exchange
20 or otherwise, land and buildings in Lewis and Clark County and equipment and furnishings for the buildings;

21 ~~(5)~~(e) issue and sell bonds and other securities;

22 ~~(6)~~(f) maintain an inventory of all buildings;

23 ~~(7)~~(g) appoint a project representative to supervise architects' and consulting engineers' inspection of
24 construction of buildings to ensure that all construction is in accordance with the contracts, plans, and
25 specifications. The cost of supervision may be charged against money available for construction.

26 ~~(8)~~(h) negotiate deductive changes, not to exceed 7% of the total cost of a project, with the lowest
27 responsible bidder when the lowest responsible bid causes the project cost to exceed the appropriation or with
28 the lowest responsible bidders, if multiple contracts will be awarded on the project, when the total of the lowest
29 responsible bids causes the project cost to exceed the appropriation. A bidder is not required to negotiate a bid
30 but is required to honor the bid for the time specified in the bidding documents. The department may terminate

1 negotiations at any time.

2 (2) Land purchases must be approved by the board of land commissioners. To the extent practical and
 3 consistent with the board of land commissioners' powers and duties pursuant to 77-1-202, land purchases may
 4 not result in a net gain in land owned by the state on [the effective date of this act]."

5

6 **Section 4.** Section 18-2-111, MCA, is amended to read:

7 **"18-2-111. Policy regarding practice of architecture -- preparation of working drawings by**
 8 **department limited.** (1) It is the policy of the state not to engage in the practice of architecture. However, this
 9 policy may not be construed as prohibiting the department of administration from:

10 (a) engaging in preplanning functions necessary to prepare a building program for presentation to the
 11 legislature;

12 (b) supervising construction as provided in ~~48-2-105(7)~~ 18-2-105(1)(g); or

13 (c) preparing working drawings for minor projects.

14 (2) The department of administration may not prepare working drawings for the construction of a building,
 15 with the exception of repair or maintenance projects, when the total cost of the construction will exceed \$75,000."

16

17 **Section 5.** Section 20-25-307, MCA, is amended to read:

18 **"20-25-307. Disposition of land.** (1) The board of regents may sell, exchange, and lease land and grant
 19 easements and licenses on land that is held or administered by the board of regents or the system and that is
 20 held by the state for the use and benefit of the board of regents or the system.

21 (2) The board of regents may not grant an estate or interest in land that was granted to the state in trust
 22 for the support and benefit of the system.

23 (3) In disposing of any estate or interest in land pursuant to subsection (1), the board of regents shall
 24 obtain consideration that equals or exceeds the full market value of the land. For sales and exchanges, full market
 25 value must be determined by the board of regents after an appraisal by a certified or licensed appraiser. If the
 26 appraiser determines that the valuation is not complicated and estimates, based on available data, that the full
 27 market value of the property is \$10,000 or less, the board of regents may use a restricted or limited appraisal.

28 (4) Before approving an exchange of land, the board of regents shall give the public notice of the
 29 proposed exchange and an opportunity to comment. The board of regents shall, upon request of any person, hold
 30 a public hearing in the area where the state land to be conveyed is located. Subject to subsection (6), the board

1 of regents may, after review of the comments, approve the exchange if it determines that the exchange is in the
2 best interests of the system.

3 (5) Prior to the sale of land, the board of regents shall prepare a request for proposals to purchase the
4 land and publish public notice of the sale once a week for 4 consecutive weeks in a newspaper of general
5 circulation published in the county where the land is situated. If a newspaper is not published in that county,
6 notice must be published in any newspaper of general circulation in that county. The notice must describe the
7 land to be sold, the appraised value of the land, the procedure by which persons may obtain the request for
8 proposals, the terms and conditions of sale, and the criteria upon which each proposal will be evaluated. The sale
9 procedure must provide reasonable opportunity for members of the public to submit proposals to purchase the
10 land. The board of regents may sell the land only if it determines that the sale is in the best interests of the
11 system. If the board of regents sells the land, the sale must be to the offeror whose proposal the board
12 determines to be the most advantageous to the system, taking into consideration the price and the other
13 evaluation criteria listed in the request for proposals.

14 (6) (a) The board of regents may sell or exchange the land only if the board of regents first:

15 (i) requests and obtains the written concurrence of the board of land commissioners;

16 (ii) provides proof that no use restrictions, encumbrances, or other conditions have been placed by the
17 board of regents on the land proposed for sale or exchange that prevent the state from obtaining full market value
18 for the land, taking into consideration the price and the other evaluation criteria listed in the request for proposals;

19 (iii) complies with the requirements of the Montana Environmental Policy Act provided in Title 75, chapter
20 1, parts 1 through 3; and

21 (iv) complies with the requirements of Montana antiquities laws provided in Title 22, chapter 3, part 4.

22 (b) The board of land commissioners may refuse to concur if it determines that:

23 (i) the sale or exchange does not return to the state full market value;

24 (ii) the evaluation criteria in the request for proposals or the sale procedure and proposal selection
25 process did not provide the public with a reasonable opportunity to submit proposals to purchase the land or to
26 have reasonable proposals selected;

27 (iii) the sale or exchange is not in the best interests of the state;

28 (iv) after considering to the extent practical and consistent with the board of land commissioners' powers
29 and duties pursuant to 77-1-202, the land purchase would result in a net gain in land owned by the state on [the
30 effective date of this act]; or

1 ~~(iv)~~(v) the system has not complied with the requirements of subsections (6)(a)(ii) through (6)(a)(iv).

2 (7) After obtaining written concurrence of the board of land commissioners required in subsection (6),
3 the board of regents shall convey the land by deed, executed by the presiding officer of the board or other person
4 designated by the board, without covenants of warranty."

5

6 **Section 6.** Section 22-3-1003, MCA, is amended to read:

7 **"22-3-1003. Powers of commission -- contracts -- rules.** (1) (a) The Montana heritage preservation
8 and development commission may contract with private organizations to assist in carrying out the purpose of
9 22-3-1001. The term of a contract may not exceed 20 years.

10 (b) The provisions of Title 18 may not be construed as prohibiting contracts under this section from being
11 let by direct negotiation. The contracts may be entered into directly with a vendor and are not subject to state
12 procurement laws.

13 (c) Architectural and engineering review and approval do not apply to the historic renovation projects
14 or projects at historic sites unless stated in specific state appropriations for construction permitted under the
15 commission's jurisdiction.

16 (d) The contracts must provide for the payment of prevailing wages.

17 (e) A contract for supplies or services, or both, may be negotiated in accordance with commission rules.

18 (f) Management activities must be undertaken to encourage the profitable operation of properties.

19 (g) Contracts may include the lease of property managed by the commission. Provisions for the renewal
20 of a contract must be contained in the contract.

21 (2) (a) Except as provided in subsection (2)(b), the commission may not contract for the construction of
22 a building, as defined in 18-2-101, in excess of \$300,000 without the consent of the legislature. Building
23 construction must be in conformity with applicable guidelines developed by the national park service of the U.S.
24 department of the interior, the Montana historical society, and the Montana department of fish, wildlife, and parks.
25 Funding for these projects must pass through directly to the commission.

26 (b) The commission may contract for the preservation, stabilization, or maintenance of existing structures
27 or buildings for an amount that exceeds \$300,000 without legislative consent if the commission determines that
28 waiting for legislative consent would cause unnecessary damage to the structures or buildings or would result
29 in a significant increase in cost to conduct those activities in the future.

30 (3) (a) Subject to subsection (3)(b), the commission, as part of a contract, shall require that a portion of

1 any profit be reinvested in the property and that a portion be used to pay the administrative costs of the property
2 and the commission.

3 (b) (i) Until the balance in the cultural and aesthetic trust reaches \$7,750,000, the commission shall
4 deposit the portion of profits not used for administrative costs and restoration of the properties in the cultural and
5 aesthetic trust.

6 (ii) Once the balance in the cultural and aesthetic trust reaches \$7,750,000, the commission shall deposit
7 the portion of profits not used for administrative costs and restoration of the properties in the general fund.

8 (c) It is the intent of the 58th legislature that no general fund money be provided for the operations and
9 maintenance of Virginia City and Nevada City beyond what has been appropriated by the 55th legislature.

10 (4) The commission may solicit funds from other sources, including the federal government, for the
11 purchase, management, and operation of properties.

12 (5) (a) The commission may use volunteers to further the purposes of this part.

13 (b) The commission and volunteers stand in the relationship of employer and employee for purposes
14 of and as those terms are defined in Title 39, chapter 71. The commission shall provide each volunteer with
15 workers' compensation coverage, as provided in Title 39, chapter 71, during the course of the volunteer's
16 assistance.

17 (6) Volunteers are not salaried employees and are not entitled to wages and benefits. The commission
18 may, in its discretion, reimburse volunteers for their otherwise uncompensated out-of-pocket expenses, including
19 but not limited to their expenditures for transportation, food, and lodging.

20 (7) The commission shall establish a subcommittee composed of an equal number of members of the
21 Montana historical society board of trustees and commission members to review and recommend the sale of
22 personal property from the former Bovey assets acquired by the 55th legislature. A recommendation to sell may
23 be presented to the commission only if the recommendation is supported by a majority of the members of the
24 subcommittee.

25 (8) The commission shall adopt rules establishing a policy for making acquisitions and sales of real and
26 personal property. With respect to each acquisition or sale, the policy must give consideration to:

27 (a) whether the property represents the state's culture and history;

28 (b) whether the property can become self-supporting;

29 (c) whether the property can contribute to the economic and social enrichment of the state;

30 (d) whether the property lends itself to programs to interpret Montana history;

1 (e) whether the acquisition or sale will create significant social and economic impacts to affected local
2 governments and the state;

3 (f) whether the sale is supported by the director of the Montana historical society;

4 (g) whether the commission should include any preservation covenants in a proposed sale agreement
5 for real property;

6 (h) whether the commission should incorporate any design review ordinances established by Virginia
7 City into a proposed sale agreement for real property; and

8 (i) other matters that the commission considers necessary or appropriate.

9 (9) Except as provided in subsection (11), the proceeds of any sale under subsection (8) must be placed
10 in the account established in 22-3-1004.

11 (10) Public notice and the opportunity for a hearing must be given in the geographical area of a proposed
12 acquisition or sale of real property before a final decision to acquire or sell the property is made. The commission
13 shall approve proposals for acquisition or sale of real property and recommend the approved proposal to the
14 board of land commissioners. Land purchases must be approved by the board of land commissioners. To the
15 extent practical and consistent with the board of land commissioners' powers and duties pursuant to 77-1-202,
16 land purchases may not result in a net gain in land owned by the state on [the effective date of this act].

17 (11) The commission, working with the board of investments, may establish trust funds to benefit historic
18 properties. Interest from any trust fund established under this subsection must be used to preserve and manage
19 assets owned by the commission. Funds from the sale of personal property from the Bovey assets must be
20 placed in a trust fund, and interest from the trust fund must be used to manage and protect the remaining
21 personal property.

22 (12) Prior to the convening of each regular session, the commission shall report to the governor and the
23 legislature, as provided in 5-11-210, concerning financial activities during the prior biennium, including the
24 acquisition or sale of any assets."
25

26 **Section 7.** Section 23-1-102, MCA, is amended to read:

27 **"23-1-102. Powers and duties of department of fish, wildlife, and parks.** (1) The department shall
28 make a study to determine the scenic, historic, archaeological, scientific, and recreational resources of the state.
29 The department may by purchase, lease, agreement, or acceptance of donations acquire for the state any areas,
30 sites, or objects that in its opinion should be held, improved, and maintained as state parks, state recreational

1 areas, state monuments, or state historical sites. The department, with the consent of the commission, may
 2 acquire by condemnation, pursuant to Title 70, chapter 30, lands or structures for the purposes provided in
 3 87-1-209(2).

4 (2) The department may accept in the name of the state, in fee or otherwise, any areas, sites, or objects
 5 conveyed, entrusted, donated, or devised to the state. It may accept gifts, grants, bequests, or contributions of
 6 money or other property to be spent or used for any of the purposes of this part.

7 (3) A contract, for any of the purposes of this part, may not be entered into or another obligation incurred
 8 until money has been appropriated by the legislature or is otherwise available. If the contract or obligation pertains
 9 to acquisition of areas or sites ~~in excess of either 100 acres or \$100,000 in value~~, the board of land
 10 commissioners shall specifically approve the acquisition. Land purchases must be approved by the board of land
 11 commissioners. To the extent practical and consistent with the board of land commissioners' powers and duties
 12 pursuant to 77-1-202, land purchases may not result in a net gain in land owned by the state on [the effective date
 13 of this act] except in the case of purchasing fishing access sites that consist of less than 5 acres.

14 (4) The department has jurisdiction, custody, and control of all state parks, recreational areas, public
 15 camping grounds, historical sites, and monuments, except wayside camps and other public conveniences
 16 acquired, improved, and maintained by the department of transportation and contiguous to the state highway
 17 system. The department may designate lands under its control as state parks, state historical sites, state
 18 monuments, or by any other designation that it considers appropriate. The department may remove or change
 19 the designation of any area or portion of an area and may name or change the name of any area. The department
 20 may lease those portions of designated lands that are necessary for the proper administration of the lands in
 21 keeping with the basic purpose of this part."

22

23 **Section 8.** Section 67-2-301, MCA, is amended to read:

24 **"67-2-301. State airports -- acquisition.** (1) The department may, on behalf of and in the name of this
 25 state:

26 (a) subject to subsection (6), acquire real or personal property by purchase, gift, devise, lease,
 27 condemnation proceedings pursuant to Title 70, chapter 30, or otherwise for the purpose of establishing and
 28 constructing airports, restricted landing areas, and other air navigation facilities;

29 (b) acquire in like manner, own, control, establish, construct, enlarge, improve, maintain, equip, operate,
 30 regulate, and police airports, restricted landing areas, and other air navigation facilities either within or outside

1 of this state;

2 (c) prior to acquisition, make investigations, surveys, and plans;

3 (d) erect, install, construct, and maintain facilities at those airports for the servicing of aircraft and for the
4 comfort and accommodation of air travelers; and

5 (e) dispose of any property, airport, restricted landing area, or other air navigation facility by sale, lease,
6 or otherwise in accordance with the laws of this state governing the disposition of other similar property of the
7 state.

8 (2) The department may not acquire or take over an airport, restricted landing area, or other air
9 navigation facility owned or controlled by a municipality of this state without the consent of the municipality. The
10 department may erect, equip, operate, and maintain at an airport all buildings and equipment necessary and
11 proper to establish, maintain, and conduct the airport and air navigation facilities connected with the airport.

12 (3) When necessary, in order to provide unobstructed air space for the landing and taking off of aircraft
13 utilizing airports and restricted landing areas acquired or operated under the provisions of this title, the
14 department may acquire, in the manner provided for the acquisition of property for airport purposes, easements
15 through or other interests in air space over land or water, interests in airport hazards outside the boundaries of
16 the airports or restricted landing areas, and other airport protection privileges that are necessary to ensure safe
17 approaches to the landing areas of airports and restricted landing areas and the safe and efficient operation of
18 them. The department may also acquire in the same manner the right or easement, for a term of years or
19 perpetually, to place or maintain suitable marks for the daytime marking and suitable lights for the nighttime
20 marking of airport hazards, including the right of ingress and egress to or from the airport hazards for the purpose
21 of maintaining and repairing the lights and marks. This authority does not limit the right, power, or authority of the
22 state or a municipality to zone property adjacent to an airport or restricted landing area pursuant to a law of this
23 state.

24 (4) The department may engage in the activities listed in subsections (1) through (3) jointly with the
25 United States, with other states, and with municipalities or other agencies of this state.

26 (5) For the purpose of acquiring any property that it is authorized to acquire, the department may
27 exercise the right of eminent domain, in the name of the state, in the manner provided in Title 70, chapter 30. The
28 acquisition of property for any of the purposes listed in this section is a public use.

29 (6) Land purchases must be approved by the board of land commissioners. To the extent practical and
30 consistent with the board of land commissioners' powers and duties pursuant to 77-1-202, land purchases may

1 not result in a net gain in land owned by the state on [the effective date of this act]."

2

3 **Section 9.** Section 75-15-223, MCA, is amended to read:

4 **"75-15-223. Authority to acquire interest in land for screening and removal of junkyards, motor**
 5 **vehicle graveyards, motor vehicle wrecking facilities, garbage dumps, and sanitary landfills.** (1) When the
 6 department of transportation determines that it is in the best interests of the state, it may acquire land or interest
 7 in land that may be necessary to provide adequate screening for junkyards, motor vehicle graveyards, motor
 8 vehicle wrecking facilities, garbage dumps, and sanitary landfills.

9 (2) When the department of transportation determines that the topography of the land adjoining the
 10 highway will not permit adequate or economically feasible screening, it may acquire by gift, purchase, exchange,
 11 or condemnation interest in land that may be necessary to secure the relocation, removal, or disposal of
 12 junkyards, motor vehicle graveyards, motor vehicle wrecking facilities, garbage dumps, or sanitary landfills that
 13 were either lawfully:

14 (a) in existence on October 22, 1965;

15 (b) along any highway made a part of the interstate or primary systems on or after October 22, 1965,
 16 and before January 1, 1968; or

17 (c) established on or after January 1, 1968.

18 (3) The department of transportation shall pay just compensation to the owner for the relocation, removal,
 19 or disposal of any facility. Condemnation must be exercised pursuant to Title 60, chapter 4, and Title 70, chapter
 20 30.

21 (4) Any new site chosen by the department of transportation pursuant to subsection (2) for the relocation
 22 of a garbage dump or sanitary landfill must be approvable as the site of a solid waste management system
 23 pursuant to Title 75, chapter 10, part 2, and the rules promulgated under authority of that part.

24 (5) Land purchases must be approved by the board of land commissioners. To the extent practical and
 25 consistent with the board of land commissioners' powers and duties pursuant to 77-1-202, land purchases may
 26 not result in a net gain in land owned by the state on [the effective date of this act]."

27

28 **Section 10.** Section 76-12-107, MCA, is amended to read:

29 **"76-12-107. Methods of bringing land under part.** (1) A natural area, as defined in 76-12-104, may
 30 become subject to the provisions of this part in any of the following ways:

- 1 ~~(1)~~(a) designation by the board on lands controlled by the board;
- 2 ~~(2)~~(b) designation by the legislature on lands owned by the state of Montana;
- 3 ~~(3)~~(c) subject to subsection (2), acquisition by the board by purchase with consent of the property owner
- 4 of sufficient interests in private property to protect the natural area; ~~provided, however, that~~ However, the transfer
- 5 of surface property or development rights ~~shall~~ may not alter the rights attending the subsurface estate if owned
- 6 by another party;
- 7 ~~(4)~~(d) gift accepted by the board under the authority of 77-1-213, including conservation easements,
- 8 provided that lands accepted must be protected and managed as natural areas and money accepted must be
- 9 used in accordance with the purposes of this part;
- 10 ~~(5)~~(e) trade of state-owned trust land for a natural area on federal, county, or private land, provided;

 29 (f) to extend and consolidate by exchange, lands or waters suitable for these purposes.

30 (2) The department, with the consent of the commission, may acquire by condemnation, as provided in

1 Title 70, chapter 30, lands or structures for the preservation of historical or archaeological sites that are
2 threatened with destruction or alteration.

3 (3) (a) Subject to section 2(3), Chapter 560, Laws of 2005, the department, with the consent of the
4 commission, may dispose of lands and water rights acquired by it on those terms after public notice as required
5 by subsection (3)(b) of this section, without regard to other laws that provide for sale or disposal of state lands
6 and with or without reservation, as it considers necessary and advisable. The department, with the consent of
7 the commission, may convey department lands and water rights for full market value to other governmental
8 entities or to adjacent landowners without regard to the requirements of subsection (3)(b) or (3)(c) if the land is
9 less than 10 acres or if the full market value of the interest to be conveyed is less than \$20,000. When the
10 department conveys land or water rights to another governmental entity or to an adjacent landowner pursuant

17 (c) The notice must advertise for cash bids to be presented to the director within 60 days from the date
18 of the first publication. Each bid must be accompanied by a cashier's check or cash deposit in an amount equal

20 after mailing notice by certified mail to the highest bidder. If that bidder defaults on payment of the balance due,
