10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

12 NEW SECTION. **Section 1. Civil penalties for anonymous materials** ~~CAMPAIGN ADVERTISING~~
13 **MATERIALS -- option for hearing -- collection and disposition of penalty amounts.** (1) In addition to any other
14 penalties or remedies established by law, a person whose ~~election materials violate~~ ~~CAMPAIGN ADVERTISING~~
15 ~~VIOLATES ELECTION MATERIALS VIOLATE~~ a provision of 13-35-225 is subject to a civil penalty of \$100 for each
16 instance, as defined by rule, in UP TO \$300 FOR EACH ORDER OF NONCOMPLIANCE FOR which the ~~election material~~
17 ~~CAMPAIGN ADVERTISING ELECTION MATERIAL~~ is not corrected or withdrawn from circulation after ~~an~~ THE order of
18 noncompliance has been issued under 13-35-225(6), ~~up to a maximum penalty of \$2,500.~~

19 (2) (a) A person against whom a civil penalty is imposed pursuant to this section may request a hearing
20 before the commissioner within 10 days of receiving a notice from the commissioner of imposition of a civil
21 penalty. Upon receipt of a timely request, the commissioner shall hold an informal contested case hearing under
22 the provisions of Title 2, chapter 4, part 6.

23 (b) At the hearing, the commissioner shall consider any mitigating factors or circumstances and may
24 reduce or waive the civil penalty.

3 ——— (i) the activities of a public officer, the public officer's staff, or legislative staff related to determining the
4 impact of passage or failure of a ballot issue on state or local government operations;

5 ——— (ii) in the case of a school district, as defined in Title 20, chapter 6, compliance with the requirements of
6 law governing public meetings of the local board of trustees, including the resulting dissemination of information
7 by a board of trustees or a school superintendent or a designated employee in a district with no superintendent
8 in support of or opposition to a bond issue or levy submitted to the electors. Public funds may not be expended
9 for any form of commercial advertising in support of or opposition to a bond issue or levy submitted to the
10 electors:

11 ——— (c) This subsection (3) is not intended to restrict the right of a public officer or public employee to express
12 personal political views:

13 ——— (4) A candidate, as defined in 13-1-101(6)(a) 13-1-101(7)(a), may not use or permit the use of state
14 funds for any advertisement or public service announcement in a newspaper, on radio, or on television that
15 contains the candidate's name, picture, or voice except in the case of a state or national emergency and then only
16 if the announcement is reasonably necessary to the candidate's official functions:

17 ——— (5) A public officer or public employee may not participate in a proceeding when an organization, other
18 than an organization or association of local government officials, of which the public officer or public employee
19 is an officer or director is:

20 ——— (a) involved in a proceeding before the employing agency that is within the scope of the public officer's
21 or public employee's job duties; or

22 ——— (b) attempting to influence a local, state, or federal proceeding in which the public officer or public
23 employee represents the state or local government.

24 ——— (6) A public officer or public employee may not engage in any activity, including lobbying, as defined in
25 5-7-102, on behalf of an organization, other than an organization or association of local government officials, of
26 which the public officer or public employee is a member while performing the public officer's or public employee's
27 job duties. The provisions of this subsection do not prohibit a public officer or public employee from performing
28 charitable fundraising activities if approved by the public officer's or public employee's supervisor or authorized
29 by law:

 4 ~~or defeat of a candidate, political party, or ballot issue~~ CAMPAIGN ADVERTISING ALL COMMUNICATIONS EXPRESSLY
 5 ADVOCATING THE SUCCESS OR DEFEAT OF A CANDIDATE, POLITICAL PARTY, OR BALLOT ISSUE through any broadcasting
 6 station, newspaper, magazine, outdoor advertising facility, direct mailing, poster, handbill, bumper sticker, internet
 7 website, or other form of general political advertising must clearly and conspicuously include the attribution "paid
 8 for by" followed by the name and address of the person who made or financed the expenditure for the
 9 communication CAMPAIGN ADVERTISING COMMUNICATION. ~~When~~ THE ATTRIBUTION MUST CONTAIN:

10 (A) FOR CAMPAIGN ADVERTISING ELECTION MATERIAL FINANCED BY a candidate or a candidate's campaign,
 11 ~~finances the expenditure, the attribution must be~~ the name and the address of the candidate or the candidate's
 12 campaign; AND ~~In the case of~~

13 (B) FOR CAMPAIGN ADVERTISING ELECTION MATERIAL FINANCED BY a political committee, ~~the attribution must~~
 14 ~~be the name of the committee, the name of the committee treasurer,~~ THE NAME and the address of the committee
 15 ~~or the committee treasurer.~~

16 (2) ~~Communications~~ CAMPAIGN ADVERTISING COMMUNICATIONS in a partisan election financed by a
 17 candidate or a political committee organized on the candidate's behalf must state the candidate's party affiliation
 18 or include the party symbol.

19 (3) (a) ~~Printed election material~~ CAMPAIGN ADVERTISING PRINTED ELECTION MATERIAL described in
 20 subsection (1) that includes information about another candidate's voting record must include:

21 (i) a reference to the particular vote or votes upon which the information is based;
 22 (ii) a disclosure of contrasting votes known to have been made by the candidate on the same issue if
 23 closely related in time; and

24 (iii) a statement, signed as provided in subsection (3)(b), that to the best of the signer's knowledge, the
 25 statements made about the other candidate's voting record are accurate and true.

26 (b) The statement required under subsection (3)(a) must be signed:

27 (i) by the candidate if the ~~election material~~ CAMPAIGN ADVERTISING ELECTION MATERIAL was prepared for
 28 the candidate or the candidate's political committee and includes information about another candidate's voting
 29 record; or

30 (ii) by the person financing the ~~communication~~ CAMPAIGN ADVERTISING COMMUNICATION or the person's

1 legal agent if the ~~election material~~ CAMPAIGN ADVERTISING ELECTION MATERIAL was not prepared for a candidate
 2 or a candidate's political committee.

3 (4) If a document or other article of advertising is too small for the requirements of subsections (1)
 4 through (3) to be conveniently included, the candidate responsible for ~~the material~~ THE MATERIAL or the person
 5 financing the ~~communication~~ CAMPAIGN ADVERTISING COMMUNICATION shall file a copy of the article with the
 6 commissioner of political practices, together with the required information or statement, at the time of its public
 7 distribution.

8 (5) If information required in subsections (1) through (3) is omitted or not printed, upon discovery of or
 9 notification about the omission, the candidate responsible for ~~the material~~ THE MATERIAL or the person financing
 10 the ~~communication~~ CAMPAIGN ADVERTISING COMMUNICATION shall:

11 (a) file notification of the omission with the commissioner of political practices within 5 days of the
 12 discovery or notification;
