5	A JOINT RESOLUTION OF THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE STATE OF
6	MONTANA ENCOURAGING THE LEGISLATIVE COUNCIL TO CONTINUE TO WORK ON LEGISLATIVE
7	SPACE ISSUES DURING THE 2011-2012 INTERIM, INCLUDING MAKING A RECOMMENDATION TO THE
8	2013 LEGISLATURE REGARDING LONG-RANGE BUILDING PROPOSALS.

10	WHEREAS, section 2-17-805(4), MCA, provides for the Legislative Council to serve as a long-range
11	building committee to recommend to the Legislature and the Department of Administration construction and
12	remodeling priorities for the Capitol; and
13	WHEREAS, section 2-17-825, MCA, states that the Legislative Council may prepare a written report of
14	its activities and recommendations related to its long-range building duties, including assignment of space in the
15	Capitol, under section 2-17-805, MCA, to assist the Legislature in determining whether recommendations should
16	be implemented; and
17	WHEREAS, on June 1, 2010, the Legislative Council voted to support a request to retain the services
18	of a professional architecture and planning firm, CTA Architects Engineers, to develop a master plan for
19	legislative space in the Capitol; and
20	WHEREAS, CTA Architects Engineers prepared a report for the Legislative Council recommending the
21	eventual building of a Legislative Annex, and the report will be forwarded, without recommendation, to the Joint
22	Subcommittees of General Government and Long-Range Planning; and
23	WHEREAS, the Legislative Council did not adopt a recommendation regarding the Legislative Annex,
24	but did forward a new proposal recommending interim improvements and does wish to continue its statutory
25	long-range planning activities next interim; and
26	WHEREAS, the Legislative Council should continue to follow up on the actions of the 2011 Legislature
27	to determine if a proposal needs to go forward to the 2013 Legislature and should continue to work with the
28	Department of Administration to determine whether any additional study is needed for the offices of the Governor
29	and the Secretary of State and their respective staff who occupy the second floor of the Capitol Building.
