5	A JOINT RESOLUTION OF THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE STATE OF
6	MONTANA URGING THE DEVELOPMENT AND PROMOTION OF POLICIES THAT PROMOTE THE
7	RESPONSIBLE DEVELOPMENT OF OIL AND GAS LEASES ON FEDERAL LANDS.

9	WHEREAS, there are 32 million acres of oil and gas minerals in Montana that are owned by the American
10	public and administered by the Bureau of Land Management (BLM); and
11	WHEREAS, the federal government does not develop oil and gas itself, but instead leases development
12	rights to private industry. Leasing demand is a function of market conditions and national energy consumption;
13	and
14	WHEREAS, the BLM succumbed to pressure from environmental groups and halted bids on oil and gas
15	leases last year even though concerns about greenhouse gas emissions and effects on wildlife are unfounded;
16	and
17	WHEREAS, the decline in federal leasing of minerals makes it more difficult for companies to develop
18	oil and gas in an environmentally responsible manner, harms economies throughout the state, and decreases
19	state and local government revenue; and
20	WHEREAS, this policy puts Montana at a distinct disadvantage compared to other regions of the country
21	that do not have significant federal lands, acting as a catalyst that will cause energy jobs and economic activity
22	to migrate to those other regions; and
23	WHEREAS, policies that further slow leasing and permitting will discourage companies from operating
24	in Montana and the state will not experience the rebound in jobs and economic growth that it otherwise would
25	as the American economy recovers; and
26	WHEREAS, the oil and gas industry in Montana is a valued partner in supplying oil and natural gas
27	resources that enhance American energy security.

29	NOW, THEREFORE, BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE

(1) That the United States Department of the Interior consider the negative impact that oil and gas leasing
 and permitting policies may have on Montana's economy, the jobs of its citizens, and the state and local
 government revenue that funds vital services such as schools, roads, and law enforcement.

4 (2) That the United States Department of the Interior develop policies that promote the responsible
5 development of Montana's public lands.

(3) That the Secretary of State send a copy of this resolution to the President of the United States, the
Speaker of the United States House of Representatives, the Majority Leader of the United States Senate, the
secretary of the United States Department of the Interior, and each member of the Montana Congressional
Delegation.
