Explanation - This amendment:

(1) revises the definition of "political committee" to remove the requirement that two or more individuals or a person other than an individual make aggregate contributions or expenditures of \$500 or more before the person or individuals are defined as political committees subject to reporting requirements.

(2) amends contributions limits in 13-37-216 to the current amounts established in administrative rule.

(3) amends the aggregate amount of money an individual must contribute before the certain information about the individual must be disclosed from \$100 to \$35.

(4) coordinates SB 375 with HB 229, which also revises contribution limits.
