"2-15-1740. Board of hearing aid dispensers. (1) There is a board of hearing aid dispensers.

(2) The board consists of five members appointed by the governor with the consent of the senate, including:

(a) ~~two three~~ members, each of whom has been a licensed hearing aid dispenser for at least 5 years, ~~possesses a current audiologist license issued under Title 37, chapter 15, and has a master's level college degree;~~~~(b) two members, each of whom does not hold a master's level college degree in audiology but has been a licensed dispenser and fitter of hearing aids for at least 5 years before being appointed to the board; and~~~~(c) (b) one public member who is either an otolaryngologist or an audiologist or is a person who is not a licensed hearing aid dispenser or a licensed audiologist and who regularly uses a hearing aid because of a demonstrated hearing impairment and who is not a licensed hearing aid dispenser or a licensed audiologist; and~~(c) a member of the public.

(3) Each member shall serve for 3-year terms. A member may not be reappointed within 1 year after the expiration of the member's second consecutive full term.

(4) The board is allocated to the department for administrative purposes only as prescribed in 2-15-121."
