5 A BILL FOR AN ACT ENTITLED: "AN ACT REQUIRING WORKERS' COMPENSATION COVERAGE FOR
6 VOLUNTEER FIREFIGHTERS; REQUIRING EACH COUNTY GOVERNING BODY TO ESTABLISH A FUND
7 FOR PAYING VOLUNTEER FIREFIGHTERS' WORKERS' COMPENSATION PREMIUMS; ALLOWING COUNTY
8 GOVERNING BODIES TO IMPOSE A PERMISSIVE LEVY FOR PAYMENT OF PREMIUMS FOR VOLUNTEER
9 FIREFIGHTERS; EXCLUDING CERTAIN CITIES FROM THE PROPERTY TAX PERMISSIVE LEVY FOR
10 VOLUNTEER FIREFIGHTERS' WORKERS' COMPENSATION; REVISING PREMIUM AND BENEFIT
11 PROVISIONS FOR VOLUNTEER FIREFIGHTERS AND CERTAIN VOLUNTEER EMERGENCY MEDICAL
12 TECHNICIANS; SUPERSEDING THE UNFUNDED MANDATE LAWS; AMENDING SECTIONS 7-6-621,
13 7-33-2109, 7-33-2209, 7-33-2403, 7-33-4111, 15-10-420, 39-71-118, 39-71-123, AND 39-71-401, MCA; AND
14 PROVIDING AN EFFECTIVE DATE."

16 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

17
18 NEW SECTION. **Section 1. Workers' compensation for volunteer firefighters -- definitions.** (1) As
19 of July 1, 2014, an employer shall provide workers' compensation coverage as provided in Title 39, chapter 71,
20 to any volunteer firefighter who is listed on a roster of service.

21 (2) An employer may purchase workers' compensation coverage from any entity authorized to provide
22 workers' compensation coverage under plan No. 1, 2, or 3 as provided in Title 39, chapter 71.

23 (3) (a) Except as provided in subsections (3)(b) and (3)(c), an employer shall by the first Tuesday in
24 September of each year certify to the county governing body the dollar amount of workers' compensation
25 premiums paid or expected to be paid for the employer's volunteer firefighters' annual policy period.

26 (b) (i) By September 3, 2013, an employer not exempted under [section 3(6)] shall provide the county
27 governing body with an estimate of the dollar amount anticipated as necessary to provide annual workers'
28 compensation coverage, starting no later than July 1, 2014, for volunteer firefighters as provided in this section.

29 (i) An employer that has provided volunteer firefighters with workers' compensation coverage with
30 funding subject to the limitations in 15-10-420 may choose to provide coverage through the permissive levy

1 allowed in [section 3] and, if that choice is made, shall base the estimated dollar amount under subsection (3)(b)(i)
 2 on actual coverage costs.

3 (c) An employer exempted under [section 3(6)] is not subject to the reporting requirements in this
 4 subsection (3) unless the employer requests funding under the permissive levy provided for in [section 3].

5 (4) The county governing body shall reimburse employers the actual costs as certified in subsection (3)
 6 for the workers' compensation coverage for volunteer firefighters from the fund established in [section 2].

7 (5) An employer shall file a roster of service with the clerk and recorder in the county in which the
 8 employer is located and update the roster of service monthly if necessary to report changes in the number of
 9 volunteers on the roster of service. The clerk and recorder shall file the original and replace it with updates
 10 whenever necessary.

11 (6) For the purposes of this section, the following definitions apply:

12 (a) (i) "Employer" means the governing body of a fire agency organized under Title 7, chapter 33,
 13 including a rural fire district, a fire service area, a volunteer fire department, a volunteer fire company, or a
 14 volunteer rural fire control crew.

15 (ii) The term does not mean a governing body of a city of the first class or second class, including a city
 16 to which 7-33-4109 applies, that on or after July 1, 2014, provides workers' compensation coverage to employees
 17 as defined in 39-71-118.

18 (b) "Roster of service" means the list of volunteer firefighters who have filled out a membership card
 19 similar to that required under the Volunteer Firefighters' Compensation Act in Title 19, chapter 17, and that is filed
 20 with the county clerk and recorder.

21 (c) (i) "Volunteer firefighter" means a volunteer who is on the employer's roster of service. A volunteer
 22 firefighter includes a volunteer emergency medical technician as defined in 50-6-202 who is on the roster of
 23 service. A volunteer firefighter is not required to be an active member as defined in 19-17-102.

24 (ii) The term does not mean an individual who is not listed on a roster of service or a member of a
 25 volunteer fire department provided for in 7-33-4109.

26
 27 **NEW SECTION. Section 2. Fund for volunteer firefighters' workers' compensation.** (1) Each county
 28 governing body shall establish a special revenue fund known as the volunteer firefighters' workers' compensation
 29 fund.

30 (2) Levies imposed pursuant to [section 3] must be placed in the fund.

1 (3) Expenditures from the fund may be made only to provide reimbursements to employers, as defined
2 in [section 1], for workers' compensation premiums required by [section 1].

3 (4) Money in the fund must be invested as provided in 7-6-202. Interest and income from the investment
4 of money in the fund must be credited to the fund.

5
6 **NEW SECTION. Section 3. County tax levy to pay volunteer firefighters' workers' compensation**

7 **coverage.** (1) Subject to subsection (6), the county governing body shall levy an annual property tax in the
8 amount necessary to:

9 (a) fund premiums for workers' compensation for volunteer firefighters as provided in [section 1]; and

10 (b) establish a reserve in accordance with 7-6-4034(2)(a).

11 (2) The amount determined in subsection (1) is not subject to the mill levy limitation provided for in
12 15-10-420. Levies implemented under this section must be calculated separately from the mill levies calculated
13 under 15-10-420 and are not subject to the inflation factor described in 15-10-420(1)(a).

14 (3) Subject to subsection (6), volunteer firefighters' workers' compensation premiums that are paid wholly
15 or in part from user charges generated by proprietary funds, as defined by generally accepted accounting
16 principles, are included in the amount exempted from the mill levy calculation limitation provided for in 15-10-420.

17 (4) If tax-billing software is capable, the county treasurer shall list separately the cumulative mill levy or
18 dollar amount on the tax notice sent to each taxpayer under 15-16-101(2). The dollar amount must also be
19 reported to the department of administration pursuant to 7-6-4003.

20 (5) The mill levy must be described as the permissive volunteer firefighters' workers' compensation levy.

21 (6) Property located within the boundaries of any incorporated city or town that on or after July 1, 2014,
22 provides workers' compensation coverage to employees as defined in 39-71-118 is not subject to the levy
23 provided for in this section.

24
25 **NEW SECTION. Section 4. Public hearing requirement.** Each year prior to implementing a levy as

26 provided in [section 3] and after giving notice of a hearing as provided in 7-1-2121, the county governing body
27 shall hold a public hearing regarding implementation of the levy.

28
29 **Section 5.** Section 7-6-621, MCA, is amended to read:

30 **"7-6-621. Volunteer firefighters' disability income insurance authorized -- voted levy -- fund. (1)**

1 Disability income insurance, as defined in 33-1-235, may be purchased for volunteer firefighters, ~~must provide~~
2 ~~that:~~

3 ~~—— (a) payments or benefits are paid only for an injury received as a volunteer firefighter; and~~

4 ~~—— (b) the duration of payments or benefits may not exceed the lesser of 1 year or until the treating~~
5 ~~physician determines that the beneficiary is no longer disabled~~ Disability income insurance purchased under this
6 section is not the same as workers' compensation coverage required under [section 1].

7 (2) If the voters have approved a levy for the purchase of volunteer firefighters' disability income
8 insurance ~~or workers' compensation coverage~~, the governing body of a local government entity may establish
9 a volunteer firefighters' disability income insurance account. The governing body may hold money in the account
10 for any time period considered appropriate by the governing body. Money held in the account may not be
11 considered as cash balance for the purpose of reducing mill levies.

12 (3) Money may be expended from the account to purchase disability income insurance coverage ~~meeting~~
13 ~~the provisions of subsection (1) or for workers' compensation coverage~~ only for volunteer firefighters organized
14 or deployed pursuant to any of the provisions of Title 7, chapter 33, parts 21 through 24 or 41.

15 (4) Money in the account must be invested as provided by law. Interest and income from the investment
16 of money in the account must be credited to the account."
17

18 **Section 6.** Section 7-33-2109, MCA, is amended to read:

19 **"7-33-2109. Tax levy, debt incurrence, and bonds authorized -- voted levy for volunteer**
20 **firefighters' disability income ~~or workers' compensation coverage~~.** (1) At the time of the annual levy of taxes,
21 the board of county commissioners may, subject to 15-10-420, levy a tax upon all property within a rural fire
22 district for the purpose of buying or maintaining fire protection facilities, including real property, and apparatus,
23 including emergency response apparatus, for the district or for the purpose of paying to a city, town, or private
24 fire service the consideration provided for in any contract with the council of the city, town, or private fire service
25 for furnishing fire protection service to property within the district. The tax must be collected as are other taxes.
26 The tax under this section is not the same as the permissive levy provided for in [section 3].

27 (2) Subject to 15-10-425, the board of county commissioners may levy a tax upon all taxable property
28 within a rural fire district for the purpose of purchasing disability income insurance coverage ~~or workers'~~
29 ~~compensation coverage~~ for the volunteer firefighters of the district as provided in 7-6-621.

30 (3) The board of county commissioners or the trustees, if the district is governed by trustees, may pledge

1 the income of the district, subject to the requirements and limitations of 7-33-2105(1)(d), to secure financing
 2 necessary to procure equipment and buildings, including real property, to house the equipment.

3 (4) In addition to the levy authorized in subsection (1), a district may borrow money by the issuance of
 4 bonds to provide funds for the payment of all or part of the cost of buying or maintaining fire protection facilities,
 5 including real property, and apparatus, including emergency response apparatus, for the district.

6 (5) The amount of debt incurred pursuant to subsection (3) and the amount of bonds issued pursuant
 7 to subsection (4) and outstanding at any time may not exceed 1.1% of the total assessed value of taxable
 8 property, determined as provided in 15-8-111, within the district, as ascertained by the most recent assessment
 9 for state and county taxes prior to the incurrence of debt or the issuance of the bonds.

10 (6) The bonds must be authorized, sold, and issued and provisions must be made for their payment in
 11 the manner and subject to the conditions and limitations prescribed for the issuance of bonds by counties under
 12 Title 7, chapter 7, part 22."

13

14 **Section 7.** Section 7-33-2209, MCA, is amended to read:

15 **"7-33-2209. Finance of fire control activities -- voted levy for volunteer firefighters' disability**
 16 **income insurance or workers' compensation coverage.** (1) The county governing body may appropriate funds
 17 for the purchase, care, and maintenance of firefighting equipment or for the payment of wages in prevention,
 18 detection, and suppression of fires.

19 (2) Subject to 15-10-420, ~~if the general fund is budgeted to the full limit,~~ the county governing body may,
 20 at any time fixed by law for levy and assessment of taxes, levy a tax for the purposes of subsection (1).

21 (3) Subject to 15-10-425, the county governing body may levy a tax for the purpose of purchasing
 22 disability income insurance coverage ~~or workers' compensation coverage~~ for volunteer firefighters of volunteer
 23 rural fire control crews and county volunteer fire companies as provided in 7-6-621."

24

25 **Section 8.** Section 7-33-2403, MCA, is amended to read:

26 **"7-33-2403. Operation of fire service area -- voted levy for volunteer firefighters' disability income**
 27 **insurance or workers' compensation coverage.** (1) Whenever the board of county commissioners has
 28 established a fire service area, the commissioners may:

29 (a) govern and manage the affairs of the area;

30 (b) appoint five qualified trustees to govern and manage the affairs of the area; or

1 (c) authorize the election of five qualified trustees to govern and manage the affairs of the area. The term
2 of office and procedures for nomination and election are the same as those provided for election of rural fire
3 district trustees in 7-33-2106.

4 (2) Subject to 15-10-425, the commissioners may levy a tax upon all property within the county for the
5 purpose of buying disability income insurance coverage ~~or workers' compensation coverage~~ for volunteer
6 firefighters deployed within the fire service area as provided in 7-6-621.

7 (3) If the commissioners appoint trustees under subsection (1), the provisions of 7-33-2105 apply and
8 7-33-2106 applies whether the trustees are elected or appointed, except that the trustees shall prepare annual
9 budgets and request a schedule of rates for the budget."
10

11 **Section 9.** Section 7-33-4111, MCA, is amended to read:

12 **"7-33-4111. Tax levy for volunteer fire departments -- voted levy for volunteer firefighters'**
13 **disability income insurance ~~or workers' compensation coverage~~.** (1) For the purpose of supporting volunteer
14 fire departments in any city or town that does not have a paid fire department and for the purpose of purchasing
15 the necessary equipment for them, the council in any city or town may, subject to 15-10-420, levy, in addition to
16 other levies permitted by law, a tax on the taxable value of all taxable property in the city or town.

17 (2) Subject to 15-10-425, a city or town may levy a tax on the taxable value of all taxable property in the
18 city or town for the purpose of purchasing disability income insurance coverage ~~or workers' compensation~~
19 ~~coverage~~ for volunteer firefighters of volunteer fire departments as provided in 7-6-621.

20 (3) The levies in subsections (1) and (2) are not the same as the permissive levy provided for in [section
21 3]."
22

23 **Section 10.** Section 15-10-420, MCA, is amended to read:

24 **"15-10-420. Procedure for calculating levy.** (1) (a) Subject to the provisions of this section, a
25 governmental entity that is authorized to impose mills may impose a mill levy sufficient to generate the amount
26 of property taxes actually assessed in the prior year plus one-half of the average rate of inflation for the prior 3
27 years. The maximum number of mills that a governmental entity may impose is established by calculating the
28 number of mills required to generate the amount of property tax actually assessed in the governmental unit in the
29 prior year based on the current year taxable value, less the current year's value of newly taxable property, plus
30 one-half of the average rate of inflation for the prior 3 years.

1 (b) A governmental entity that does not impose the maximum number of mills authorized under
2 subsection (1)(a) may carry forward the authority to impose the number of mills equal to the difference between
3 the actual number of mills imposed and the maximum number of mills authorized to be imposed. The mill authority
4 carried forward may be imposed in a subsequent tax year.

5 (c) For the purposes of subsection (1)(a), the department shall calculate one-half of the average rate of
6 inflation for the prior 3 years by using the consumer price index, U.S. city average, all urban consumers, using
7 the 1982-84 base of 100, as published by the bureau of labor statistics of the United States department of labor.

8 (2) A governmental entity may apply the levy calculated pursuant to subsection (1)(a) plus any additional
9 levies authorized by the voters, as provided in 15-10-425, to all property in the governmental unit, including newly
10 taxable property.

11 (3) (a) For purposes of this section, newly taxable property includes:

12 (i) annexation of real property and improvements into a taxing unit;

13 (ii) construction, expansion, or remodeling of improvements;

14 (iii) transfer of property into a taxing unit;

15 (iv) subdivision of real property; and

16 (v) transfer of property from tax-exempt to taxable status.

17 (b) Newly taxable property does not include an increase in value that arises because of an increase in
18 the incremental value within a tax increment financing district.

19 (4) (a) For the purposes of subsection (1), the taxable value of newly taxable property includes the
20 release of taxable value from the incremental taxable value of a tax increment financing district because of:

21 (i) a change in the boundary of a tax increment financing district;

22 (ii) an increase in the base value of the tax increment financing district pursuant to 7-15-4287; or

23 (iii) the termination of a tax increment financing district.

24 (b) If a tax increment financing district terminates prior to the certification of taxable values as required
25 in 15-10-202, the increment value is reported as newly taxable property in the year in which the tax increment
26 financing district terminates. If a tax increment financing district terminates after the certification of taxable values
27 as required in 15-10-202, the increment value is reported as newly taxable property in the following tax year.

28 (c) For the purpose of subsection (3)(a)(ii), the value of newly taxable class four property that was
29 constructed, expanded, or remodeled property since the completion of the last reappraisal cycle is the current
30 year market value of that property less the previous year market value of that property.

1 (d) For the purpose of subsection (3)(a)(iv), the subdivision of real property includes the first sale of real
2 property that results in the property being taxable as class four property under 15-6-134 or as nonqualified
3 agricultural land as described in 15-6-133(1)(c).

4 (5) Subject to subsection (8), subsection (1)(a) does not apply to:

5 (a) school district levies established in Title 20; or

6 (b) a mill levy imposed for a newly created regional resource authority.

7 (6) For purposes of subsection (1)(a), taxes imposed do not include net or gross proceeds taxes received
8 under 15-6-131 and 15-6-132.

9 (7) In determining the maximum number of mills in subsection (1)(a), the governmental entity:

10 (a) may increase the number of mills to account for a decrease in reimbursements; and

11 (b) may not increase the number of mills to account for a loss of tax base because of legislative action
12 that is reimbursed under the provisions of 15-1-121(7).

13 (8) The department shall calculate, on a statewide basis, the number of mills to be imposed for purposes
14 of 15-10-108, 20-9-331, 20-9-333, 20-9-360, and 20-25-439. However, the number of mills calculated by the
15 department may not exceed the mill levy limits established in those sections. The mill calculation must be
16 established in tenths of mills. If the mill levy calculation does not result in an even tenth of a mill, then the
17 calculation must be rounded up to the nearest tenth of a mill.

18 (9) (a) The provisions of subsection (1) do not prevent or restrict:

19 (i) a judgment levy under 2-9-316, 7-6-4015, or 7-7-2202;

20 (ii) a levy to repay taxes paid under protest as provided in 15-1-402;

21 (iii) an emergency levy authorized under 10-3-405, 20-9-168, or 20-15-326;

22 (iv) a levy for the support of a study commission under 7-3-184;

23 (v) a levy for the support of a newly established regional resource authority;

24 (vi) the portion that is the amount in excess of the base contribution of a governmental entity's property
25 tax levy for contributions for group benefits excluded under 2-9-212 or 2-18-703; ~~or~~

26 (vii) a levy for reimbursing a county for costs incurred in transferring property records to an adjoining
27 county under 7-2-2807 upon relocation of a county boundary; or

28 (viii) a levy to pay the amounts authorized in [section 3] to obtain workers' compensation coverage for
29 volunteer firefighters as provided in [section 1].

30 (b) A levy authorized under subsection (9)(a) may not be included in the amount of property taxes

1 actually assessed in a subsequent year.

2 (10) A governmental entity may levy mills for the support of airports as authorized in 67-10-402,
3 67-11-301, or 67-11-302 even though the governmental entity has not imposed a levy for the airport or the airport
4 authority in either of the previous 2 years and the airport or airport authority has not been appropriated operating
5 funds by a county or municipality during that time.

6 (11) The department may adopt rules to implement this section. The rules may include a method for
7 calculating the percentage of change in valuation for purposes of determining the elimination of property, new
8 improvements, or newly taxable property in a governmental unit."

9

10 **Section 11.** Section 39-71-118, MCA, is amended to read:

11 **"39-71-118. Employee, worker, volunteer, volunteer firefighter, and volunteer emergency medical**
12 **technician defined.** (1) As used in this chapter, the term "employee" or "worker" means:

13 (a) each person in this state, including a contractor other than an independent contractor, who is in the
14 service of an employer, as defined by 39-71-117, under any appointment or contract of hire, expressed or implied,
15 oral or written. The terms include aliens and minors, whether lawfully or unlawfully employed, and all of the
16 elected and appointed paid public officers and officers and members of boards of directors of quasi-public or
17 private corporations, except those officers identified in 39-71-401(2), while rendering actual service for the
18 corporations for pay. Casual employees, as defined by 39-71-116, are included as employees if they are not
19 otherwise covered by workers' compensation and if an employer has elected to be bound by the provisions of
20 the compensation law for these casual employments, as provided in 39-71-401(2). Household or domestic
21 employment is excluded.

22 (b) any juvenile who is performing work under authorization of a district court judge in a delinquency
23 prevention or rehabilitation program;

24 (c) a person who is receiving on-the-job vocational rehabilitation training or other on-the-job training
25 under a state or federal vocational training program, whether or not under an appointment or contract of hire with
26 an employer, as defined in 39-71-117, and, except as provided in subsection ~~(9)~~ (7), whether or not receiving
27 payment from a third party. However, this subsection (1)(c) does not apply to students enrolled in vocational
28 training programs, as outlined in this subsection, while they are on the premises of a public school or community
29 college.

30 (d) an aircrew member or other person who is employed as a volunteer under 67-2-105;

1 (e) a person, other than a juvenile as described in subsection (1)(b), who is performing community
2 service for a nonprofit organization or association or for a federal, state, or local government entity under a court
3 order, or an order from a hearings officer as a result of a probation or parole violation, whether or not under
4 appointment or contract of hire with an employer, as defined in 39-71-117, and whether or not receiving payment
5 from a third party. For a person covered by the definition in this subsection (1)(e):

6 (i) compensation benefits must be limited to medical expenses pursuant to 39-71-704 and an impairment
7 award pursuant to 39-71-703 that is based upon the minimum wage established under Title 39, chapter 3, part
8 4, for a full-time employee at the time of the injury; and

9 (ii) premiums must be paid by the employer, as defined in 39-71-117(3), and must be based upon the
10 minimum wage established under Title 39, chapter 3, part 4, for the number of hours of community service
11 required under the order from the court or hearings officer.

12 (f) an inmate working in a federally certified prison industries program authorized under 53-30-132;

13 (g) a volunteer firefighter as described in 7-33-4109 and [section 1] or a person who provides ambulance
14 services under Title 7, chapter 34, part 1;

15 (h) a person placed at a public or private entity's worksite pursuant to 53-4-704. The person is
16 considered an employee for workers' compensation purposes only. The department of public health and human
17 services shall provide workers' compensation coverage for recipients of financial assistance, as defined in
18 53-4-201, or for participants in the food stamp program, as defined in 53-2-902, who are placed at public or
19 private worksites through an endorsement to the department of public health and human services' workers'
20 compensation policy naming the public or private worksite entities as named insureds under the policy. The
21 endorsement may cover only the entity's public assistance participants and may be only for the duration of each
22 participant's training while receiving financial assistance or while participating in the food stamp program under
23 a written agreement between the department of public health and human services and each public or private
24 entity. The department of public health and human services may not provide workers' compensation coverage
25 for individuals who are covered for workers' compensation purposes by another state or federal employment
26 training program. Premiums and benefits must be based upon the wage that a probationary employee is paid for
27 work of a similar nature at the assigned worksite.

28 (i) a member of a religious corporation, religious organization, or religious trust while performing services
29 for the religious corporation, religious organization, or religious trust, as described in 39-71-117(1)(d).

30 (2) The terms defined in subsection (1) do not include a person who is:

1 (a) performing voluntary service at a recreational facility and who receives no compensation for those
2 services other than meals, lodging, or the use of the recreational facilities;

3 (b) performing services as a volunteer, except for a person who is otherwise entitled to coverage under
4 the laws of this state. As used in this subsection (2)(b), "volunteer" means a person who performs services on
5 behalf of an employer, as defined in 39-71-117, but who does not receive wages as defined in 39-71-123.

6 (c) serving as a foster parent, licensed as a foster care provider in accordance with 52-2-621, and
7 providing care without wage compensation to no more than six foster children in the provider's own residence.
8 The person may receive reimbursement for providing room and board, obtaining training, respite care, leisure
9 and recreational activities, and providing for other needs and activities arising in the provision of in-home foster
10 care.

11 (d) performing temporary agricultural work for an employer if the person performing the work is otherwise
12 exempt from the requirement to obtain workers' compensation coverage under 39-71-401(2)(r) with respect to
13 a company that primarily performs agricultural work at a fixed business location or under 39-71-401(2)(d) and is
14 not required to obtain an independent contractor's exemption certificate under 39-71-417 because the person
15 does not regularly perform agricultural work away from the person's own fixed business location. For the
16 purposes of this subsection, the term "agricultural" has the meaning provided in 15-1-101(1)(a).

17 (3) (a) With the approval of the insurer, an employer may elect to include as an employee under the
18 provisions of this chapter any volunteer as defined in subsection (2)(b).

19 (b) ~~A fire district, fire service area, or volunteer fire department formed under Title 7, chapter 33, an~~ An
20 ambulance service not otherwise covered by subsection (1)(g); or a paid or volunteer nontransporting medical
21 unit, as defined in 50-6-302, in service to a town, city, or county may elect to include as an employee under the
22 provisions of this chapter ~~a volunteer firefighter or a volunteer emergency medical technician.~~

23 ~~(4) (a) The term "volunteer emergency medical technician" means a person who has received a~~

5 (j) employment as an official, including a timer, referee, umpire, or judge, at an amateur athletic event;

6 (k) employment of a person performing services as a newspaper carrier or freelance correspondent if
7 the person performing the services or a parent or guardian of the person performing the services in the case of
8 a minor has acknowledged in writing that the person performing the services and the services are not covered.

10 (i) "freelance correspondent" means a person who submits articles or photographs for publication and

30 motor carrier when hired by an individual or entity who meets the definition of a broker or freight forwarder, as
