

My name is Karen Snow from Missoula. I am a volunteer member of the Public Education and Information Committee of the Missoula County DUI Task Force. I am here to support HB 202, not only because of my work on the committee - but because my family is one of hundreds of Montana families who have lost a loved one in a DUI crash. My step-brother Mark Ayers was killed 28 years ago in one such crash.

I believe that drinking and driving is an epidemic in our state - it's our culture. In order to change this societal ill, we must continually educate citizens, train servers in bars not to over-serve and punish citizens who drink and drive, as a few examples.

The work of the DUI Task Forces takes many forms. There are dedicated task force coordinators who do SO much with small budgets; Grants to law enforcement agencies for emphasis patrols; education campaigns in print and on the radio and television; designated driver programs, etc.
