Definition Changes

<p>General Election - means an election that is held for offices that first appear on a primary election ballot, unless the primary is canceled as authorized by law, and that is held on the first Tuesday after the first Monday in November.</p>	<p>"General election" or "regular election" means an election held for the election of public officers throughout the state at times specified by law, including elections for officers of political subdivisions when the time of the election is set on the same date for all similar political subdivisions in the state. For ballot issues required by Article III, section 6, or Article XIV, section 8, of the Montana constitution to be submitted by the legislature to the electors at a general election, "general election" means an election held at the time provided in 13-1-104(1). For ballot issues required by Article XIV, section 9, of the Montana constitution to be submitted as a constitutional initiative at a regular election, regular election means an election held at the time provided in 13-1-104(1)</p>
<p>Primary Election - An election held on the first Tuesday after the first Monday in June to nominate candidates for offices filled at a general election</p>	<p>"Primary" or "primary election" means an election held throughout the state to nominate candidates for public office at times specified by law, including nominations of candidates for offices of political subdivisions when the time for nominations is set on the same date for all similar subdivisions in the state</p>
<p>Regular School Election - means the school trustee election on the first Tuesday after the first Monday in May</p>	<p>"As used in this title, unless the context clearly indicates otherwise, "school election" means any election conducted by a district or community college district for the purpose of electing trustees, for authorizing taxation, for authorizing the issuance of bonds by an elementary district or a high school district, or for accepting or rejecting any proposition that may be presented to the electorate for decision in accordance with the provisions of this title."</p>
<p>Special Election - An election held on a day other than the day specified for primary election, general election, or regular school election</p>	<p><i>Under current law, a special election can be held on a primary or general election day, which is confusing when the election involves special purpose district officers who are not elected through a primary and general election process. Also, a "special purpose district" definition encompasses all types of special districts, and not just those "special districts" as defined 7-11-1002, which relate to certain aspects of governance structure, but does not suffice for the purposes of elections.</i></p>
<p>Special Purpose District - An area with special boundaries created as authorized by law for a specialized and limited purpose.</p>	<p>"Special district" means a unit of local government, other than a city, town, or county, authorized by law to perform a single function or a limited number of functions, including but not limited to water districts, irrigation districts, fire districts, fire service areas, school districts, community college districts, hospital districts, sewer districts, and transportation districts.</p>

Mail Ballot Election - Any election that is conducted under Title 13, chapter 19, by mailing ballots to all active electors.

There was a lot of confusion in this statute because at some points it mentioned 'mail ballot elections' in terms of elections where everyone was mailed a ballot (polling or mail election) and at time referred to it as a date (general or mail election).

Resort Districts	At least three times no earlier than 40 days and no later than 10 days before the election	The notice must be published twice, with at least 6 days separating publications. The first publication must be no more than 30 days prior to the election and the last no less than 3 days prior to the election
County Bonds	At least three times no earlier than 40 days and no later than 10 days before the election <i>(Retains requirements that notice include the amount and purpose of the bond and other details)</i>	Required special notice depending on election: Whether the election is held at the general election, at an election that is conducted by mail ballot, as provided in Title 13, chapter 19, or at a special election that is held in conjunction with a regular or primary election, separate notice of the election must be given
Municipal Bonds	At least three times no earlier than 40 days and no later than 10 days before the election. <i>(Strikes discretionary language about posting notice in each precinct at least 10 days prior to election, which is unnecessary language because nothing would prohibit this.)</i>	Required special notice depending on election
County Sewer and Water Districts (Election on Board member salaries)	At least three times no earlier than 40 days and no later than 10 days before the election (If full election and not at annual meeting)	"Notice of the vote on the proposed monthly salary for the members of the board of directors must be provided to the members of the district"

Other Changes:

- Community College elections will be conducted by the County Clerk as opposed to the College Board at the request of the Community College leaders.
- Petitions for community college regent elections would be filed with the county election administrator as opposed to the regents. Regents will be notified.
- There will be no primary election for municipal officers for the first election after the original incorporation of a municipality. There will be primary elections in following elections.
- Cost of initial community college election would be paid by the university system rather than by elementary school districts within the proposed community college district.
- Conservation districts primary elections are eliminated for the first election of officers.
- If an election is held for a special district that covers multiple counties the election will be administered by the county with more electors as opposed to the county with the largest geographic size.
- Drainage district write-in candidates must file. Votes won't be counted unless a candidate files.
- The certification of names for the ballot would apply to all general elections with respect to candidates that file with the Secretary of State, not just to federal general election candidates.
- The term of office for county superintendents starts at 12:01 a.m. on January 1 following election rather than on the first Monday in January.
- A written plan for mail ballot elections must be submitted for each mail ballot election, rather than just a blanket or general plan.
- Puts in a requirement that political subdivisions and school district shall cooperate if they are having a polling place election on the same day.
- Effective date: November 4, 2015 (date after this year's election day)
