6 A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING FORFEITURE LAWS; REQUIRING A
7 CRIMINAL CONVICTION FOR FORFEITURE OF PROPERTY; REQUIRING NOTICE OF SEIZED PROPERTY;
8 PROVIDING FOR A PRETRIAL HEARING TO DETERMINE THE VALIDITY OF THE SEIZURE; REQUIRING
9 A HEARING UPON CRIMINAL CONVICTION TO DETERMINE WHETHER PROPERTY MUST BE FORFEITED;
10 REQUIRING PROOF BY CLEAR AND CONVINCING EVIDENCE THAT SEIZED PROPERTY WAS USED IN
11 CONNECTION WITH OR CONSTITUTES PROCEEDS FROM THE COMMISSION OF A CRIMINAL OFFENSE;
12 PROVIDING EXCEPTIONS FOR INNOCENT OWNERS AND PERSONS WITH AN OWNERSHIP INTEREST
13 IN SEIZED PROPERTY; APPLYING PRETRIAL HEARING AND INNOCENT OWNER PROVISIONS TO
14 CRIMINAL FORFEITURE LAWS; CLARIFYING FORFEITURE PROCEEDINGS RELATED TO COMMONLY
15 DOMESTICATED HOOFED ANIMALS AND MOTOR VEHICLES FOR DRIVING UNDER THE INFLUENCE OF
16 ALCOHOL OR DRUGS; PROVIDING DEFINITIONS; AMENDING SECTIONS 44-12-101, 44-12-102, 44-12-103,
17 44-12-205, 45-6-328, 45-9-206, AND 61-8-421, MCA; REPEALING SECTIONS 44-12-201, 44-12-202,
18 44-12-203, AND 44-12-204, MCA; AND PROVIDING AN APPLICABILITY DATE AND AN EFFECTIVE DATE."

20 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

21
22 NEW SECTION. **Section 1. Forfeiture of property for commission of criminal offense.** (1) Except
23 for controlled substances as provided in 44-12-104, a court may not order forfeiture of real or personal property
24 of any kind pursuant to this chapter, including money, vehicles and other conveyances, and tangible and
25 intangible personal property, unless:

26 (a) the owner of the property has been convicted of a criminal offense;
27 (b) the criminal offense specifically provides for forfeiture of property upon conviction; and
28 (c) the property has been found by clear and convincing evidence to have been used in connection with
29 or to constitute proceeds from the criminal offense.

30 (2) This section does not prohibit property from being forfeited pursuant to a plea agreement between

1 the prosecutor and the defendant subject to the approval of the court.

2

3 **NEW SECTION. Section 2. Notice of seized property -- itemized receipt -- charging document.**

4 (1) Upon seizure of property, a peace officer shall:

5 (a) provide an itemized receipt of seized property pursuant to 44-12-103; and

6 (b) ~~instruct the clerk of the district court of the county in which the seizure occurred to~~ notify all persons
7 known to have an interest in the property in the same manner as provided in [section 4(2)].

8 (2) Property subject to forfeiture pursuant to 44-12-102 must be identified in the charging document filed
9 by the prosecutor for the criminal offense providing for forfeiture of property upon conviction. The charging
10 document must specify the time and place of the alleged violation, identify the property, and particularly describe
11 the property's use in connection with the criminal offense.

12

13 **NEW SECTION. Section 3. Pretrial hearing.** (1) Following the seizure of property in a proceeding
14 under this chapter, a defendant who has been charged with a criminal offense providing for forfeiture of property
15 upon conviction or a person claiming an interest in the property allegedly used in or derived from the commission
16 of a criminal offense may make a written request for a pretrial hearing to determine the validity of the seizure.

17 (2) The request for a hearing pursuant to this section must be filed with the court in which the criminal
18 proceeding is pending within 15 days of receiving notice of the seized property pursuant to [section 2(1)(b)]. If
19 more than one person receives notice pursuant to [section 2(1)(b)], the 15-day request period for a hearing begins
20 from the date the last notice was received. The court shall hold a hearing on the request as soon as practicable
21 but no later than 30 days after the request is filed.

22 (3) The claimant has the burden of demonstrating a lawful ownership interest or right of possession in
23 the property.

24 (4) At least 10 days prior to a hearing on the request, a statement demonstrating probable cause for the
25 seizure made pursuant to 44-12-103 must be filed with the court and provided to the claimant.

26 (5) The court shall order that the property be returned to the claimant if the court finds that:

27 (a) it is likely the final judgment in the criminal proceeding will result in the state being ordered to return
28 the property;

29 (b) it is not reasonably necessary for the property to be held for investigatory reasons; or

30 (c) the property is the only reasonable means for the claimant to pay the costs of legal representation in

1 the forfeiture or criminal proceeding. The court may order the return of a portion of the total amount of property
 2 seized sufficient to pay the costs of legal representation and may require an accounting of the remaining property.

3 (6) In lieu of ordering the return of the property, the court may order the law enforcement agency to
 4 provide security or other written assurances for satisfaction of any judgment that may be rendered in the forfeiture
 5 proceeding or criminal proceeding, including any damages sustained as a result of retaining the property.

6
 7 **NEW SECTION. Section 4. Forfeiture upon criminal conviction -- hearing.** (1) Upon conviction of
 8 a defendant for a criminal offense providing for forfeiture of property upon conviction and upon notice to all
 9 persons known to have an interest in the property pursuant to subsection (2), the court shall hold a hearing to
 10 determine whether the property must be forfeited pursuant to [section 1] and disposed of as provided in
 11 44-12-205 and 44-12-206 or, in the case of forfeiture for theft of commonly domesticated hooved animals or illegal
 12 branding or altering or obscuring a brand, 45-6-329. Unless the defendant requests separate proceedings, a
 13 proceeding for the criminal offense providing for forfeiture of property must be held in conjunction with a
 14 proceeding for the forfeiture of the property.

15 (2) Pursuant to subsection (1), ~~the clerk of the district court of the county in which the seizure occurred~~
 16 A PEACE OFFICER OR AN OFFICER OF THE AGENCY THAT SEIZED THE PROPERTY shall notify all persons known to have
 17 an interest in the property by one of the following methods:

18 (a) for a person whose address is known, by personal service of a copy of the notice; or

19 (b) for a person whose address is unknown, by publication in one issue of a newspaper of general
 20 circulation in the county where the seizure occurred or, if there is no such newspaper, by publication in one issue
 21 of a newspaper of general circulation in an adjoining county, and by mailing a copy of the notice to the most
 22 recent address of the person having an ownership interest in the property, if any, shown in the records of the
 23 department of justice.

24 (3) To establish that the seized property is subject to forfeiture under this chapter, a peace officer or an
 25 officer of an agency that seizes any property other than controlled substances must establish by clear and
 26 convincing evidence that the property was used in connection with or constitutes proceeds from the commission
 27 of the criminal offense.

28 (4) Seized property shall not be subject to forfeiture if an owner can establish that the owner is an
 29 innocent owner as provided in [section 5].

30 (5) A bona fide security interest is not subject to forfeiture unless the person claiming a security interest

1 had actual knowledge that the property was subject to forfeiture at the time that the property was seized under
 2 this chapter. A person claiming a security interest bears the burden of production and must establish the validity
 3 of the interest by clear and convincing evidence.

4
 5 **NEW SECTION. Section 5. Innocent owner -- ownership interest in property subject to forfeiture.**

6 (1) The property of an innocent owner is not subject to forfeiture under [sections 1 through 4].

7 (2) A property owner or person with an ownership interest in property subject to forfeiture must be
 8 declared an innocent owner if:

9 (a) the property owner or person with an ownership interest in the property can establish a legal right,
 10 title, or interest in the seized property; and

11 (b) the state is unable to prove by clear and convincing evidence that the owner or person with an
 12 ownership interest in the property had actual knowledge of the crime associated with a forfeiture proceeding.

13
 14 **Section 6.** Section 44-12-101, MCA, is amended to read:

15 **"44-12-101. ~~Definition of controlled substance~~ Definitions.** As used in this chapter, the following
 16 definitions apply:

17 (1) "Actual knowledge" means direct and clear awareness of information.

18 (2) "~~controlled~~ "Controlled substance" means any substance designated as a dangerous drug pursuant
 19 to Title 50, chapter 32, parts 1 and 2."

20
 21 **Section 7.** Section 44-12-102, MCA, is amended to read:

22 **"44-12-102. Things subject to forfeiture.** (1) ~~The following are subject to forfeiture~~ A court may order,
 23 as part of the sentence imposed upon conviction, that the following property be forfeited as provided in [sections
 24 1 through 5]:

25 (a) all controlled substances that have been manufactured, distributed, prepared, cultivated,
 26 compounded, processed, or possessed in violation of Title 45, chapter 9;

27 (b) all money, raw materials, products, and equipment of any kind that are used or intended for use in
 28 manufacturing, preparing, cultivating, compounding, processing, delivering, importing, or exporting any controlled
 29 substance in violation of Title 45, chapter 9, except items used or intended for use in connection with quantities
 30 of marijuana in amounts less than 60 grams;

1 (c) except as provided in subsection (2)(d), all property that is used or intended for use as a container
2 for anything enumerated in subsection (1)(a) or (1)(b);

3 (d) except as provided in subsection (2), all conveyances, including aircraft, vehicles, and vessels, that
4 are used or intended for use in any manner to facilitate the commission of a violation of Title 45, chapter 9;

5 (e) all books, records, and research products and materials, including formulas, microfilm, tapes, and
6 data, that are used or intended for use in violation of Title 45, chapter 9;

7 (f) all drug paraphernalia as defined in 45-10-101;

8 (g) everything of value furnished or intended to be furnished in exchange for a controlled substance in
9 violation of Title 45, chapter 9, all proceeds traceable to an exchange, and all money, negotiable instruments, and
10 securities used or intended to be used to facilitate a violation of Title 45, chapter 9;

11 (h) any personal property constituting or derived from proceeds obtained directly or indirectly from a
12 violation of Title 45, chapter 9, that is punishable by more than 5 years in prison; and

13 (i) real property, including any right, title, and interest in any lot or tract of land and any appurtenances
14 or improvements, that is directly used or intended to be used in any manner or part to commit or facilitate the
15 commission of or that is derived from or maintained by the proceeds resulting from a violation of Title 45, chapter
16 9, that is punishable by more than 5 years in prison. An owner's interest in real property is not subject to forfeit
17 by reason of any act or omission unless it is proved that the act or omission was the owner's or was with the
18 owner's actual knowledge, as defined in 44-12-101, or express consent.

19 (2) ~~(a) A conveyance used by a person as a common carrier in the transaction of business as a common
20 carrier is not subject to forfeiture under this section unless it appears that the owner or other person in charge
21 of the conveyance is a consenting party or privy to a violation of Title 45, chapter 9.~~

22 ~~—— (b) A conveyance is not subject to forfeiture under this section because of any act or omission
23 established by the owner of the conveyance to have been committed or omitted without the owner's knowledge
24 or consent.~~

25 ~~—— (c) A forfeiture of a conveyance encumbered by a bona fide security interest is subject to the interest of
26 the secured party if the secured party neither had knowledge of nor consented to any violation of Title 45, chapter
27 9.~~

28 ~~—— (d) A conveyance or container is not subject to forfeiture under this section if it was used or intended for
29 use in transporting less than 60 grams of marijuana, but this exception does not apply to synthetic cannabinoids
30 listed as dangerous drugs in 50-32-222."~~

2 **Section 8.** Section 44-12-103, MCA, is amended to read:

3 **"44-12-103. When property may be seized.** (1) A peace officer who has probable cause to make an
4 arrest for a violation of Title 45, chapter 9, probable cause to believe that a conveyance has been used or is
5 intended to be used to unlawfully transport a controlled substance, or probable cause to believe that a
6 conveyance has been used to keep, deposit, or conceal a controlled substance shall seize the conveyance used
7 or intended to be used or any conveyance in which a controlled substance is unlawfully possessed by an
8 occupant. A peace officer shall:

9 (a) provide an itemized receipt to the person in possession of the property or, if reasonably practicable,
10 leave a receipt in the place where the property was found if no person is present; and

11 (b) immediately deliver a conveyance that the officer seizes to the offices of the officer's law enforcement
12 agency, to be held as evidence until forfeiture is declared or release ordered.

13 (2) All property subject to forfeiture under 44-12-102 may be seized by a peace officer under a search
14 warrant issued by a district court having jurisdiction over the property. Seizure without a warrant may be made
15 if:

16 (a) the seizure is incident to an arrest or a search under a search warrant issued for another purpose
17 or an inspection under an administrative inspection warrant;

18 (b) the property subject to seizure has been the subject of a prior judgment in favor of the state in a
19 criminal proceeding or a forfeiture proceeding based on this chapter;

20 (c) the peace officer has probable cause to believe that the property is directly or indirectly dangerous
21 to health or safety; or

22 (d) the peace officer has probable cause to believe that the property was used or is intended to be used
23 in violation of Title 45, chapter 9, or in violation of Title 45, chapter 10, part 1."

24

25 **Section 9.** Section 44-12-205, MCA, is amended to read:

26 **"44-12-205. Disposition of property following hearing.** (1) ~~If the court finds that the property was not~~
27 ~~used for the purpose charged or that the property listed in 44-12-102(1)(g) was used without the knowledge or~~
28 ~~consent of the owner, it~~ provisions of [section 1] are not established or the property owner is an innocent owner
29 as provided in [section 5], the court shall order that the property be released to the owner of record as of the date
30 of the seizure.

1 (2) If the court finds that the property was used for the purpose charged and that the property listed in
 2 ~~44-12-102(1)(g)~~ was used with the knowledge or consent of the owner provisions of [section 1] are established
 3 and the property owner is not an innocent owner as provided in [section 5], the property must be disposed of as
 4 follows:

5 (a) If proper proof of a claim is presented at the hearing by the holder of a security interest, the court shall
 6 order that the property be released to the holder of the security interest if the amount due to the holder is equal
 7 to or in excess of the value of the property as of the date of seizure because the purpose of this chapter is to
 8 forfeit only the right, title, or interest of the owner. If the amount due the holder of the security interest is less than
 9 the value of the property, the property, if it is sold, must be sold at public auction by the law enforcement agency
 10 that seized the property in the same manner provided by law for the sale of property under execution or the law
 11 enforcement agency may return the property to the holder of the security interest without proceeding with an
 12 auction. The property may not be sold to an officer or employee of the law enforcement agency that seized the
 13 property or to a person related to an officer or employee by blood or marriage.

14 (b) If a claimant does not exist and the confiscating agency wishes to retain the property for its official
 15 use, it may do so. If the property is not to be retained, it must be sold as provided in subsection (2)(a).

16 (c) If a claimant who has presented proper proof of a claim exists and the confiscating agency wishes
 17 to retain the property for its official use, it may do so if it compensates the claimant in the amount of the security
 18 interest outstanding at the time of the seizure.

19 (3) In making a disposition of property under this chapter, the court may take any action to protect the
 20 rights of innocent persons."

22 **Section 10.** Section 45-6-328, MCA, is amended to read:

23 **"45-6-328. Forfeiture for theft of commonly domesticated hoofed animal or illegal branding or**
 24 **altering or obscuring of brand.** (1) The following property is subject to criminal forfeiture under this section:

25 (a) money, raw materials, products, equipment, and other property of any kind that is used or intended
 26 for use in the theft of a commonly domesticated hoofed animal or illegal branding or altering or obscuring a brand
 27 in violation of 45-6-301 or 45-6-327;

28 (b) property used or intended for use as a container for property enumerated in subsection (1)(a);

29 (c) except as provided in subsection (2), a conveyance, including an aircraft, vehicle, or vessel, used
 30 or intended for use to facilitate the theft of a commonly domesticated hoofed animal or illegal branding or altering

1 or obscuring a brand in violation of 45-6-301 or 45-6-327;

2 (d) books, records, research products and materials, formulas, microfilm, tapes, and data used or
3 intended for use in connection with the theft of a commonly domesticated hoofed animal or illegal branding or
4 altering or obscuring a brand in violation of 45-6-301 or 45-6-327;

5 (e) everything of value furnished or intended to be furnished in exchange for a commonly domesticated
6 hoofed animal in violation of 45-6-301 or 45-6-327 and all proceeds traceable to the exchange;

9 (g) personal property constituting or derived from proceeds obtained directly or indirectly from theft of

12 (2) A conveyance is not subject to criminal forfeiture under this section unless the owner or other person
13 in charge of the conveyance knowingly used the conveyance or knowingly consented to its use for the purpose
14 of theft of a commonly domesticated hoofed animal or illegal branding or altering or obscuring a brand in violation
15 of 45-6-301 or 45-6-327.

19 forfeiture if the person knowingly possesses, owns, uses, or attempts to use property that is subject to criminal
20 forfeiture under this section. A person convicted of the offense of use or possession of property subject to criminal
21 forfeiture shall be imprisoned in the state prison for a term not to exceed 10 years. Upon conviction, the property
22 subject to criminal forfeiture is forfeited to the state and must be disposed of in accordance with the provisions
23 of 44-12-205 and 44-12-206.

24 (2) A person charged with an offense pursuant to this section may request a pretrial forfeiture hearing
25 pursuant to [section 3].

25 (7) A bona fide security interest is not subject to forfeiture unless the person claiming a security interest
26 had actual knowledge, as defined in 44-12-101, that the property was subject to forfeiture at the time that the
27 property was seized under this chapter. A person claiming a security interest bears the burden of production and
28 must establish the validity of the interest by clear and convincing evidence.

29 (8) The property of an innocent owner is not subject to forfeiture under this section. A property owner or
30 person with an ownership interest in property subject to forfeiture must be declared an innocent owner if:

1 (a) the property owner or person with an ownership interest in the property can establish a legal right,
 2 title, or interest in the seized property; and

3 (b) the state is unable to prove by clear and convincing evidence that the owner or person with an
 4 ownership interest in the property had actual knowledge, as defined in 44-12-101, of the crime associated with
 5 a forfeiture proceeding."

8 **"61-8-421. Forfeiture procedure.** (1) A motor vehicle forfeited under 61-8-733 must be seized by the
 9 arresting agency within 10 days after the conviction and disposed of as provided in Title 44, chapter 12, part 2.
 10 Except as provided in this section, the provisions of Title 44, chapter 12, part 2, apply to the extent applicable.

11 (2) Forfeiture proceedings under ~~44-12-201(4)~~ [sections 1 through 5] must be instituted by the arresting
 12 agency within 20 days after the seizure of the motor vehicle.

13 ~~(3) For purposes of 44-12-203 and 44-12-204, there is a rebuttable presumption of forfeiture. The owner~~
 14 ~~of the motor vehicle may rebut the presumption by proving a defense under 61-8-733(2) or by proving that the~~
 15 ~~owner was not convicted of a second or subsequent offense under 61-8-401, 61-8-406, or 61-8-411. It is not a~~
 16 ~~defense that the convicted person owns the motor vehicle jointly with another person.~~

17 ~~(4)~~(3) (a) For purposes of 44-12-206, the proceeds of the sale of the motor vehicle must be distributed
 18 first to the holders of security interests who have presented proper proof of their claims, up to the amount of the
 19 interests or the amount received from the sale, whichever is less, and the remainder to the general fund of the
 20 arresting agency.

21 (b) A holder of a security interest may petition the sentencing court for transfer of title to the motor vehicle

10 penalties that were incurred, or proceedings that were begun before [the effective date of this act].
