8	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

10	NEW SECTION. Section 1. Hydrocarbon and geology investigation program purpose
11	grants. (1) The bureau of mines and geology shall establish a hydrocarbon and geology investigation program
12	to determine the existence of oil and gas deposits in the state. The purposes of the program are to determine if
13	new methods of oil and gas production will improve production in existing oil and gas fields and to locate new
14	fields containing oil and gas resources.
15	(2) In prioritizing areas to investigate, the bureau of mines and geology shall first consider counties
16	where there exists historical evidence of oil and gas production, including the counties of Blaine, Carter,
17	Chouteau, Custer, Daniels, Dawson, Fallon, Fergus, Garfield, Glacier, Hill, Liberty, McCone, Musselshell,
18	Petroleum, Phillips, Pondera, Powder River, Prairie, Richland, Roosevelt, Rosebud, Sheridan, Teton, Toole,
19	Treasure, Valley, and Yellowstone.
20	(3) The bureau of mines and geology may start an investigation when it has sufficient funds to
21	conduct an investigation or in other circumstances the bureau determines appropriate.
22	(4) (a) Within 1 year of starting an investigation, the bureau of mines and geology shall present the
23	results of the investigation in the form of maps and text to:
24	(i) the counties included in the investigation;
25	(ii) the economic affairs interim committee; and
26	(iii) the environmental quality council.
27	(b) After the establishment of the program, the bureau of mines and geology shall report to the
28	legislature in accordance with 5-11-210.

1	(5) (a) To fulfill the requirements of subsections (1) and (2), the bureau of mines and geology may
2	provide grants to faculty or students of any institution of higher education in the state in the areas of geology,
3	geohydrology, civil engineering, chemical engineering, mechanical engineering, mining engineering, and
4	petroleum engineering.
5	(b) The bureau of mines and geology shall provide notice of available grants to all institutions of
6	higher education in the state and post notice on its website.
7	(c) Grant recipients pursuant to this subsection (5) shall report progress to the bureau of mines and
8	geology at least twice a year in a manner determined by the bureau.
9	(6) The bureau of mines and geology may accept appropriations, gifts, grants, and reimbursements to
10	be used for the purposes of this section.
11	
12	NEW SECTION. Section 2. Coal ash markets investigation program. (1) The department of
13	commerce shall establish a coal ash markets investigation program to determine the existence of economically
14	viable markets to reuse coal ash.
15	(2) The department may start an investigation when it has sufficient funds to conduct an investigation
16	or in other circumstances the department determines appropriate.
17	(3) (a) Within 1 year of starting an investigation, the bureau of mines and geology shall present the
18	results of the investigation in the form of maps and text to:
19	(i) the economic interim affairs committee; and
20	(ii) the environmental quality council.
