9	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

11	Section 1. Section 23-5-501, MCA, is amended to read:
12	"23-5-501. Definitions. As used in this part, unless the context clearly requires otherwise, the
13	following definitions apply:
14	(1) (a) "Sports pool" means a gambling activity, other than an activity governed under chapter 4 or
15	chapter 5, part 2, of this title, in which a person wagers money for each chance to win money or other items of
16	value based on the outcome of a sports event or series of sports events wherein the competitors in the sports
17	event or series of sports events are natural persons or animals.
18	(b) Unless the context requires otherwise, the term includes a "multiple competitor sports pool" in
19	which three or more competitors simultaneously compete in a sports event or series of sports. The term
20	includes but is not limited to a car race or races, golf or basketball tournaments, or a sports event where
21	competitors are placed into a bracket.
22	(2) "Sports tab" means a folded or banded ticket with a face covered to conceal a combination of two
23	numbers, with each number ranging from zero through nine.
24	(3) "Sports tab game" means a gambling enterprise conducted on a card to which 100 sports tabs are
25	attached that have 100 different combinations for which consideration in money is paid by the person
26	purchasing each tab. A person may purchase a sports tab from the card for the chance to win money or other
27	items of value on a sports event or series of sports events as provided in 23-5-503."

1	Section 2. Section 23-5-512, MCA, is amended to read:
2	"23-5-512. Sports pool design multiple competitor sports pool department rules. (1) (a) A
3	Except as provided in subsection (2), a sports pool must be designed to ensure that:
4	(a)(i) there is at least one winner from among the participants in the pool; and
5	(b)(ii) each participant has an equal chance to win the pool.
6	(2)(b) Competitors in a sports event or series of sports events must be randomly assigned to each
7	participant in the sports pool.
8	(2) (a) A multiple competitor sports pool must be designed to ensure that:
9	(i) there is at least one winner, but there may be categories of winners among the participants in the
10	pool; and
11	(ii) a participant's chance to win the pool may be based on the participant's relative skill in selecting
12	competitors in a sports event or series of sports events.
13	(b) Nothing in subsection (2)(a)(ii) requires competitors in a multiple competitor sports pool to be
14	randomly assigned to a participant in a sports pool.
15	(3) The department shall by rule describe the types of sports pools authorized by this part. Variations
16	in the authorized sports pools must be submitted to the department for review and approval before they are
17	made available for public play. The department may charge a nominal fee to review variations in the authorized
18	sports pools."
