14 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

15  
16 **Section 1.** Section 13-37-113, MCA, is amended to read:

17 **"13-37-113. Hiring of attorneys -- prosecutions.** The commissioner may hire or retain attorneys  
18 who are properly licensed to practice before the supreme court of the state of Montana to prosecute violations  
19 of chapter 35 of this title or this chapter. Any attorney retained or hired shall exercise the powers of a special  
20 attorney general, and the attorney may prosecute, subject to the control and supervision of the commissioner  
21 and the provisions of 13-35-240, 13-37-124, and 13-37-125, any criminal or civil action arising out of a violation  
22 of any provision of chapter 35 of this title or this chapter. All prosecutions must be brought in the state district  
23 court for the county in which a violation has occurred ~~or in the district court for Lewis and Clark County.~~ The  
24 authority to prosecute as prescribed by this section includes the authority to:

25 (1) institute proceedings for the arrest of persons charged with or reasonably suspected of criminal  
26 violations of chapter 35 of this title or this chapter;

27 (2) attend and give advice to a grand jury when cases involving criminal violations of chapter 35 of  
28 this title or this chapter are presented;

- 1 (3) draw and file indictments, informations, and criminal complaints;
- 2 (4) prosecute all actions for the recovery of debts, fines, penalties, or forfeitures accruing to the state
- 3 or county from persons convicted of violating chapter 35 of this title or this chapter; and
- 4 (5) do any other act necessary to successfully prosecute a violation of any provision of chapter 35 of
- 5 this title or this chapter."

7 **Section 2.** Section 15-1-108, MCA, is amended to read:

8 **"15-1-108. Prohibition on sales -- restrictions on certain disclosures and uses.** (1) (a) Subject to

9 subsection (1)(b), a tax return preparer may not sell, receive any consideration for, or otherwise disclose tax

10 return information for the benefit of the tax return preparer or of any persons controlling, controlled by, or under

11 common control of the tax return preparer.

12 (b) The provisions of this section do not prevent the bona fide sale of a tax return preparation,

13 accounting, or law practice in the ordinary course of business.

14 (2) A tax return preparer may not disclose return information to a tax return preparer located outside

15 of the state unless:

16 (a) (i) the taxpayer has requested the disclosure; or

17 (ii) disclosure is required in connection with an internal audit;

18 (b) the tax return preparer located outside of the state agrees:

19 (i) not to sell or receive any consideration for the tax return information; and

20 (ii) not to otherwise disclose the tax return information for its benefit or for the benefit of any person

21 controlling, controlled by, or under common control with it; and

22 (c) the local tax return preparer indemnifies the taxpayer for the damages provided for in subsection

23 (3)(d) for any sale or disclosure by the tax return preparer located outside the state in violation of subsection

24 (2)(b).

25 (3) (a) A person whose tax return information is or will be used or disclosed in violation of subsection

26 (1) or (2) may bring an action to enjoin the violation and for the recovery of damages.

27 (b) An action under this section may be brought in Montana district court in the county where the

28 plaintiff resides or maintains its principal place of business ~~or in the Montana first judicial district.~~

1 (c) If the court finds that the defendant is violating or has violated any of the provisions of subsection  
2 (1) or (2), the court shall enjoin the defendant. It is not necessary to allege or prove actual damages to the  
3 plaintiff.

4 (d) In addition to injunctive relief, the plaintiff is entitled to recover from the defendant in an amount  
5 that is the greater of three times the amount of actual damages sustained by the plaintiff or up to \$10,000.

6 (e) In any action brought under this section, the court may award the prevailing party reasonable  
7 attorney fees incurred in prosecuting or defending the action. A person who brings an action on the person's  
8 own behalf without an attorney may receive equivalent fees at the judge's discretion.

9 (4) A tax return preparer may disclose or use return information:

- 10 (a) for quality or peer reviews;
- 11 (b) when authorized to do so by Montana law;
- 12 (c) when required to do so by federal or state law; or
- 13 (d) pursuant to a court subpoena or administrative summons.

14 (5) As used in this section, the following definitions apply:

15 (a) (i) "Return information" includes a taxpayer's identity, the nature, source, or amount of the  
16 taxpayer's income, payments, receipts, deductions, exemptions, credits, assets, liabilities, net worth, tax  
17 liability, tax withheld, deficiencies, overassessments, or tax payments, or any other data received by, recorded  
18 by, prepared by, furnished to, or collected by the department with respect to a return or with respect to the  
19 determination of the existence or possible existence of liability or the amount of a liability of any person under  
20 this title for any tax, penalty, interest, fine, forfeiture, or other imposition or any offense.

21 (ii) The term does not include data in a form that cannot be associated with or otherwise identify,  
22 directly or indirectly, a particular taxpayer.

23 (b) "Tax return preparer" means:

- 24 (i) any person who:
  - 25 (A) is engaged in the business of preparing tax returns;
  - 26 (B) is engaged in the business of providing services in connection with the preparation of tax returns;
  - 27 (C) prepares or assists in preparing or presents to the public that the person prepares or assists in  
28 preparing a tax return for compensation;

- 1 (D) develops software used to prepare or file tax returns; or
- 2 (E) is an electronic return originator; and
- 3 (ii) an individual who, as a part of that individual's duties or employment with a person described in
- 4 subsection (5)(b)(i), performs services relating to:
  - 5 (A) the preparation or filing of or the provision of services in connection with the preparation or filing of
  - 6 a tax return; or
  - 7 (B) the development of software used to prepare or file tax returns."

8

9 **Section 3.** Section 16-4-411, MCA, is amended to read:

10 **"16-4-411. Appeals concerning alcoholic beverages laws.** (1) Any interested party shall have the

11 right to appeal any decision of the department of revenue concerning the issuance, transfer, suspension, or

12 revocation of alcoholic beverages licenses to the district court in the county in which the issuance, transfer,

13 suspension, or revocation occurred ~~or, at the appellant's option, in the district court of the first judicial district.~~

14 (2) The appeal must be in conformity with the provisions of Title 2, chapter 4, part 7."

15

16 **Section 4.** Section 19-2-401, MCA, is amended to read:

17 **"19-2-401. Location of board -- jurisdiction and venue for judicial review -- quorum -- officers**

18 **and employees.** (1) The board shall maintain its office in the city of Helena. Jurisdiction and venue for judicial

19 review of final administrative decisions of the board are in the judicial district in which the appealing party

20 resides or, if the person resides outside the state, the first judicial district, Lewis and Clark County,~~unless~~

21 ~~otherwise stipulated by the parties.~~

22 (2) A quorum of the board is four members.

23 (3) The board shall elect one of its members presiding officer. The board may appoint a committee of

24 one or more of its members to perform routine acts, such as retirement of members and fixing of retirement

25 benefits, approval of death claims, and correction of records necessary in the administration of the systems in

26 accordance with the provisions of chapters 2, 3, 5 through 9, 13, 17, and 50 of this title and in accordance with

27 the rules of the board. The attorney general is the legal counsel for the board."

1           **Section 5.** Section 19-20-201, MCA, is amended to read:

2           **"19-20-201. Administration by retirement board -- jurisdiction and venue for judicial review. (1)**

3           The retirement board shall administer and operate the retirement system within the limitations prescribed by  
4           this chapter, and it is the duty of the retirement board to:

5           (a) establish rules necessary for the proper administration and operation of the retirement system;

6           (b) approve or disapprove all expenditures necessary for the proper operation of the retirement  
7           system;

8           (c) keep a record of all its proceedings, which must be open to public inspection;

9           (d) submit a report to the office of budget and program planning detailing the fiscal transactions for  
10          the 2 fiscal years immediately preceding the report due date, the amount of the accumulated cash and  
11          securities of the retirement system, and the last fiscal year balance sheet showing the assets and liabilities of  
12          the retirement system;

13          (e) keep in convenient form the data that is necessary for actuarial valuation of the various funds of  
14          the retirement system and for checking the experience of the retirement system;

15          (f) prepare an annual valuation of the assets and liabilities of the retirement system that includes an  
16          analysis of how market performance is affecting the actuarial funding of the retirement system;

17          (g) require the board's actuary to conduct and report on a periodic actuarial investigation into the  
18          actuarial experience of the retirement system;

19          (h) prescribe a form for membership application that will provide adequate and necessary information  
20          for the proper operation of the retirement system;

21          (i) annually determine the rate of regular interest as prescribed in 19-20-501;

22          (j) establish and maintain the funds of the retirement system in accordance with the provisions of part  
23          6 of this chapter; and

24          (k) perform other duties and functions as are required to properly administer and operate the  
25          retirement system.

26          (2) In discharging its duties, the board, or an authorized representative of the board, may conduct  
27          hearings, administer oaths and affirmations, take depositions, certify to official acts and records, and issue  
28          subpoenas to compel the attendance of witnesses and the production of books, papers, correspondence,

1 memoranda, and other records. Subpoenas must be issued and enforced pursuant to 2-4-104.

2 (3) The board may send retirement-related material to employers and the campuses of the Montana  
3 university system for delivery to employees. To facilitate distribution, employers and those campuses shall each  
4 provide the board with a point of contact who is responsible for distribution of the material provided by the  
5 board.

6 (4) The board shall make available to the state administration and veterans' affairs interim committee  
7 and to the legislature pursuant to 5-11-210 copies of the annual actuarial valuation and reports required  
8 pursuant to subsections (1)(d), (1)(f), and (1)(g).

9 (5) Jurisdiction and venue for judicial review of the board's final administrative decisions is the judicial  
10 district in which the appealing party resides or, if the person resides outside the state, the first judicial district,  
11 Lewis and Clark County, unless otherwise stipulated by the parties."

12

13 **Section 6.** Section 22-3-429, MCA, is amended to read:

14 **"22-3-429. Requests for consultation -- public notice -- appeal of findings.** (1) A federal or state  
15 entity that acts upon a proposed federal or state action or an application for a federal, state, or local permit,  
16 license, lease, or funding may request the views of the historic preservation officer concerning:

17 (a) the recommended eligibility for a register listing of any heritage property or paleontological  
18 remains;

19 (b) the effects of a proposed action, activity, or undertaking on heritage property or remains that are  
20 found to be eligible for register listing; and

21 (c) the appropriateness of a proposed plan for the avoidance or mitigation of effects.

22 (2) A request for comment pursuant to 16 U.S.C. 470f may be made simultaneously with a request  
23 pursuant to subsection (1). The historic preservation officer shall respond in writing to a request within 30  
24 calendar days of receiving the request and shall address each property in the request and each topic of the  
25 request. In the event that an agency requests simultaneous consultation for two or more criteria under this  
26 section, the agency and historic preservation officer may extend the 30-day review period by mutual  
27 agreement. If the historic preservation officer fails to comment within that time, that failure is construed as  
28 concurrence with the agency's recommendation. In the event of failure to comment on a specific undertaking,

1 the historic preservation officer may not change a finding for a heritage property at a later date.

2 (3) If the proposed finding is that a heritage property or paleontological remains are involved and that  
3 a proposed activity will have an adverse impact on the property or remains, the proposed finding must address  
4 all properties or remains involved and describe the characteristics that illustrate the qualities that make the  
5 property or remains eligible for inclusion in the register. If the proposed finding includes a conclusion that a  
6 property or remains may be eligible but additional information or study is needed to reach an eligibility finding,  
7 the finding must specify the type and amount of information required in accordance with standards and  
8 guidelines as provided in 22-3-428.

9 (4) At the time that the state or federal agency requests the views of the historic preservation officer  
10 as provided in subsection (1), the agency shall provide notice to the applicant, affected property owners, and  
11 other interested persons of the request for consultation and shall identify locations where the submitted  
12 materials may be reviewed.

13 (5) The applicant and any affected property owners have 20 days in which to appeal the historic  
14 preservation officer's finding to the director. The appeal notice must include a written statement of reasons for  
15 the appeal and any additional supporting information.

16 (6) The director of the historical society shall issue a final finding within 30 days of the expiration of  
17 the 20-day appeal period provided for under subsection (5). The issuance of this finding does not limit the rights  
18 of any applicant or affected property owner to challenge a finding under an existing federal law, regulation, or  
19 regulatory or administrative process.

20 (7) If the applicant or an affected property owner is not satisfied with the finding of the director of the  
21 historical society concerning the eligibility of the property or remains for listing in the register or a finding of  
22 adverse effect to the property, the entity or property owner may appeal the finding to the district court in ~~either~~  
23 ~~Lewis and Clark County~~ or a county in which affected property is located. Appeal may be taken by filing a  
24 petition with the district court citing the decision by the director of the historical society and the evidence upon  
25 which the director relied. On appeal, the district court may consider any documents supporting or not supporting  
26 the finding, the written comments received by the director of the historical society, and any additional evidence  
27 that may be submitted to the court. The district court may substitute its judgment for the judgment of the director  
28 of the historical society as to the weight of the evidence.

1           (8) A state agency may not require a historical or archaeological survey as a condition of applying for  
 2 or receiving a state or local permit, license, lease, or funding for a project to reconstruct or maintain an irrigation  
 3 ditch or appurtenant structures or equipment when the ditch or appurtenant structures or equipment are in use  
 4 or have been in use within the past 10 years, if the reconstruction or maintenance will occur within the existing  
 5 ditch easement and if the project is not on land owned by the state."

6

7           **Section 7.** Section 25-2-126, MCA, is amended to read:

8           "**25-2-126. Against state and political subdivisions.** (1) ~~The~~Except as provided in subsection (2),  
 9 the proper place of trial for an action against the state is in the county in which the claim arose or in Lewis and  
 10 Clark County. In an action against the state brought by a resident of the state, the county of the plaintiff's  
 11 residence is also a proper place of trial.

12           (2) For an action that challenges the issuance, approval, renewal, or denial of a permit, license,  
 13 authorization, or certificate by a state agency, the action must be brought in the county in which the permitted,  
 14 licensed, authorized, or certificated activity would occur. If an activity would occur in more than one county, any  
 15 county in which the activity would occur is a proper place for an action.

16           ~~(2)~~(3) The proper place of trial for an action against a political subdivision is in the county in which the  
 17 claim arose or in any county where the political subdivision is located."

18

19           **Section 8.** Section 30-14-111, MCA, is amended to read:

20           "**30-14-111. Department to restrain unlawful acts.** (1) Whenever the department has reason to  
 21 believe that a person is using, has used, or is about to knowingly use any method, act, or practice declared by  
 22 30-14-103 to be unlawful and that proceeding would be in the public interest, the department may bring an  
 23 action in the name of the state against the person to restrain by temporary or permanent injunction or  
 24 temporary restraining order the use of the unlawful method, act, or practice upon giving appropriate notice to  
 25 that person.

26           (2) The notice must state generally the relief sought and be served in accordance with 30-14-115 at  
 27 least 20 days before the hearing of the action in which the relief sought is a temporary or permanent injunction.  
 28 The notice for a temporary restraining order is governed by 27-19-315.



1 (3) An action under this section may be brought in the district court in the county in which a person  
2 resides or has the person's principal place of business or in the district court of Lewis and Clark County if the  
3 person is not a resident of this state or does not maintain a place of business in this state.

4 (4) A district court is authorized to issue temporary or permanent injunctions or temporary restraining  
5 orders to restrain and prevent violations of this part, and an injunction must be issued without bond."  
6

7 **Section 9.** Section 30-14-1413, MCA, is amended to read:

8 **"30-14-1413. Civil remedies -- venue -- burden of proof.** (1) The sale of any goods or services by  
9 an unregistered seller or telemarketer that is required to register is void. A person obtaining a judgment for  
10 damages, attorney fees, or costs against a seller or telemarketer pursuant to this section has the right to be  
11 reimbursed for those damages, attorney fees, or costs from any bond or security posted by the seller or  
12 telemarketer pursuant to the provisions of 30-14-1404.

13 (2) A person that suffers a loss or harm as a result of an unfair and deceptive act or practice or a  
14 prohibited act or practice is entitled to recover actual damages or \$500, whichever is greater, attorney fees,  
15 court costs, and any other remedies provided by law.

16 (3) In addition to the remedies provided in subsection (2), a person that suffers harm as a result of an  
17 abusive act or practice is entitled to receive injunctive or declaratory relief.

18 (4) (a) The department or a county attorney, on behalf of state residents who have suffered a loss or  
19 harm as a result of a violation of this part, may seek any remedy provided by Title 30, chapter 14, part 1.

20 (b) The proper place for trial for an action based on a claim of a violation of this part is the district  
21 court of ~~Lewis and Clark County~~ or in the county in which the alleged violation occurred.

22 (5) In a civil proceeding alleging a violation of this part, the burden of proving an exemption under 30-  
23 14-1405 or an exception to a definition contained in 30-14-1403 is on the person claiming the exemption or  
24 exception."

26 **Section 10.** Section 31-1-726, MCA, is amended to read:

27 **"31-1-726. Investigations by department -- subpoenas -- oaths -- examination of witnesses and**  
28 **evidence.** (1) The department may investigate any matter, upon complaint or otherwise, if it appears that a

1 person has engaged in or offered to engage in any act or practice that is in violation of any provision of this part  
2 or any rule adopted or order issued by the department pursuant to this part.

3 (2) The department may issue subpoenas to compel the attendance of witnesses and the production  
4 of documents, papers, books, records, and other evidence before it in any matter over which it has jurisdiction,  
5 control, or supervision pertaining to this part. The department may administer oaths and affirmations to a  
6 person whose testimony is required.

7 (3) If a person refuses to obey a subpoena or to give testimony or produce evidence as required by  
8 the subpoena, a judge of the district court ~~of Lewis and Clark County or in~~ the county in which the licensed  
9 premises ~~are located~~ or the person's principal place of business is located or where the person resides may,  
10 upon application and proof of the refusal, issue a subpoena or subpoena duces tecum for the witness to appear  
11 before the department to give testimony and produce evidence as may be required. The clerk of court shall  
12 then issue the subpoena, as directed, under the seal of the court, requiring the person to whom it is directed to  
13 appear at the time and place designated in the subpoena.

14 (4) If a person served with a subpoena refuses to obey the subpoena or to give testimony or produce  
15 evidence as required by the subpoena, the department may proceed under the contempt provisions of Title 3,  
16 chapter 1, part 5.

17 (5) Failure to comply with a court-ordered subpoena is punishable pursuant to 45-7-309."  
18

19 **Section 11.** Section 32-1-912, MCA, is amended to read:

20 **"32-1-912. Enforcement of notices or orders.** The director may apply to the district court of the  
21 county in which the home office of the institution is located or to the district court for Lewis and Clark County if  
22 the institution does not have a home office in this state for the enforcement of any effective and outstanding  
23 notice or order issued under this part. The court has jurisdiction to require compliance therewith."  
24

25 **Section 12.** Section 32-5-402, MCA, is amended to read:

26 **"32-5-402. Investigations by department -- subpoenas -- oaths -- examination of witnesses and**  
27 **evidence.** (1) The department may at any time investigate any transaction with borrowers and may examine  
28 the books, accounts, and records to discover violations of this chapter by:

- 1 (a) a licensee; or
- 2 (b) a person who the department has reason to believe is violating or is about to violate this chapter.

3 (2) The department or the department's authorized representatives must be given free access to the  
4 offices and places of business and files of all licensees. The department may investigate any matter, upon  
5 complaint or otherwise, if it appears that a person has engaged in or offered to engage in any act or practice  
6 that is in violation of any provision of this chapter or any rule adopted or order issued by the department  
7 pursuant to this chapter.

8 (3) The department may issue subpoenas to compel the attendance of witnesses and the production  
9 of documents, papers, books, records, and other evidence before it in any matter over which it has jurisdiction,  
10 control, or supervision pertaining to this chapter. The department may administer oaths and affirmations to a  
11 person whose testimony is required.

12 (4) If a person refuses to obey a subpoena or to give testimony or produce evidence as required by  
13 the subpoena, a judge of the district court of ~~Lewis and Clark County~~ or in the county in which the licensed  
14 premises are located or in the district court of Lewis and Clark County if no licensed premises are maintained in  
15 the state may, upon application and proof of the refusal, issue a subpoena or subpoena duces tecum for the  
16 witness to appear before the department to give testimony and produce evidence as may be required. The clerk  
17 of court shall then issue the subpoena, as directed, under the seal of the court, requiring the person to whom it  
18 is directed to appear at the time and place designated in the subpoena.

19 (5) If a person served with a subpoena refuses to obey the subpoena or to give testimony or produce  
20 evidence as required by the subpoena, the department may proceed under the contempt provisions of Title 3,  
21 chapter 1, part 5.

22 (6) Failure to comply with the requirements of a court-ordered subpoena is punishable pursuant to 45-  
23 7-309."

24

25 **Section 13.** Section 33-1-804, MCA, is amended to read:

26 **"33-1-804. Civil penalty -- civil action for collection of penalty.** (1) A health carrier or a managed  
27 care organization violating 33-1-802 or 33-1-803 is subject to a civil penalty, as provided in 33-1-317, for each  
28 violation. Each day of violation constitutes a separate violation for the purposes of this section.

1           (2) In addition to other enforcement methods provided by law, the commissioner may bring a civil  
 2      action ~~in the district court of the first judicial district~~ in the district court in the county in which the violation  
 3      occurred to collect the civil penalty provided for in subsection (1) from a person violating a provision of this part.  
 4      If the violation occurred in more than one county, any county in which the violation occurred is a proper venue  
 5      for a civil action. An amount collected by the commissioner pursuant to this section must be deposited in the  
 6      general fund."

7

8           **Section 14.** Section 37-1-332, MCA, is amended to read:

9           **"37-1-332. Administrative proceedings to stop unlicensed practice -- board of realty regulation**  
 10      **-- state electrical board -- board of plumbers.** (1) For purposes of this section, the term "board" means the  
 11      board of realty regulation provided for in 2-15-1757, the state electrical board provided for in 2-15-1764, or the  
 12      board of plumbers provided for in 2-15-1765.

13           (2) (a) After investigation under 37-1-317, the board may establish a screening panel to determine if  
 14      there is reasonable cause to believe a person has engaged in or is engaging in any act or practice constituting  
 15      unlicensed practice of a profession or occupation.

16           (b) If reasonable cause is found under subsection (2)(a), the board may initiate a contested case  
 17      proceeding against the person pursuant to the Montana Administrative Procedure Act in Title 2, chapter 4, part  
 18      6.

19           (3) Following a contested case proceeding, the board may apply any of the following sanctions to a  
 20      person found to have engaged in the unlicensed practice of a profession or occupation:

21           (a) impose a civil penalty not to exceed \$1,500 for each violation and not to exceed a total of \$5,000  
 22      for all related violations; and

23           (b) require the person to pay up to \$5,000 for the costs of the administrative proceedings, including  
 24      but not limited to costs allowable under Title 25, chapter 10, but excluding the costs of investigation and the  
 25      board's attorney fees.

26           (4) Judicial review of any contested case under this section must be filed ~~with the first judicial district~~  
 27      ~~or~~ in the district where the violation occurred, pursuant to the Montana Administrative Procedure Act in Title 2,  
 28      chapter 4, part 7.

1 (5) The remedies provided by this section are in addition to all other remedies or actions that may be

**"75-10-715. Liability -- reimbursement and penalties -- proceedings -- defenses and exclusions.**

(1) Except as provided in 70-30-323 and 75-10-742 through 75-10-751, notwithstanding any other provision of law, and subject only to the defenses set forth in subsection (5) and the exclusions set forth in subsection (7), the following persons are jointly and severally liable for a release or threatened release of a hazardous or deleterious substance from a facility:

- (a) a person who owns or operates a facility where a hazardous or deleterious substance was disposed of;
- (b) a person who at the time of disposal of a hazardous or deleterious substance owned or operated a facility where the hazardous or deleterious substance was disposed of;
- (c) a person who generated, possessed, or was otherwise responsible for a hazardous or deleterious substance and who, by contract, agreement, or otherwise, arranged for disposal or treatment of the substance or arranged with a transporter for transport of the substance for disposal or treatment; and
- (d) a person who accepts or has accepted a hazardous or deleterious substance for transport to a disposal or treatment facility.

(2) A person identified in subsection (1) is liable for the following costs:

- (a) all remedial action costs incurred by the state; and
- (b) damages for injury to, destruction of, or loss of natural resources caused by the release or threatened release, including the reasonable technical and legal costs of assessing and enforcing a claim for the injury, destruction, or loss resulting from the release, unless the impaired natural resources were specifically identified as an irreversible and irretrievable commitment of natural resources in an approved final state or federal environmental impact statement or other comparable approved final environmental analysis for a project or facility that was the subject of a governmental permit or license and the project or facility was being operated within the terms of its permit or license.

(3) If the person liable under subsection (1) fails, without sufficient cause, to comply with a department order issued pursuant to 75-10-711(4) or to properly provide remedial action upon notification by the department pursuant to 75-10-711(3), the person may be liable for penalties in an amount not to exceed

1 two times the amount of any costs incurred by the state pursuant to this section.

2 (4) The department may initiate civil proceedings in district court to recover remedial action costs,  
3 natural resource damages, or penalties under subsections (1), (2), and (3). Proceedings to recover costs and  
4 penalties must be conducted in accordance with 75-10-722. Venue for any action to recover costs, damages, or  
5 penalties lies in the county where the release occurred or where the person liable under subsection (1) resides  
6 or has its principal place of business ~~or in the district court of the first judicial district.~~

7 (5) A person has a defense and is not liable under subsections (1), (2), and (3) if the person can  
8 establish by a preponderance of the evidence that:

9 (a) the department failed to provide notice to the person claiming the defense when required by 75-  
10 10-711. Establishment of this defense only prohibits the department from collecting those costs incurred or  
11 encumbered by the department prior to providing notice to the person and does not provide the person a

13 (b) the release did not emanate from any vessel, vehicle, or facility to which the person contributed  
14 any hazardous or deleterious substance or over which the person had any ownership, authority, or control and  
15 was not caused by any action or omission of the person;

16 (c) the release or threatened release occurred solely as a result of:

17 (i) an act or omission of a third party other than either an employee or agent of the person; or

18 (ii) an act or omission of a third party other than one whose act or omission occurs in connection with a  
19 contractual relationship, existing directly or indirectly, with the person, if the person establishes by a  
20 preponderance of the evidence that the person:

21 (A) exercised due care with respect to the hazardous or deleterious substance concerned, taking into  
22 consideration the characteristics of the hazardous or deleterious substance in light of all relevant facts and  
23 circumstances; and

24 (B) took precautions against foreseeable acts or omissions of a third party and the consequences that  
25 could foreseeably result from those acts or omissions;

26 (d) the release or threatened release occurred solely as the result of an act of God or an act of war;

27 (e) the release or threatened release was from a facility for which a permit had been issued by the  
28 department, the hazardous or deleterious substance was specifically identified in the permit, and the release



1 was within the limits allowed in the permit;

2 (f) in the case of assessment of penalties under subsection (3), factors beyond the control of the  
3 person prevented the person from taking timely remedial action; or

4 (g) the person transported only household refuse, unless that person knew or reasonably should have  
5 known that the hazardous or deleterious substance was present in the refuse.

6 (6) (a) For the purpose of subsection (5)(c)(ii), the term "contractual relationship" includes but is not  
7 limited to land contracts, deeds, or other instruments transferring title or possession, unless the real property on  
8 which the facility is located was acquired by the person after the disposal or placement of the hazardous or  
9 deleterious substance on, in, or at the facility and one or more of the following circumstances is also  
10 established by the person by a preponderance of the evidence:

11 (i) At the time the person acquired the facility, the person did not know and had no reason to know  
12 that a hazardous or deleterious substance that is the subject of the release or threatened release was disposed  
13 of on, in, or at the facility.

14 (ii) The person is a governmental entity that acquired the facility by escheat, lien foreclosure, or  
15 through any other involuntary transfer or acquisition or through the exercise of eminent domain authority by  
16 purchase or condemnation pursuant to Title 70, chapter 30.

17 (iii) The person acquired the facility by inheritance or bequest.

18 (b) In addition to establishing one or more of the circumstances in subsection (6)(a)(i) through  
19 (6)(a)(iii), the person shall establish that the person has satisfied the requirements of subsection (5)(c)(i) or  
20 (5)(c)(ii).

21 (c) To establish that the person had no reason to know, as provided in subsection (6)(a)(i), the person  
22 must have undertaken, at the time of acquisition, all appropriate inquiry into the previous ownership and uses of  
23 the property consistent with good commercial or customary practice in an effort to minimize liability. For  
24 purposes of assessing this inquiry, the following must be taken into account:

25 (i) any specialized knowledge or experience on the part of the person;

26 (ii) the relationship of the purchase price to the value of the property if uncontaminated;

27 (iii) commonly known or reasonably ascertainable information about the property;

28 (iv) the obviousness of the presence or the likely presence of contamination on the property; and

1 (v) the ability to detect the contamination by appropriate inspection.

2 (d) (i) Subsections (5)(b) and (5)(c) or this subsection (6) may not diminish the liability of a previous  
3 owner or operator of the facility who would otherwise be liable under this part.

4 (ii) Notwithstanding this subsection (6), if the previous owner or operator obtained actual knowledge of  
5 the release or threatened release of a hazardous or deleterious substance at the facility when the person  
6 owned the real property and then subsequently transferred ownership of the property to another person without  
7 disclosing the knowledge, the previous owner is liable under subsections (1), (2), and (3) and a defense under  
8 subsection (5)(b) or (5)(c) is not available to that person.

9 (e) This subsection (6) does not affect the liability under this part of a person who, by any act or  
10 omission, caused or contributed to the release or threatened release of a hazardous or deleterious substance  
11 that is the subject of the action relating to the facility.

12 (7) A person has an exclusion and is not liable under this section if:

13 (a) the person generated or disposed of only household refuse, unless the person knew or reasonably  
14 should have known that the hazardous or deleterious substance was present in the refuse;

15 (b) the person owns or operates real property where hazardous or deleterious substances have come  
16 to be located solely as a result of subsurface migration in an aquifer from a source or sources outside the  
17 person's property, provided that the following conditions are met:

18 (i) the owner or operator did not cause, contribute to, or exacerbate the release or threatened release  
19 of any hazardous or deleterious substances through any act or omission. The failure to take affirmative steps to  
20 mitigate or address contamination that has migrated from a source outside the owner's or operator's property  
21 does not, in the absence of exceptional circumstances, constitute an omission by the owner or operator.

22 (ii) the person who caused, contributed to, or exacerbated the release or threatened release of any  
23 hazardous or deleterious substance is not and was not an agent or employee of the owner or operator and is  
24 not or was not in a direct or indirect contractual relationship with the owner or operator, unless the department  
25 provides a written determination that an existing or proposed contractual relationship is an insufficient basis to  
26 establish liability under this section;

27 (iii) there is no other basis of liability under subsection (1) for the owner or operator for the release or  
28 threatened release of a hazardous or deleterious substance; and

1 (iv) the owner or operator cooperates with the department and all persons conducting department-  
2 approved remedial actions on the property, including granting access and complying with and implementing all  
3 required institutional controls;

4 (c) the person owns or occupies real property of 20 acres or less for residential purposes, provided  
5 that the following conditions are met:

6 (i) the person did not cause, contribute to, or exacerbate the release or threatened release of any  
7 hazardous or deleterious substance through any act or omission;

8 (ii) the person uses or allows the use of the real property for residential purposes. This exclusion does  
9 not apply to any person who acquires or develops real property for commercial use or any use other than  
10 residential use.

11 (iii) at the time the person purchased or occupied the real property, there were no visible indications of  
12 contamination on the surface of the real property;

13 (iv) the person cooperates with the department and all persons conducting department-approved  
14 remedial actions on the property, including granting access and complying with and implementing all required  
15 institutional controls; and

16 (v) there is no other basis of liability under subsection (1) for the owner or occupier for the release or  
17 threatened release of a hazardous or deleterious substance.

18 (8) A person is liable under this section if the department provides substantial credible evidence that  
19 the person fails to satisfy any element of each exclusion in subsections (7)(a) through (7)(c).

20 (9) The liability of a fiduciary under the provisions of this part for a release or a threatened release of  
21 a hazardous or deleterious substance from a facility held in a fiduciary capacity may not exceed the assets held  
22 in the fiduciary capacity that are available to indemnify the fiduciary unless the fiduciary is liable under this part  
23 independent of the person's ownership or actions taken in a fiduciary capacity.

24 (10) A person who holds indicia of ownership in a facility primarily to protect a security interest is not  
25 liable under subsections (1)(a) and (1)(b) for having participated in the management of a facility within the  
26 meaning of 75-10-701(15)(b) because of any one or any combination of the following:

27 (a) holding an interest in real or personal property when the interest is being held as security for  
28 payment or performance of an obligation, including but not limited to a mortgage, deed of trust, lien, security

1 interest, assignment, pledge, or other right or encumbrance against real or personal property that is furnished  
2 by the owner to ensure repayment of a financial obligation;

3 (b) requiring or conducting financial or environmental assessments of a facility or a portion of a  
4 facility, making financing conditional upon environmental compliance, or providing environmental information or  
5 reports;

6 (c) monitoring the operations conducted at a facility or providing access to a facility to the department  
7 or its agents or to remedial action contractors;

8 (d) having the mere capacity or unexercised right to influence a facility's management of hazardous or  
9 deleterious substances;

10 (e) giving advice, information, guidance, or direction concerning the administrative and financial  
11 aspects, as opposed to day-to-day operational aspects, of a borrower's operations;

12 (f) providing general information concerning federal, state, or local laws governing the transportation,  
13 storage, treatment, and disposal of hazardous or deleterious substances and concerning the hiring of remedial  
14 action contractors;

15 (g) engaging in financial workouts, restructuring, or refinancing of a borrower's obligations;

16 (h) collecting rent, maintaining utility services, securing a facility from unauthorized entry, or  
17 undertaking other activities to protect or preserve the value of the security interest in a facility;

18 (i) extending or denying credit to a person owning or in lawful possession of a facility;

19 (j) in an emergency, requiring or undertaking activities to prevent exposure of persons to hazardous  
20 or deleterious substances or to contain a release;

21 (k) requiring or conducting remedial action in response to a release or threatened release if prior  
22 notice is given to the department and the department approves of the remedial action; or

23 (l) taking title to a facility by foreclosure, provided that the holder of indicia of ownership, from the time  
24 the holder acquires title, undertakes to sell, re-lease property held pursuant to a lease financing transaction  
25 (whether by a new lease financing transaction or substitution of the lessee), or otherwise divest itself of the  
26 property in a reasonably expeditious manner, using whatever commercially reasonable means are relevant or  
27 appropriate with respect to the facility and taking all facts and circumstances into consideration and provided  
28 that the holder does not:

- 1 (i) outbid or refuse a bid for fair consideration for the property or outbid or refuse a bid that would
- 2 effectively compensate the holder for the amount secured by the facility;
- 3 (ii) worsen the contamination at the facility;
- 4 (iii) incur liability under subsection (1)(c) or (1)(d) by arranging for disposal of or transporting
- 5 hazardous or deleterious substances; or
- 6 (iv) engage in conduct described in subsection (11).

7 (11) The protection from liability provided in subsections (9) and (10) is not available to a fiduciary or to  
8 a person holding indicia of ownership primarily to protect a security interest if the fiduciary or person through  
9 affirmative conduct:

- 10 (a) causes or contributes to a release of hazardous or deleterious substances from the facility;
- 11 (b) allows others to cause or contribute to a release of hazardous or deleterious substances; or
- 12 (c) in the case of a person holding indicia of ownership primarily to protect a security interest, actually
- 13 participates in the management of a facility by:
  - 14 (i) exercising decisionmaking control over environmental compliance; or
  - 15 (ii) exercising control at a level comparable to that of a manager of the enterprise with responsibility for
  - 16 day-to-day decisionmaking either with respect to environmental compliance or substantially all of the
  - 17 operational, as opposed to financial or administrative, aspects of the facility."

**"82-4-441. Administrative and judicial penalties -- enforcement.** (1) When the department has reason to believe that a person is in violation of this part, a rule adopted or an order issued under this part, or a term or condition of a permit issued under this part, it shall send a violation letter to the person. The violation letter must describe the provision of the statute, rule, order, or permit alleged to be violated and the facts alleged to constitute the violation. The letter must also recommend corrective actions that are necessary to return to compliance. Issuance of a violation letter under this subsection does not limit the authority of the

1 department under this part to bring a judicial action for penalties or injunctive relief or to initiate an  
2 administrative enforcement action.

3 (2) By issuance of an order pursuant to subsection (5), the department may assess against a person  
4 who violates any of the provisions of this part, rules adopted or orders issued under this part, or provisions of a  
5 permit:

6 (a) an administrative penalty of not less than \$100 or more than \$1,000 for the violation; and

7 (b) an additional administrative penalty of not less than \$100 or more than \$1,000 for each day during  
8 which a violation continues.

9 (3) The department may bring a judicial action seeking a penalty of not more than \$5,000 against a  
10 person who violates any of the provisions of this part, rules adopted or orders issued under this part, or  
11 provisions of a permit and a penalty of not more than \$5,000 for each day that the violation continues. In  
12 determining the amount of the penalty, the district court shall consider the factors in subsection (4).

13 (4) Penalties assessed under this section must be determined in accordance with the penalty factors  
14 in 82-4-1001.

15 (5) (a) In addition to the violation letter sent pursuant to subsection (1), the department may also  
16 issue an order if it has credible information that a violation listed in subsection (2) has occurred. The order must  
17 specify the provision of the part, rule, order, or permit alleged to be violated and the facts alleged to constitute  
18 the violation. The order may require necessary corrective action within a reasonable period of time, may assess  
19 an administrative penalty determined in accordance with this section, or both. The order must be served  
20 personally or by certified mail.

21 (b) An order issued pursuant to subsection (5)(a) becomes final unless, within 30 days after the order  
22 is served, the person to whom the order is issued submits to the board a written request for a hearing stating  
23 the reason for the request. Service of an order by mail is complete 3 business days after mailing. If a request  
24 for a hearing is filed, a hearing must be held within a reasonable time under the contested case provisions of  
25 the Montana Administrative Procedure Act, Title 2, chapter 4, part 6. After a hearing, the board shall affirm,  
26 modify, or rescind the order.

27 (6) The department may bring an action to enjoin an operator or other person violating or threatening  
28 to violate this part, rules adopted pursuant to this part, or a permit issued pursuant to this part. Actions for

1 injunctions or penalties must be filed in the district court of the county in which the opencut operation is located  
2 or, if mutually agreed on by both parties in the action, in the first judicial district, Lewis and Clark County.

3 (7) The provisions of this section do not limit the authority of the department to bring a judicial action  
4 for penalties or injunctive relief prior to or instead of initiating an administrative enforcement action under this  
5 part."

7 **Section 50.** Section 82-15-120, MCA, is amended to read:

8 **"82-15-120. Department of environmental quality to enforce prohibition on methyl tertiary butyl**

9 **ether -- notice requirements -- hearing -- penalties.** (1) (a) Whenever the department of environmental  
10 quality believes that a violation of 82-15-110(8) or of the rules adopted pursuant to 82-15-102(3) has occurred,  
11 it may serve written notice of the violation on the alleged violator or an agent of the alleged violator.

12 (b) The notice must specify the facts alleged to constitute a violation and may include an order  
13 assessing an administrative penalty pursuant to subsection (3), an order to take necessary corrective action  
14 within a reasonable period of time stated in the order, or both.

15 (c) The order becomes final unless, within 30 days after the notice is served, the person named in the  
16 order requests in writing a hearing before the board of environmental review. Service by mail is complete on the  
17 date of mailing.

18 (d) Upon receipt of the request, the board of environmental review shall schedule a hearing. The  
19 contested case provisions of the Montana Administrative Procedure Act provided in Title 2, chapter 4, part 6,  
20 apply to a hearing conducted under this section.

21 (2) If, after a hearing held under subsection (1), the board of environmental review finds that a  
22 violation has occurred, it shall either affirm or modify the order of the department of environmental quality. An  
23 order issued by the department of environmental quality or by the board of environmental review may prescribe  
24 the date by which the violation must cease and may prescribe time limits for a particular action. If, after hearing,  
25 the board of environmental review finds no violation has occurred, it shall rescind the department of  
26 environmental quality's order.

27 (3) A violation of 82-15-110(8) or of a rule adopted pursuant to 82-15-102(3) is subject to an  
28 administrative penalty of up to \$1,000. Each day of violation constitutes a separate violation.

1 (4) Any person who violates 82-15-110(8), a rule adopted pursuant to 82-15-102(3), or an order  
2 issued under this section is subject to a civil penalty not to exceed \$5,000 for each violation. Each day of  
3 violation constitutes a separate violation.

4 (5) The department of environmental quality is authorized to commence a civil action seeking  
5 appropriate relief, including temporary and permanent injunctions and penalties under subsection (4) of this  
6 section, for a violation of 82-15-110(8), a rule adopted pursuant to 82-15-102(3), or a violation of an order  
7 issued under this section. The action must be brought in the district court of the first judicial district, Lewis and  
8 Clark County, or in the district court of the county in which the violation occurred."

10 **Section 51.** Section 85-2-431, MCA, is amended to read:

11 **"85-2-431. Penalty.** (1) A person who fails to comply with the requirements of 85-2-424 is liable for a  
12 civil penalty of not more than \$75.

13 (2) An action to recover the penalty must be brought by the department and filed in the district court  
14 for the first judicial district. ~~At the discretion of the department, the judgment may be certified to the district court~~  
15 in the county where the real property is located.

16 (3) Any penalty fee collected under this section must be deposited in the water right appropriation  
17 account provided for in 85-2-318."

19 **Section 52.** Section 85-6-109, MCA, is amended to read:

20 **"85-6-109. Operation of projects with water users' association -- definitions.** (1) As used in this  
21 section, the following definitions apply:

22 (a) "Association" means a water users' association.

23 (b) "Department" means the department of natural resources and conservation provided for in Title 2,  
24 chapter 15, part 33.

25 (2) Whenever the department proposes a program of maintenance, repair, operation, or alteration of a  
26 project in excess of \$25,000, the cost of which will be borne by an association pursuant to the terms of a water  
27 marketing contract, the association must be informed of the program and given an opportunity to comment. The  
28 department shall notify the association of its decision. If the association believes the program to be

1 unnecessary or excessive in cost, it may appeal the department decision to the district court in any county  
2 where all or part of the project works is located ~~or to the district court in Lewis and Clark County.~~

3 (3) If an appeal is filed under subsection (2), the court shall hold a trial de novo on the question of  
4 necessity of the department program and the question of excessive costs. If the association prevails, the court  
5 may award costs to the association. The court may specify an acceptable program of maintenance, repair,  
6 operation, or alteration or may order the department and the association to develop a program, subject to court  
7 approval.

8 (4) Whenever a program of maintenance, repair, operation, or alteration is proposed, the department  
9 shall assist the association in attempting to secure sources of financing, including federal funds.

10 (5) Whenever the department proposes to abandon, sell, or otherwise dispose of a project that  
11 involves a water users' association, the department shall notify the association. Before the department may  
12 take further action to abandon, sell, or otherwise dispose of a project that involves a water users' association,  
13 the department must receive a petition approving the abandonment, sale, or disposition. The petition must be  
14 signed by stockholders of the association who represent 66 2/3% or more of the issued and outstanding stock  
15 of the association. If, within 30 days of receipt of the final proposal of abandonment, sale, or other disposal,  
16 stockholders of the association who represent 30% or more of the issued and outstanding stock of the  
17 association file a petition of protest with the department, the project may not be abandoned, sold, or otherwise  
18 disposed of without the consent of the legislature."
