15 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

17 **Section 1.** Section 15-30-2618, MCA, is amended to read:

18 **"15-30-2618. (Temporary) Confidentiality of tax records.** (1) Except as provided in 5-12-303, 15-1-  
19 106, 17-7-111, and subsections (7) through (9) of this section, in accordance with a proper judicial order, or as  
20 otherwise provided by law, it is unlawful to divulge or make known in any manner:

21 (a) the amount of income or any particulars set forth or disclosed in any individual report or individual  
22 return required under this chapter or any other information secured in the administration of this chapter; or

23 (b) any federal return or federal return information disclosed on any return or report required by rule of  
24 the department or under this chapter.

25 (2) (a) The officers charged with the custody of the reports and returns may not be required to  
26 produce them or evidence of anything contained in them in an action or proceeding in a court, except in an  
27 action or proceeding:

28 (i) to which the department is a party under the provisions of this chapter or any other taxing act; or

1 (ii) on behalf of a party to any action or proceedings under the provisions of this chapter or other taxes  
2 when the reports or facts shown by the reports are directly involved in the action or proceedings.

3 (b) The court may require the production of and may admit in evidence only as much of the reports or  
4 of the facts shown by the reports as are pertinent to the action or proceedings.

5 (3) This section does not prohibit:

6 (a) the delivery to a taxpayer or the taxpayer's authorized representative of a certified copy of any  
7 return or report filed in connection with the taxpayer's tax;

8 (b) the publication of statistics classified to prevent the identification of particular reports or returns  
9 and the items of particular reports or returns; or

10 (c) the inspection by the attorney general or other legal representative of the state of the report or  
11 return of any taxpayer who brings an action to set aside or review the tax based on the report or return or  
12 against whom an action or proceeding has been instituted in accordance with the provisions of 15-30-2630.

13 (4) The department may deliver to a taxpayer's spouse the taxpayer's return or information related to  
14 the return for a tax year if the spouse and the taxpayer filed the return with the filing status of married filing  
15 separately on the same return. The information being provided to the spouse or reported on the return,  
16 including subsequent adjustments or amendments to the return, must be treated in the same manner as if the  
17 spouse and the taxpayer filed the return using a joint filing status for that tax year.

18 (5) Reports and returns must be preserved for at least 3 years and may be preserved until the  
19 department orders them to be destroyed.

20 (6) Any offense against subsections (1) through (5) is punishable by a fine not exceeding \$500. If the  
21 offender is an officer or employee of the state, the offender must be dismissed from office or employment and  
22 may not hold any public office or public employment in this state for a period of 1 year after dismissal or, in the  
23 case of a former officer or employee, for 1 year after conviction.

24 (7) This section may not be construed to prohibit the department from providing taxpayer return  
25 information and information from employers' payroll withholding reports to:

26 (a) the department of labor and industry to be used for the purpose of investigation and prevention of  
27 noncompliance, tax evasion, fraud, and abuse under the unemployment insurance laws;

28 (b) the state fund to be used for the purpose of investigation and prevention of noncompliance, fraud,

1 and abuse under the workers' compensation program; or

2 (c) the department of public health and human services to verify, ~~as required under 53-6-133,~~ the  
3 income reported by applicants for medical assistance under the children's health insurance program provided  
4 for in Title 53, chapter 4, part 10, and the medicaid program provided for in Title 53, chapter 6, part 1.

5 (8) The department may permit the commissioner of internal revenue of the United States or the  
6 proper officer of any state imposing a tax on the incomes of individuals or the authorized representative of  
7 either officer to inspect the return of income of any individual or may furnish to the officer or an authorized  
8 representative an abstract of the return of income of any individual or supply the officer with information  
9 concerning an item of income contained in a return or disclosed by the report of an investigation of the income  
10 or return of income of an individual, but the permission may be granted or information furnished only if the  
11 statutes of the United States or of the other state grant substantially similar privileges to the proper officer of  
12 this state charged with the administration of this chapter.

13 (9) On written request to the director or a designee of the director, the department shall furnish:

14 (a) to the department of justice all information necessary to identify those persons qualifying for the  
15 additional exemption for blindness pursuant to 15-30-2114(4), for the purpose of enabling the department of  
16 justice to administer the provisions of 61-5-105;

17 (b) to the department of public health and human services information acquired under 15-30-2616,  
18 pertaining to an applicant for public assistance, reasonably necessary for the prevention and detection of public  
19 assistance fraud and abuse, provided notice to the applicant has been given;

20 (c) to the department of labor and industry:

21 (i) for the purpose of prevention and detection of fraud and abuse in and eligibility for benefits under  
22 the unemployment compensation and workers' compensation programs, information on whether a taxpayer  
23 who is the subject of an ongoing investigation by the department of labor and industry is an employee, an  
24 independent contractor, or self-employed; and

25 (ii) for the purpose of administering the apprenticeship tax credit provided for in 39-6-109, employer  
26 and apprentice information necessary to implement 15-30-2357, 15-31-173, and 39-6-109;

27 (d) to the department of fish, wildlife, and parks specific information that is available from income tax  
28 returns and required under 87-2-102 to establish the residency requirements of an applicant for hunting and

1 fishing licenses;

2 (e) to the board of regents information required under 20-26-1111;

3 (f) to the legislative fiscal analyst and the office of budget and program planning individual income tax  
4 information as provided in 5-12-303, 15-1-106, and 17-7-111. The information provided to the office of budget  
5 and program planning must be the same as the information provided to the legislative fiscal analyst.

6 (g) to the department of transportation farm income information based on the most recent income tax  
7 return filed by an applicant applying for a refund under 15-70-430, provided that notice to the applicant has  
8 been given as provided in 15-70-430. The information obtained by the department of transportation is subject to  
9 the same restrictions on disclosure as are individual income tax returns.

10 (h) to the department of commerce tax information about a taxpayer whose debt is assigned to the  
11 department of revenue for offset or collection pursuant to the terms of Title 17, chapter 4, part 1. The  
12 information provided to the department of commerce must be used for the purposes of preventing and detecting  
13 fraud or abuse and determining eligibility for grants or loans.

14 **Section 2.** Section 15-31-511, MCA, is amended to read:

15 **"15-31-511. Confidentiality of tax records.** (1) Except as provided in this section, in accordance with  
16 a proper judicial order, or as otherwise provided by law, it is unlawful to divulge or make known in any manner:

17 (a) the amount of income or any particulars set forth or disclosed in any return or report required  
18 under this chapter or any other information relating to taxation secured in the administration of this chapter; or

19 (b) any federal return or information in or disclosed on a federal return or report required by law or  
20 rule of the department under this chapter.

21 (2) (a) An officer or employee charged with custody of returns and reports required by this chapter  
22 may not be ordered to produce any of them or evidence of anything contained in them in any administrative  
23 proceeding or action or proceeding in any court, except:

24 (i) in an action or proceeding in which the department is a party under the provisions of this chapter;  
25 or

26 (ii) in any other tax proceeding or on behalf of a party to an action or proceeding under the provisions  
27 of this chapter when the returns or reports or facts shown in them are directly pertinent to the action or  
28 proceeding.

1 (b) If the production of a return, report, or information contained in them is ordered, the court shall  
2 limit production of and the admission of returns, reports, or facts shown in them to the matters directly pertinent  
3 to the action or proceeding.

4 (3) This section does not prohibit:

5 (a) the delivery of a certified copy of any return or report filed in connection with a return to the  
6 taxpayer who filed the return or report or to the taxpayer's authorized representative;

7 (b) the publication of statistics prepared in a manner that prevents the identification of particular  
8 returns, reports, or items from returns or reports;

9 (c) the inspection of returns and reports by the attorney general or other legal representative of the  
10 state in the course of an administrative proceeding or litigation under this chapter;

11 (d) access to information under subsection (4);

12 (e) the director of revenue from permitting a representative of the commissioner of internal revenue of  
13 the United States or a representative of a proper officer of any state imposing a tax on the income of a taxpayer  
14 to inspect the returns or reports of a corporation. The department may also furnish those persons abstracts of  
15 income, returns, and reports; information concerning any item in a return or report; and any item disclosed by  
16 an investigation of the income or return of a corporation. The director of revenue may not furnish that  
17 information to a person representing the United States or another state unless the United States or the other  
18 state grants substantially similar privileges to an officer of this state charged with the administration of this  
19 chapter.

20 (4) On written request to the director or a designee of the director, the department shall:

21 (a) allow the inspection of returns and reports by the legislative auditor, but the information furnished  
22 to the legislative auditor is subject to the same restrictions on disclosure outside that office as provided in  
23 subsection (1);

24 (b) provide corporate income tax and alternative corporate income tax information, including any  
25 information that may be required under Title 15, chapter 30, part 33, to the legislative fiscal analyst, as provided  
26 in 5-12-303 or 15-1-106, and the office of budget and program planning, as provided in 15-1-106 or 17-7-111.  
27 The information furnished to the legislative fiscal analyst and the office of budget and program planning is  
28 subject to the same restrictions on disclosure outside those offices as provided in subsection (1).

19 **Section 3.** Section 53-2-215, MCA, is amended to read:

20 **"53-2-215. Social Security Act section 1115 waiver.** (1) The department may pursue approval from  
 21 the U.S. department of health and human services for implementation in Montana of a health insurance  
 22 flexibility and accountability demonstration initiative and other demonstration projects through section 1115  
 23 waivers, within the limitations established in this section.

24 (2) The department may implement a demonstration project upon approval of a section 1115 waiver  
 25 by the U.S. department of health and human services. The department may:

26 (a) coordinate a demonstration project with a program approved through a section 1915 waiver; or

27 (b) terminate and subsume in a new section 1115 waiver an existing managed care or access  
 28 program approved through a section 1915(b) waiver, an optional state plan medicaid service authorized under

1 53-6-101, an optional state plan eligibility group authorized under 53-6-131, or an existing program approved by  
2 a section 1115 waiver that is administered by the department.

3 (3) The department may initiate and administer section 1115 waivers to more efficiently apply  
4 available state general fund money, other available state and local public and private funding, and federal  
5 money to the development and maintenance of medicaid-funded programs of health services and of other  
6 public assistance services and to structure those programs or services for more efficient and effective delivery  
7 to specific populations.

8 (4) (a) In establishing programs or services in a demonstration project approved through a section  
9 1115 waiver, the department shall administer the expenditures under each demonstration project within the  
10 state spending authority that is available for that demonstration project. The department may limit enrollments  
11 in each program within a demonstration project, reduce the per capita expenditures available to enrollees, and  
12 modify and reduce the types and amounts of services available through each program when the department  
13 determines that expenditures can be reasonably expected to exceed the available state spending authority.

14 (b) The department shall develop a contingency plan if there is a spending cap as a condition of the  
15 waiver and the spending cap is exceeded. The contingency plan must address the effects on new programs,  
16 services, or eligibility groups.

17 (5) The department may coordinate the state children's health insurance program authorized under  
18 Title 53, chapter 4, part 10, with a section 1115 waiver for the purpose of increasing the state funding match  
19 available under the waiver and expanding the number of participants in the state children's health insurance  
20 program.

21 (6) The department, subject to the terms and conditions of the section 1115 waiver:

22 (a) shall establish the eligibility groups based upon the funding principles stated in 53-6-101(2);

23 (b) may provide medicaid coverage for one or more optional medicaid eligibility groups;

24 (c) may provide medicaid coverage for one or more specific populations of persons who are not within  
25 the federally authorized medicaid eligibility groups but who are within the requirements of subsection ~~(7)~~(8);

26 (d) may establish the service coverage, eligibility requirements, financial participation requirements,  
27 and other features for the administration and delivery of services to each section 1115 waiver eligibility group;

28 (e) shall set limits on the number of participants for each section 1115 waiver eligibility group;

1 (f) shall set limits on the total expenditures under each demonstration project; and

2 (g) shall set the limits on the total expenditures on the services to be provided to each section 1115  
3 waiver eligibility group.

4 (7) The department may not implement 12-month continuous eligibility through a section 1115 waiver  
5 for individuals who are eligible for medical assistance pursuant to 42 U.S.C. 1396a(a)(10)(A)(i)(VIII).

6 ~~(7)~~(8) The categories of persons that the department may consider for establishment as a section  
7 1115 waiver eligibility group include but are not limited to:

8 (a) low-income parents of children who are eligible to participate in medicaid under 53-6-131 or in the  
9 state children's health insurance program authorized under Title 53, chapter 4, part 10;

10 (b) children who because of limits on enrollment may not be covered through the state children's  
11 health insurance program authorized under Title 53, chapter 4, part 10;

12 (c) children who are eligible to participate in the state children's health insurance program authorized  
13 under Title 53, chapter 4, part 10; and

14 (d) other specific groups of persons who are participants in programs or services funded solely or  
15 primarily through state general funds or who the department determines are in need of specific types of health  
16 care and related services, such as prescription drugs, reproductive health care, and mental health services, and  
17 are without adequate financial means to procure health insurance coverage of those needs.

18 ~~(8)~~(9) Children participating in a section 1115 waiver eligibility group or children who would be eligible  
19 to participate in the state children's health insurance program are subject to the eligibility criteria applicable  
20 under 53-4-1004, except as provided in subsection ~~(9)~~ (10) of this section, for participation in the state  
21 children's health insurance program and must receive benefits as provided through the state children's health  
22 insurance program under 53-4-1005.

23 ~~(9)~~(10) (a) Except as provided in this subsection ~~(9)~~ (10), the eligibility for the section 1115 waiver  
24 eligibility groups may not exceed 150% of the federal poverty level.

25 (b) The department may establish eligibility at greater than 150% but no more than 200% of the  
26 federal poverty level for any of the following groups established for purposes of a section 1115 waiver:

27 (i) participants in the state children's health insurance program;

28 (ii) participants in a group that may be covered under the state children's health insurance program;

1 (iii) participants in a family planning program;

2 (iv) participants in a group composed of persons previously served through a program funded with  
3 state general fund money and other nonmedicaid money; or

4 (v) participants in a group composed of persons with a significant need for particular services that are  
5 not readily available to that population through insurance products or because of personal financial limitations.

6 (c) In establishing the eligibility criteria based upon federal poverty levels, the department shall select  
7 levels to ensure that the resulting expenditures will remain within the available funding and will conform with the  
8 terms and conditions of approval by the U.S. department of health and human services.

9 (d) The department may adopt additional programmatic and financial eligibility criteria for a section  
10 1115 waiver eligibility group in order to appropriately define the subject population, to limit use for fiscal and  
11 programmatic purposes, to prevent improper use, and to conform the administration of the program with the  
12 terms and conditions of the section 1115 waiver.

13 (e) Eligibility criteria applicable to a section 1115 waiver eligibility group need not conform to the  
14 criteria applicable to another section 1115 waiver eligibility group or to a medicaid eligibility group that is not  
15 encompassed within the demonstration project.

- 19 (4) Medical assistance provided by the Montana medicaid program may, as provided by department

  - 23 (b) home health care services;
  - 24 (c) private-duty nursing services;

- 12 1396d(h), in a residential treatment facility, as defined in 50-5-101, that is licensed in accordance with 50-5-201;
- 13 (q) services of behavioral health peer support specialists certified under Title 37, chapter 38, provided
- 14 to adults 18 years of age and older with a diagnosis of a mental disorder, as defined in 53-21-102; and
- 15 (r) any additional medical service or aid allowable under or provided by the federal Social Security
- 16 Act.
- 17 (5) Services for persons qualifying for medicaid under the medically needy category of assistance, as
- 18 described in 53-6-131, may be more limited in amount, scope, and duration than services provided to others
- 19 qualifying for assistance under the Montana medicaid program. The department is not required to provide all of
- 20 the services listed in subsections (3) and (4) to persons qualifying for medicaid under the medically needy

13 (a) the date or dates on which waiver approval is received or denied; and

14 (b) if waiver approval is received, the dates on which the various provisions of [this act] are  
15 implemented.

17 **Section 16.** Section 48, Chapter 415, Laws of 2019, is amended to read:

18 **"Section 48. Termination -- contingency -- intent.** (1) Except as provided in subsection (4) if, if a  
19 court of final disposition finds that the community engagement requirements provided for in [section 1] are  
20 invalid, [this act] terminates June 30, 2025.

21 (2) It is the intent of the legislature that if the contingency provided for in subsection (1) occurs, the  
22 legislature has an opportunity to consider issues of program integrity, reform, and cost-effectiveness to  
23 determine whether [this act] should continue.

24 (3) [Sections 19 and 20] regarding supplemental transfers terminate June 30, 2021.

25 (4) [Sections 8 and 10] do not terminate.
