4 A JOINT RESOLUTION OF THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE STATE OF  
5 MONTANA REQUESTING AN INTERIM STUDY OF THE CHILDREN'S MENTAL HEALTH SYSTEM; AND  
6 REQUIRING THAT THE FINAL RESULTS OF THE STUDY BE REPORTED TO THE 68TH LEGISLATURE.

8 WHEREAS, in 2009, the Montana Legislature enacted a requirement that the Department of Public  
9 Health and Human Services report to the Legislature about the number of Montana children who are placed out  
10 of state for mental health treatment and the reasons for those out-of-state placements; and

11 WHEREAS, since reporting began, significant numbers of children have been sent to service providers  
12 in other states, including children who are involved in the child protective services system and the juvenile  
13 justice system; and

14 WHEREAS, Montana's publicly funded children's mental health system experienced system-altering  
15 cutbacks in Fiscal Year 2018 after Fiscal Year 2017 state revenue came in below anticipated levels, triggering a  
16 range of cuts to mental health services and other programs; and

17 WHEREAS, all stakeholders have a strong interest in diverting children in need of intensive mental  
18 health services from out-of-state placements if the services are available or can be reasonably made available  
19 in Montana; and

20 WHEREAS, there may be gaps in Montana's service system for children, leading to at least some of  
21 the out-of-state placements that occur each year.

23 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF  
24 THE STATE OF MONTANA:

25 That the Legislative Council be requested to designate an appropriate interim committee or statutory  
26 committee, pursuant to section 5-5-217, MCA, to undertake a comprehensive review of the elements of  
27 Montana's mental health system for children to determine:

- 28 (1) how children become involved in the mental health system, including children who are involved

1 with the child protective or juvenile justice systems, and the reasons some of the children are placed in  
2 psychiatric or other facilities that are located outside of Montana;

3 (2) whether gaps exist in Montana's service system that cause children to be sent to out-of-state  
4 services;

5 (3) the prevention systems that exist in Montana for children to avoid placement in psychiatric  
6 facilities either in Montana or outside of Montana; and

7 (4) the steps that the Legislature or executive branch could take to improve the system of children's  
8 mental health services in this state to avoid psychiatric institutional placements for children and meet their  
9 needs in less-restrictive settings.

10 BE IT FURTHER RESOLVED, that the study include input from appropriate stakeholders.

11 BE IT FURTHER RESOLVED, that all aspects of the study, including presentation and review  
12 requirements, be concluded prior to September 15, 2022.

13 BE IT FURTHER RESOLVED, that the final results of the study, including any findings, conclusions,  
14 comments, or recommendations of the appropriate committee, be reported to the 68th Legislature.
