13	unless:
14	(a) the patient or a person authorized to make health care decisions for the patient has provided
15	specific informed consent to the examination;
16	(b) the examination is within the scope of care for a procedure or diagnostic examination scheduled to
17	be performed on the patient; or
18	(c) an emergency exists, it is impracticable to obtain consent, and the examination is necessary for
19	diagnostic or treatment purposes.
20	(2) Violation of subsection (1) constitutes unprofessional conduct.
21	
22	NEW SECTION. Section 2. Performance of sensitive medical examinations informed consent
23	required. (1) An advanced practice registered nurse licensed under this chapter may not knowingly perform or
24	supervise the performance of a breast, pelvic, urogenital, prostate, or rectal examination on a patient who is
25	anesthetized or unconscious unless:
26	(a) the patient or a person authorized to make health care decisions for the patient has provided
27	specific informed consent to the examination;
28	(b) the examination is within the scope of care for a procedure or diagnostic examination scheduled to

2	(c) an emergency exists, it is impracticable to obtain consent, and the examination is necessary for

6	NEW SECTION. Section 3. Codification instruction. (1) [Section 1] is intended to be codified as an
7	integral part of Title 37, chapter 3, part 3, and the provisions of Title 37, chapter 3, part 3, apply to [section 1].
8	(2) [Section 2] is intended to be codified as an integral part of Title 37, chapter 8, part 4, and the
9	provisions of Title 37, chapter 8, part 4, apply to [section 2].
