15	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:
16	
17	Section 1. Section 37-25-101, MCA, is amended to read:
18	"37-25-101. Legislative finding and purpose. The legislature finds and declares that the practice of
19	dietetics and nutrition assessment and counseling and the provision of medical nutrition therapy affects the
20	public health, safety, and welfare. It is the purpose of this chapter to provide for the licensing and regulation of
21	dietitian nutritionists and nutrition specialists in order-to protect the public health, safety, and welfare, to ensure
22	that nutritional services of high quality are available to the people of Montana, and to provide a means of
23	identifying those qualified to practice dietetics and nutrition and provide medical nutrition therapy."
24	
25	Section 2. Section 37-25-102, MCA, is amended to read:
26	"37-25-102. Definitions. In this chapter, unless the context requires otherwise, the following
27	definitions apply:
28	(1) "Accredited" means accredited through the council on postsecondary accreditation and the U.S.



1	department of education.
2	(2) "Board" means the board of medical examiners.
3	(3) <u>"Board for certification of nutrition specialists" means the entity that serves as the credentialing</u>
4	agency for certified nutrition specialists.
5	(4) "Certified nutrition specialist" means an individual certified as a nutrition specialist by the board for
6	certification of nutrition specialists that authorizes the individual to use the title "certified nutrition specialist" and
7	the abbreviation "CNS" to indicate the individual is a certified nutrition specialist.
8	(5) "Commission on dietetic registration" "Commission" means the commission on dietetic registration,
9	which is a member of the national commission for health certifying agencies credentialing agency of the
10	academy of nutrition and dietetics.
11	(4)(6) "Dietetic-nutrition practice" or "dietetics-nutrition" is the integration and application of principles
12	derived from the sciences of nutrition, biochemistry, physiology, and food management and from the behavioral
13	and social sciences to achieve and maintain health. The primary function of dietetic-nutrition practice is to
14	provide nutrition assessment and nutrition counseling. "Dietetics" means the integration, application, and
15	communication of practice principles derived from the food, nutrition, social, business, and basic sciences to
16	achieve and maintain the optimal nutrition status for an individual.
17	(7) "Dietitian" or "dietitian nutritionist" means an individual licensed as a licensed dietitian nutritionist
18	pursuant to 37-25-302 who may be referred to or refer to themselves as a nutritionist, dietitian nutritionist, or
19	dietitian.
20	(8) "Evidence-based standard" means the conscientious, explicit, and judicious use of the current
21	best evidence based on the overall systematic review of the research in making decisions about the care of
22	individual patients.
23	(5)(9) "General nonmedical nutritional information" means information on:
24	(a) principles of good nutrition human nutrition and food preparation;
25	(b) foods to be included in a daily diet;
26	(c)(b) the essential nutrients needed by the human body;
27	(d) recommended amounts of these nutrients;
28	(e)(c) the action of these nutrients on the body actions of nutrients in the human body;



1	(f)(d) the effects of deficiencies in these nutrients; or effects of deficiencies or excesses of nutrients
2	on the human body;
3	(g)(e) foods and supplements that are good sources of essential nutrients. foods, herbs, and dietary
4	supplements that are sources of essential nutrients for the human body; or
5	(f) principles of self-care and a healthy relationship with food.
6	(10) "General supervision" means the qualified supervisor is onsite and present where nutrition care
7	services are provided or is immediately available to the supervisee providing the services by means of
8	electronic communications, maintains continual involvement in the appropriate aspects of patient care, and has
9	primary responsibility for all nutrition care services rendered by a supervisee.
10	(11) "Licensed dietitian nutritionist" means an individual who is licensed as a licensed dietitian
11	nutritionist pursuant to the provisions of 37-25-302(1).
12	(6)(12)— _"Licensed nutritionist" means a nutritionist licensed under this chapter. "Licensed nutrition
13	specialist" means an individual who is licensed as a nutrition specialist pursuant to the provisions of 37-25-
14	<u>302(2).</u>
15	(13) "Licensed nutritionist" means an individual who is licensed as a nutritionist under this chapter prior
16	to [the effective date of this act].
17	(14) "Medical nutrition therapy" means nutrition care services provided for the treatment or
18	management of a disease or medical condition. The term includes the provision of any part or all of the
19	following services:
20	(a) interpreting anthropometric, biochemical, clinical, and dietary data in acute and chronic disease
21	states and recommending or ordering nutrient needs based on the dietary data, including but not limited to tube
22	feedings and parenteral nutrition;
23	(b) food and nutrition counseling, including prescription drug interactions;
24	(c) developing, managing, and maintaining appropriate standards of quality in food service operations
25	with functions in nutrition care, including operations connected with health care facilities as defined in 50-5-101,
26	implicated in the ordering, preparation, or serving of therapeutic diets, or otherwise utilized in the management
27	or treatment of diseases or medical conditions; and
28	(d) medical weight control.



1	(15) "Medical weight control" means medical nutrition therapy for the purpose of reducing, maintaining,
2	or gaining weight.
3	(16) "Nutrition" means the science of food and nutrients, including the action, interaction, and balance
4	of food and nutrients in relation to health and disease and the process by which humans ingest, absorb,
5	transport, utilize, and excrete food substances.
6	(7)(17) "Nutrition assessment" means the evaluation of nutritional needs of individuals and groups
7	based on appropriate biochemical, anthropometric, physical, and dietary data in order to determine nutrient
8	needs and to recommend appropriate nutritional intake, including both enteral and parenteral nutrition means
9	the ongoing, dynamic, and systematic process of obtaining, verifying, and interpreting biochemical,
10	anthropometric, physical, nutrigenomic, and dietary data to make decisions about the nature and cause of
11	nutrition-related problems and make nutrition diagnoses and recommendations, including enteral and
12	parenteral nutrition. The mere collection of data itself does not constitute nutrition assessment.
13	(18) "Nutrition care services" means the provision of any part or all of the following services within a
14	systematic process:
15	(a) assessing and evaluating the nutritional needs of individuals and groups and determining
16	resources and constraints in the practice setting, including ordering laboratory tests to check and track nutrition
17	status, creating dietary plans and orders, and monitoring the effectiveness of the dietary plans and orders;
18	(b) establishing priorities, goals, and objectives that meet nutritional needs and are consistent with
19	available resources and constraints;
20	(c) providing nutrition counseling in health and disease;
21	(d) developing, implementing, and managing nutrition care systems;
22	(e) evaluating, making changes in, and maintaining appropriate standards of quality in food and
23	nutrition services; and
24	(f) ordering therapeutic diets.
25	(8)(19) "Nutrition counseling" means providing assistance and advice to individuals or groups in the
26	selection of food and other sources of nutrients to achieve appropriate nutritional intake, based on:
27	(a) the nutrition assessment;
28	(b) the composition of food and other sources of nutrients; and



1	(c) meal preparation consistent with cultural background and socioeconomic status. a supportive
2	process, characterized by a collaborative counselor-patient relationship with individuals or groups, to establish
3	food and nutrition priorities, goals, and individualized action plans and general physical activity guidance that
4	acknowledge and foster responsibility for self-care to treat an existing condition or promote health.
5	(20) "Nutrition diagnosis" means identifying and labeling nutritional problems managed and treated by
6	a dietitian nutritionist or nutrition specialist. The term does not include the medical differential diagnosis of the
7	health status of an individual.
8	(21) "Nutrition intervention" means purposefully planned actions and nutrition counseling intended to
9	positively change a nutrition-related behavior, risk factor, environmental condition, or aspect of the health status
10	for an individual.
11	(9) (22) "Nutritionist" means:
12	(a) a person licensed under this chapter; or
13	(b) a person who has satisfactorily completed a baccalaureate and master's or a doctoral degree in
14	the field of dietetics, food and nutrition, or public health nutrition conferred by an accredited college or
15	university."Nutrition monitoring and evaluation" means identifying patient outcomes relevant to a nutrition
16	diagnosis and comparing the outcomes with the patient's previous health status, intervention goals, or
17	reference standards to determine the progress made in achieving desired outcomes of nutrition care and
18	whether planned interventions should be continued or revised.
19	(23) "Nutritionist" means an individual licensed under this chapter as a licensed dietitian nutritionist,
20	licensed nutritionist, or licensed nutrition specialist.
21	(24) "Onsite supervision" means the qualified supervisor is onsite and present in the department or
22	facility where nutrition care services are provided, is immediately available to the supervisee providing the
23	services, maintains continual involvement in the appropriate aspects of patient care, and has primary
24	responsibility for all nutrition care services rendered by a supervisee.
25	(25) "Patient" means an individual with a disease, illness, injury, or other medical condition for which
26	nutrition interventions are an essential component of standard care.
27	(26) "Practice of dietetics and nutrition" means the integration and application of scientific principles
28	derived from the study of food, nutrition, biochemistry, metabolism, nutrigenomics, physiology, food



1	management, and from behavioral and social sciences in achieving and maintaining health throughout the life
2	span. The primary functions of the practice of dietetics and nutrition include the provision of medical nutrition
3	therapy as disease management or to treat or rehabilitate an illness, injury, or condition and the provision of
4	other nutrition care services to promote health and wellness and as a primary prevention of chronic disease.
5	(27) (a) "Qualified supervisor" means, when supervising the provision of medical nutrition therapy by a
6	supervisee, an individual who is either:
7	(i) a registered dietitian nutritionist or certified nutrition specialist;
8	(ii) a dietitian, dietitian nutritionist, nutritionist, or other qualified nutrition professional licensed or
9	certified under the laws of any other state whose legally prescribed scope of practice includes the provision of
10	medical nutrition therapy, or an individual licensed under this chapter as a dietitian nutritionist, nutritionist, or
11	nutrition specialist; or
12	(iii) a health care provider licensed or otherwise authorized by any U.S. state or territory to provide
13	nutrition care services for the treatment or management of a disease or medical condition.
14	(b) A qualified supervisor must be licensed in this state if supervising an applicant providing medical
15	nutrition therapy to an individual in this state.
16	(c) When supervising the provision of nutrition care services by a supervisee that do not constitute
17	medical nutrition therapy, a gualified supervisor is an individual who either meets the requirements of this
18	subsection (27)(a) or all of the following requirements:
19	(i) has been regularly employed or self-employed in the field of clinical nutrition for at least 3 of the
20	last 5 years immediately preceding commencement of the applicant's supervised practice experience; and
21	(ii) holds a masters or doctoral degree with a major course of study in dietetics, human nutrition, foods
22	and nutrition, community nutrition, public health nutrition, naturopathic medicine, nutrition education, nutrition,
23	nutrition science, clinical nutrition, applied clinical nutrition, nutrition counseling, nutrition and functional
24	medicine, nutritional biochemistry, nutrition and integrative health, or an equivalent course of study as approved
25	by the board conferred by either:
26	(A) a regionally accredited college or university in the United States; or
27	(B) an institution outside of the United States and its territories with the supervisor's doctoral degree
28	validated by the board as equivalent to the doctoral degree conferred by a regionally accredited college or



1	university in the United States.
2	(d) Qualified supervisors may provide supervision only for those clinical activities or nutrition care
3	services for which they are qualified and have been authorized to perform.
4	(28) "Registered dietitian" or "registered dietitian nutritionist" means an individual who is credentialed
5	as a registered dietitian or a registered dietitian nutritionist by the commission on dietetic registration that
6	authorizes the individual to use the title "registered dietitian" or "registered dietitian nutritionist" and the
7	abbreviation "RD" or "RDN".
8	(29) "Telehealth" means the use of electronic information and telecommunications technologies to
9	provide services under this chapter to support clinical health care, patient and professional health-related
10	education, public health, and health administration between a licensee in one location and an individual in
11	another location.
12	(30) "Therapeutic diet" means a diet intervention prescribed by a physician or other authorized
13	nonphysician practitioner that provides food or nutrients through oral, enteral or parenteral routes as part of the
14	treatment of disease or clinical conditions to modify, eliminate, decrease, or increase identified micronutrients
15	and macronutrients in the diet."
16	
17	Section 3. Section 37-25-201, MCA, is amended to read:
18	"37-25-201. Powers and duties of board. In addition to all other powers and duties conferred and
19	imposed on the board by Title 37, chapter 1, and this chapter, the board shall adopt rules that set professional,
20	practice, and ethical standards for licensed nutritionists licensed dietitian nutritionists and licensed nutrition
21	specialists, and other rules as may be necessary for the administration of this chapter."
22	
23	Section 4. Section 37-25-301, MCA, is amended to read:
24	"37-25-301. Scope of dietetic-nutrition practice. Only a nutritionist can provide the following
25	services:
26	(1) assessing the nutrition needs of individuals and groups and determining resources and constraints
27	in the practice setting;
28	(2) establishing priorities and objectives that meet nutritive needs and are consistent with available



1	resources and constraints;
2	(3) providing nutrition counseling for any individual;
3	(4) developing, implementing, and managing nutrition care systems; and
4	(5) evaluating, adjusting, and maintaining appropriate standards of quality in food and nutrition
5	services. (1) Unless otherwise exempted under this chapter, only a licensed dietitian nutritionist, licensed
6	nutritionist, or licensed nutrition specialist can provide medical nutrition therapy.
7	(2) An individual licensed under this chapter shall provide nutrition care services using evidence-
8	based practice in clinical and community settings.
9	(3) An individual licensed under this chapter may accept or transmit verbal, delegated, or
10	electronically transmitted orders from a referring provider consistent with applicable laws and rules, including
11	any protocols established to implement medical nutrition therapy.
12	(4) An individual licensed under this chapter may order patient or resident diets, including therapeutic
13	diets, in accordance with the provisions of subsections (4)(a) through (4)(c). Oral therapeutic diets may be
14	ordered by an individual licensed under this chapter. Enteral and parenteral therapeutic diets and associated
15	nutrition-related services may only be ordered, initiated, or performed by an individual licensed under this
16	chapter who also meets one of the following criteria:
17	(a) the individual is a registered dietitian nutritionist;
18	(b) the individual is a certified nutrition support clinician credentialed by the national board of nutrition
19	support certification; or
20	(c) the individual meets other requirements as determined by the board, consistent with competencies
21	necessary for evaluating, ordering, and administering enteral and parenteral nutrition.
22	(5) Nothing in this section may be construed to limit the ability of any other licensed health care
23	provider in this state to order therapeutic diets, provided the ordering of therapeutic diets falls within the scope
24	of the individual's license.
25	(6) An individual licensed under this chapter may order medical laboratory tests related to nutritional
26	therapeutic treatments consistent with state law.
27	(7) An individual licensed under this chapter may implement prescription drug dose adjustments for
28	specific disease treatment protocols within the limits of their knowledge, skills, judgment, and current evidence-



1	based clinical practice guidelines as indicated in a facility approved protocol and as approved and delegated by
2	the licensed prescriber. This does not allow licensees to prescribe or initiate drug treatment. An individual
3	licensed under this chapter may be authorized to prescribe vitamin and mineral supplements or discontinue
4	unnecessary vitamins and minerals."

6	Section 5. Section 37-25-302, MCA, is amended to read:
7	"37-25-302. Licensing requirements. (1) An applicant for licensure as a licensed nutritionist shall file
8	a written application with the board and demonstrate to the board that the person is registered by the
9	commission.
10	(2) An applicant shall pay an application fee set by the board. (1) An applicant for licensure as a
11	dietitian nutritionist shall file a written application on forms prescribed by the board showing the applicant meets
12	all of the following requirements:
13	(a) is of good moral character and at least 18 years of age;
14	(b) pays an application fee set by the board; and
15	(c) is currently registered in good standing by the commission on dietetic registration as a registered
16	dietitian nutritionist or registered dietitian.
17	(2) (a) An applicant for licensure as a nutrition specialist shall file a written application on forms
18	prescribed by the board showing the applicant meets all of the following requirements:
19	(i) is of good moral character and at least 18 years of age;
20	(ii) pays an application fee set by the board; and
21	(iii) submits proof the applicant has received a master's degree or doctoral degree from a regionally
22	accredited college or university in the United States or has an academic degree from a college or university in a
23	foreign country that has been validated as equivalent by the board, with all of the following:
24	(A) a major course of study in human nutrition, food and nutrition, community nutrition, public health
25	nutrition, nutrition education, nutrition, nutrition science, clinical nutrition, applied clinical nutrition, nutrition
26	counseling, nutrition and functional medicine, nutritional biochemistry, nutrition and integrative health, or a
27	comparable major course of study as determined by the board, or a doctoral degree or validated foreign
28	equivalent in a field of clinical health care; and

16	supervision of a qualified supervisor as defined in 37-25-102(27). Qualified supervisors shall provide onsite
17	supervision of an applicant's supervised practice experience in the provision of medical nutrition therapy and
18	provide general supervision of an applicant's provision of other nutrition care services that do not constitute
19	medical nutrition.
20	(c) The applicant shall meet one or both of the following criteria:
21	(i) The applicant must have successfully passed the certification examination for nutrition specialists
22	administered by the board for certification of nutrition specialists or the diplomate of the American clinical board
23	of nutrition examination administered by the American clinical board of nutrition.
24	(ii) The applicant must hold a valid current certification with the board for certification of nutrition
25	specialists that authorizes the applicant to use the title "certified nutrition specialist" or the abbreviation "CNS"
26	or a valid current certification with the American clinical board of nutrition that authorizes the applicant to use
27	the title "diplomate, American clinical board of nutrition" or the abbreviation "DACBN"."

2	"37-25-304. Exemptions from licensure requirements. This chapter does not prevent:
3	(1) a student or intern in an approved academic program or a paraprofessional with approved dietetic-
4	nutrition training from engaging in the practice of dietetics-nutrition if a licensed nutritionist is available for direct
5	supervision and if the student, intern, or paraprofessional does not represent to the public that the individual is a
6	nutritionist;
7	(2) a licensed physician or nurse from engaging in the practice of dietetics-nutrition when it is
8	incidental to the practice of that profession;
9	(3) a person licensed under any other law from engaging in the profession or business for which the
10	person is licensed if the person does not represent to the public that the person is a nutritionist;
11	(4) an educator or adviser employed by a nonprofit agency acceptable to the board or by an
12	accredited degree-granting institution or an accredited elementary or secondary school from engaging in an
13	activity within the scope of the individual's salaried position;
14	(5) a person employed by or under contract with an agency of the state or federal government from
15	discharging an official duty if the person does not represent to the public that the person is a nutritionist;
16	(6) a person from furnishing general nutritional information, including dissemination of literature, as to
17	the use of food, food materials, or dietary supplements or from engaging in the explanation as to the use of
18	foods or food products, including dictary supplements, in connection with the marketing and distribution of
19	those products if the person does not represent to the public that the person is a nutritionist;
20	(7) a person from furnishing general nutrition information or disseminating literature if the person does
21	not represent to the public that the person is a dietitian or a nutritionist; or
22	(8) a person from fulfilling state or federal regulations governing the delivery or provision of nutritional
23	health services to hospitals or long-term care facilities if the person does not represent to the public that the
24	person is a nutritionist. (1) Provided an individual does not purport to be licensed to provide medical nutrition
25	therapy or refer to themself as a licensed dietitian nutritionist, licensed nutritionist, or licensed nutrition
26	specialist, or otherwise use words or letters in connection with the individual's name in violation of 37-25-305,
27	this chapter does not prevent:
28	(a) an individual licensed to teach from the teaching of dietetics and nutrition within the scope of the

13	(i) under a program of instruction approved in writing by one of the following:
14	(A) a licensed dietitian nutritionist, licensed nutritionist, or licensed nutrition specialist licensed under
15	this chapter;
16	(B) a dietitian nutritionist or nutritionist certified or licensed under the laws of another state that has
17	requirements no less stringent to the licensure requirements for licensed dietitian nutritionists or licensed
18	nutrition specialists under this chapter as determined by the board;
19	(C) a registered dietitian nutritionist; or
20	(D) a certified nutrition specialist; or
