11	the departm	ent of public health and human services a hospital community benefit assessment no later than	
12	June 29 of fiscal years 2021, 2022, and 2023. All proceeds from the assessment must be deposited into the		
13	general fund.		
14	(2)	For the purposes of this section, "hospital" means a facility licensed as a hospital pursuant to Title	
15	50, chapter 5, and does not include a critical access hospital, a children's psychiatric hospital, or the Montana		
16	state hospital.		
17	(3)	The following amounts are imposed as the annual community benefit assessment:	
18	(a)	for Advanced Care Hospital in Billings, \$122,000;	
19	(b)	for Benefis Health System in Great Falls, \$696,600;	
20	(c)	for Billings Clinic, \$835,300;
