10	NEW SECTION. Section 1. Indigent funeral assistance. (1) (a) There is a special revenue account
11	within the state special revenue fund established in 17-2-102 to aid counties in providing adequate burial,
12	entombment, or cremation of an indigent person.
13	(b) There must be deposited in the account money received from donations to provide adequate
14	burial, entombment, or cremation of an indigent person as defined in 53-3-116(5).
15	(c) Money in the account is statutorily appropriated, as provided in 17-7-502, to the department of
16	administration and may only be used for those purposes provided in this section.
17	(2) (a) A county may request to receive funding from the special revenue account created in this
18	section to provide assistance for the burial, entombment, or cremation of an indigent person regardless of
19	whether the county currently provides an indigent assistance program as provided in 53-3-116.
20	(b) A county may not use the funding provided in this section to cover amounts prohibited in 53-3-
21	116(7).
22	(3) The department of administration may adopt rules to implement this section.

24	Section 2. Section 17-7-502, MCA, is amended to read:
25	"17-7-502. Statutory appropriations definition requisites for validity. (1) A statutory
26	appropriation is an appropriation made by permanent law that authorizes spending by a state agency without
27	the need for a biennial legislative appropriation or budget amendment.
28	(2) Except as provided in subsection (4), to be effective, a statutory appropriation must comply with

 - (4) There is a statutory appropriation to pay the principal, interest, premiums, and costs of issuing, paying, and securing all bonds, notes, or other obligations, as due, that have been authorized and issued pursuant to the laws of Montana. Agencies that have entered into agreements authorized by the laws of Montana to pay the state treasurer, for deposit in accordance with 17-2-101 through 17-2-107, as determined by the state treasurer, an amount sufficient to pay the principal and interest as due on the bonds or notes have statutory appropriation authority for the payments.
