9	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

11	Section 1. Section 70-1-522, MCA, is amended to read:
12	"70-1-522. Certain restrictions on parking restrictions of first-responder vehicles and on
13	political free speech contrary to public policy enforcement prohibited definitions. (1) A person,
14	homeowners' association, property owners' association, corporation, or other private entity may not, as a
15	condition of property ownership within the jurisdiction of the private entity or by other means,:
16	(a) prohibit a resident from parking an authorized emergency vehicle, a police vehicle, or a highway
17	patrol vehicle in a parking space in which the resident is allowed to park a vehicle; or
18	(b) prohibit the placement of a sign advocating the election, appointment, or defeat of a candidate for
19	public office or the passage or defeat of a ballot issue on:
20	(a)(i) property belonging to individual or joint property owners who authorize the placement of the
21	sign; or
22	(b)(ii) common areas in which an owner owns an undivided interest.
23	(2) A person, homeowners' association, property owners' association, corporation, or other private
24	entity may impose limits on the size of signs allowed to be displayed within the jurisdiction of the private entity
25	and may regulate the location of sign placement and the time period during which signs may be displayed.
26	(3) An ordinance, covenant, contract term, or other provision, whether agreed to or not between the
27	homeowners' association, property owners' association, corporation, or other private entity and the owner or
28	tenant, contrary to subsection (1), is contrary to the public policy of this state. A court may not enforce the terms
