6	A JOINT RESOLUTION OF THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE STATE OF
7	MONTANA APPLYING FOR A CONVENTION OF THE STATES UNDER ARTICLE V OF THE
8	CONSTITUTION OF THE UNITED STATES.

10	WHEREAS, the founders of our Constitution empowered state legislators to be guardians of liberty
11	against future abuses of power by the federal government; and
12	WHEREAS, the federal government has created a crushing national debt through improper and
13	imprudent spending; and
14	WHEREAS, the federal government has invaded the legitimate roles of the states through the
15	manipulative process of federal mandates, most of which are unfunded to a great extent; and
16	WHEREAS, the federal government has ceased to live under a proper interpretation of the Constitution
17	of the United States; and
18	WHEREAS, it is the solemn duty of the states to protect the liberty of our people particularly for the
19	generations to come by proposing amendments to the Constitution of the United States through a convention
20	of the states under Article V for the purpose of restraining these and related abuses of power.

22	NOW, THEREFORE, BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF
23	THE STATE OF MONTANA:
24	Section 1. The Legislature of the State of Montana hereby applies to Congress, under the provisions of
25	Article V of the Constitution of the United States, for the calling of a convention of the states limited to proposing
26	amendments to the Constitution of the United States that impose fiscal restraints on the federal government,
27	limit the power and jurisdiction of the federal government, and limit the terms of office for its officials and for
28	members of Congress.

Section 2. The secretary of state is hereby directed to transmit copies of this application to the
President and Secretary of the United States Senate and to the Speaker and Clerk of the United States House
of Representatives and to the members of the United States Senate and the United States House of
Representatives from this State and also to transmit copies of this application to the presiding officers of each
of the legislative houses in the several states, requesting their cooperation.

Section 3. This application constitutes a continuing application in accordance with Article V of the
Constitution of the United States until the legislatures of at least two-thirds of the several states have made
