8	AMENDMENT TO ARTICLE VII, SECTION 2, OF THE MONTANA CONSTITUTION TO REMOVE

12	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

14	Section 1. Article VII, section 2, of The Constitution of the State of Montana is amended to read:		
15	"Section 2. Supreme court jurisdiction. (1) The supreme court has appellate jurisdiction and may		
16	issue, hear, and determine writs appropriate thereto. It has original jurisdiction to issue, hear, and determine		
17	writs of habeas corpus and such other writs as may be provided by law.		
18	(2) It has general supervisory control over all other courts.		
19	(3) It may make rules governing appellate procedure, and practice and procedure for all other courts,		
20	admission to the bar and the conduct of its members. Rules of procedure shall be subject to disapproval by the		
21	legislature in either of the two sessions following promulgation.		
22	(4) Supreme court process shall extend to all parts of the state."

24	NEW SECTION. Section 2. Two-thirds vote required. Because [section 1] is a legislative proposal		
25	to amend the constitution, Article XIV, section 8, of the Montana constitution requires an affirmative roll call vote		
26	of two-thirds of all the members of the legislature, whether one or more bodies, for passage.

28	NEW SECTION. Section 3. Effective Date. [This act] is effective on approval by the electorate.
