14	"10-1-10	010. Appointment of acting officials. (1) When an elected official is ordered to military		
15	service, an actin	ng official must be appointed as provided in this section if:		
16	(a)	the elected official is precluded pursuant to federal law from performing the official duties of the		
17	office; or			
18	(b)	the elected official requests the appointment of an acting official.		
19	(2)	If an acting official is appointed, the acting official shall take any oath of office required to		
20	assume the office, shall exercise all the rights, powers, and duties vested in the office, and must be provided			
21	with all the employment rights and benefits associated with the position until the elected official is restored to			
22	office pursuant t	to 10-1-1008(5) or the elected official's term expires, whichever occurs first.		
23	(3)	(a) The governor shall appoint the acting official for any office elected by the state at large and		
24	for the office of o	district judge, public service commissioner, or any other elected regional or district office of the		
25	state.			
26	(b)	An acting official for a legislative district must be appointed using the procedures in 5-2-402.		
27	(c)	The board of county commissioners shall appoint the acting official for any elected office of a

- 2 (4) For any elected office not covered under subsection (3), the governing body shall determine 3 the method by which an acting official may be appointed pursuant to this section.

  5 exceed the unexpired term for the office and subject to the right of the elected official to be restored to the office
  6 upon returning from the military service, as provided in 10-1-1008(5)."

- 8 **Section 2.** Section 13-12-207, MCA, is amended to read:
- 9 "13-12-207. Order of placement. (1) The order on the ballot for state and federal offices must be as follows:
  - (a) If the election is in a year in which a president of the United States is to be elected, in spaces separated from the balance of the party tickets by a line must be the names and spaces for voting for candidates for president and vice president. The names of candidates for president and vice president for each political party must be grouped together.
- 15 (b) United States senator;
  - (c) United States representative;
- 17 (d) governor and lieutenant governor;
- 18 (e) secretary of state;
- 19 (f) attorney general;
- 20 (g) state auditor;
- 21 (h) state superintendent of public instruction;
- 22 (i) public service commissioners;
- 23 (j)(i) clerk of the supreme court;
- 24 (k)(i) chief justice of the supreme court;
- 25 (I)(k) justices of the supreme court;
- 26 (m)(l) district court judges;
- 27 (n)(m) state senators;

1 (2) The following order of placement must be observed for county offices: 2 clerk of the district court; (a) 3 county commissioner; (b) 4 (c) county clerk and recorder; 5 (d) sheriff; 6 coroner; (e) 7 (f) county attorney; 8 (g) county superintendent of schools; 9 (h) county auditor; 10 (i) public administrator; 11 (j) county assessor; 12 (k) county treasurer; 13 (l) surveyor: 14 (m) justice of the peace. 15 (3)The secretary of state shall designate the order for placement on the ballot of any offices not 16 on the above lists, except that the election administrator shall designate the order of placement for municipal, 17 charter, or consolidated local government offices and district offices when the district is part of only one county. 18 (4) Constitutional amendments must be placed before statewide referendum and initiative 19 measures. "13-37-216. Limitations on contributions -- adjustment. (1) (a) Subject to adjustment as provided for in subsection (3) and subject to 13-35-227 and 13-37-219, aggregate contributions for each election in a

- 9 (i) a contribution to a candidate includes contributions made to any political committee organized 10 on the candidate's behalf; and
  - (ii) a political committee that is not independent of the candidate is considered to be organized on the candidate's behalf.
- 13 (2) All political committees except those of political party organizations are subject to the 14 provisions of subsection (1). Political party organizations may form political committees that are subject to the 15 following aggregate limitations, adjusted as provided for in subsection (3) and subject to 13-37-219, from all 16 political party committees:
- for candidates filed jointly for the offices of governor and lieutenant governor, not to exceed \$100,000;
  - (b) for a candidate to be elected for state office in a statewide election, other than the candidates for governor and lieutenant governor, not to exceed \$75,000;
  - (c) for a candidate for public service commissioner, not to exceed \$15,000;
- 22  $\frac{\text{(d)}(c)}{\text{(d)}}$  for a candidate for the state senate, not to exceed \$3,000;
- 23 (e)(d) for a candidate for any other public office, not to exceed \$2,000.
- (3) (a) The commissioner shall adjust the limitations in subsections (1) and (2) by multiplying each limit by an inflation factor, which is determined by dividing the consumer price index for June of the year prior to the year in which a general election is held by the consumer price index for June 2021.
- 27 (b) The resulting figure must be rounded up or down to the nearest:
- 28 (i) \$10 increment for the limits established in subsection (1); and

- 3 (4) A candidate may not accept any contributions, including in-kind contributions, in excess of the 4 limits in this section.
  - (5) For the purposes of applying the limits in this section if the contributions were received by a joint fundraising committee, a contribution must be construed to be:
    - from the person who originally contributed funds to the joint fundraising committee; and (a)
- 8 (b) received by the candidate participant to whom the funds were allocated by the joint fundraising 9 committee as provided in 13-37-211.
  - For purposes of this section, "election" means the general election or a primary election that (6)involves two or more candidates for the same nomination. If there is not a contested primary, there is only one election to which the contribution limits apply. If there is a contested primary, then there are two elections to which the contribution limits apply."

**Section 4.** Section 13-37-240, MCA, is amended to read:

"13-37-240. Surplus campaign funds. (1) A candidate shall dispose of any surplus funds from the candidate's campaign within 120 days after the time of filing the closing campaign report pursuant to 13-37-228. In disposing of the surplus funds, a candidate may not contribute the funds to another campaign, including the candidate's own future campaign, or use the funds for personal benefit. A successful candidate for a statewide elected or legislative office or for public service commissioner may establish a constituent services account as provided in 13-37-402. The candidate shall provide a supplement to the closing campaign report to the commissioner showing the disposition of any surplus campaign funds.

(2) For purposes of this section, "personal benefit" means a use that will provide a direct or indirect benefit of any kind to the candidate or any member of the candidate's immediate family."

**Section 5.** Section 69-1-103, MCA, is amended to read:

"69-1-103. Composition of commission. (1) The commission shall consist of five members, who shall-must be qualified electors of the district from which they are elected appointed, with each such-member

2	(2) The members of the commission must be appointed by the governor for each district and		
3	confirmed by the senate.		
4	(3) (a) There is a public service commission nomination advisory committee consisting of:		
5	(i) four legislators appointed by the president of the senate and the speaker of the house of		
6	representatives; and		
7	(ii) three legislators appointed by the minority leader of the senate and the minority leader of the		
8	house of representatives.		
9	(b) The committee shall evaluate and submit no fewer than three candidates in each district for the		
10	governor's consideration in making appointments to the commission.		
11	(4) (a) When appointing commissioners, the governor shall consider persons who have 5 years or		
12	more experience practicing law in the state, or persons in science, technology, engineering, and math fields,		
13	public accounting, or property and utility valuation and finance professions. Commissioners must have a		
14	bachelor's degree from an accredited university, be a representative of the general public, and have a general		
15	knowledge of the laws governing and administering the department of public service regulation and the purpose		
16	of the commission.		
17	(b) A person is not eligible to be appointed if the person has been employed with an entity or an		
18	affiliated company of an entity that is subject to regulation by the commission within 5 years from the date when		
19	the person's term on the commission begins.		
20	(c) A person is not eligible for appointment unless the person has resided in the state 2 years		
21	immediately before appointment."

24	"69-1-104. Public service commission districts. (1) In this state there are five public service		
25	commission districts, with one commissioner elected from each district, distributed as follows:

27	Basin, Liberty, McCone, Musselshell, Petroleum, Phillips, Pondera, Richland, Roosevelt, Sheridan, Toole,

3	a successor is elected and qualified. At the biennial election following the occurrence of any vacancy in the
4	commission, there must be elected one member to fill out the unexpired term for which the vacancy exists.
5	(2) (a) When a vacancy occurs, if the former incumbent represented a party eligible for primary
6	election under 13-10-601, the person appointed by the governor must be a member of the same political party
7	and must be selected by the governor as provided in subsections (3) and (4).
8	(b) If the former incumbent was an independent or was originally nominated from a party that does
9	not meet the requirements of 13-10-601, the governor shall appoint an individual to the vacant position within
10	45 days of receiving notification from the secretary of state of the vacancy.
11	(3) Within 7 days of being notified of a vacancy as described in 2-16-501, the secretary of state shall
12	notify the governor and, if the former incumbent represented a party eligible for primary election under 13-10-

14	(4) (a) Upon receipt of a notification of a vacancy, the state party central committee notified pursuant
15	to subsection (3) has 30 days to forward to the governor a list of three prospective appointees, each of whom
16	must be a resident of the district represented by the former incumbent.
17	(b) If the governor does not select an appointee from the list forwarded pursuant to subsection (4)(a)
18	within 15 days, the central committee shall, within 15 days, forward a second list of three prospective
19	appointees, each of whom must be a resident of the district represented by the former incumbent. The second
20	list may not contain a name submitted on the first list. Within 15 days of receipt of the second list, the governor
21	shall select an appointee from either list.
22	(2) If the senate is not in session, the appointment is subject to confirmation during the next
23	session. An appointment to fill a vacancy is for the unexpired term for which the vacancy exists."

"69-1-107. Presiding officer of commission. A presiding officer must be selected by the commission from its membership at the first meeting of each <u>odd-numbered</u> year <del>after a general election</del>."

17	NEW SECTION. Section 12. Codification instruction. [Section 10] is intended to be codified as an				
18	integral part of Title 69, chapter 1, part 1, and the provisions of Title 69, chapter 1, part 1, apply to [section 10].

20	NEW SECTION. Section 13. Severability. If a part of [this act] is invalid, all valid parts that are				
21	severable from the invalid part remain in effect. If a part of [this act] is invalid in one or more of its applications,				
22	the part remains in effect in all valid applications that are severable from the invalid applications.

24	NEW SECTION. Section 14. Effective date. [This act] is effective on passage and approval.

26	NEW SECTION. Section 15. Termination. [Section 11] terminates July 1, 2027.
