9	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

11	NEW S	SECTION. Section 1. Article VIII of The Constitution of the State of Montana is amended by
12	adding a new section 18 that reads:	
13	Sectio	n 18. Return of excess revenue to taxpayers. (1) As soon as is practicable after
14	adjournment si	ne die of a regular session of the legislature, the governor shall cause an estimate to be
15	prepared of revenues that must be received by the general fund for the biennium beginning July 1 of the year of	
16	the regular legislative session.	
17	(2)	As soon as is practicable after the end of the biennium, the governor shall cause actual
18	collections of revenues received by the general fund for that biennium to be determined.	
19	(3)	If the revenues received from general fund revenue sources during the biennium exceed the
20	amount estimated to be received from the sources for the biennium by 10% or more, the total amount of the	
21	excess must be returned to Montana resident taxpayers as determined by law.	
22	(4)	The legislature may enact laws:
23	(a)	establishing a tax credit, refund payment, or other mechanism by which the excess revenues
24	are returned to	Montana resident taxpayers and establishing related administrative procedures; and
25	(b)	permitting a taxpayer's share of excess revenues to be offset by any liability of the taxpayer for
26	which the state is authorized to undertake collection efforts.	
27	(5)	Prior to the close of a biennium for which an estimate described in subsection (1) has been
28	made, the legislature, by a two-thirds majority vote of all members elected to each house, may enact legislation

1 declaring an emergency and increasing the amount of the estimate prepared pursuant to subsection (1). 2 This section does not apply if, for a biennium or any portion of a biennium, a state tax is not 3 imposed on or measured by the income of individuals. 4 5 NEW SECTION. Section 2. Two-thirds vote required. Because [section 1] is a legislative proposal 6 to amend the constitution, Article XIV, section 8, of the Montana constitution requires an affirmative roll call vote 7 of two-thirds of all the members of the legislature, whether one or more bodies, for passage. 8 9 NEW SECTION. Section 3. Effective date. [This act] is effective January 1, 2025. 10 11 NEW SECTION. Section 4. Submission to electorate. [This act] shall be submitted to the qualified 12 electors of Montana at the general election to be held in November 2024 by printing on the ballot the full title of 13 [this act] and the following: 14 []YES on Constitutional Amendment . 15 []NO on Constitutional Amendment \_\_\_\_\_. 16 - END -
