4	A BILL FOR AN ACT ENTITLED: "AN ACT SUBMITTING TO THE QUALIFIED ELECTORS OF MONTANA AN
5	AMENDMENT TO ARTICLE XII OF THE MONTANA CONSTITUTION TO CREATE THE MENTAL HEALTH
6	TRUST FUND; PROVIDING FOR THE PROTECTION OF THE TRUST FUND IN THE AMOUNT OF \$50

14	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

16	NEW SECTION. Section 1. Article XII of The Constitution of the State of Montana is amended by
17	adding a new section 5 that reads:
18	Section 5. Mental health trust fund. (1) The legislature shall provide for a fund to be known as the
19	mental health trust fund of the state of Montana that is to be funded as provided by law.
20	(2) The principal of the mental health trust fund must forever remain inviolate in an amount of fifty
21	million dollars (\$50,000,000) unless appropriated by vote of a majority of the members of each house of the
22	legislature for the state's mental health priorities.
23	(3) The interest and income generated from the mental health trust fund may be appropriated by a
24	majority vote of each house of the legislature to fund the state's mental health priorities as provided by law.
25	(4) The principal and the interest and income generated from the mental health trust fund may be
26	appropriated for other measures by a vote of two-thirds of all the members of the legislature.

28	NEW SECTION. Section 2. Two-thirds vote required. Because [section 1] is a legislative proposal
