Board of Nursing Home Administrators

Board = 6 voting members appointed by the governor with consent of the Senate. Three members must be nursing home administrators; 1 is a public member at least 55 years of age or older at appointment, and 2 members of professions or institutions concerned with the care of chronically ill and infirm aged patients. The latter members may not be of the same profession or have a financial interest in a nursing home. The director of the Department of Public Health and Human Services is an ex officio, nonvoting member of the board. A term is 5 years. (term expiration in parentheses)

Scope of Practice (based on definition)

A Nursing Home Administrator: "administers, manages, supervises, or is in general administrative charge of a long-term care facility, whether the individual has an ownership interest in the facility and whether the individual's functions and duties are shared with one or more other individuals". (37-9-101(4), MCA)

2011 Legislation Impacting Board or Profession

- HB 94, sponsored by Rep. Arntzen at the request of the Department of Labor and Industry, generally revises reciprocity and other board functions. (Became law)
