MAR 2014 Issue No 13 (July 10, 2014) At page 1505 of the 2014 MAR, the DOJ issued a NOTICE OF ADOPTION AND AMENDMENT regarding the adoption of one new rule (23.16.106) concerning the electronic submission of documents and the amendment of ARM 23.16.101, 23.16.508, 23.16.1102, 23.16.1103, 23.16.1201, 23.16.1202, 23.16.1225, 12.16.1705, 23.16.1929, 23.16.3501 and 23.16.3801 dealing with various types of games such as, card game tournaments, sports pools, and carnival games. The proposed amendments also reflect proposed definition changes, machine repair rules, and rules dealing with changes in managers and officers with respect to the gaming industry. At the hearing held on June 12, 2014, oral comments were received supporting the proposed rules.

MAR 2014 Issue No 12 (June 26, 2014) At page 1392 of the 2014 MAR, the DOJ issued a NOTICE OF ADOPTION regarding the adoption of three new rules pertaining to school crossing guards. The department received two comments of support for the proposed rules.
