A RESOLUTION

WHEREBY THE CHIPPEWA CREE BUSINESS COMMITTEE HEREBY SUPPORTS THE INVOLVEMENT OF THE STONE CHILD COLLEGE AND THE ROCKY BOY HEALTH BOARD IN THE FIGHT AGAINST SUICIDE BY ESTABLISHING A SUICIDE PREVENTION TASKFORCE.

WHEREAS, the Chippewa Cree Business Committee is the governing body of the Chippewa Cree Tribe of the Rocky Boy's Indian Reservation, Montana, by the authority of the Constitution and By-Laws of the Chippewa Cree Tribe approved on the 23rd day of November, 1935; and

WHEREAS, pursuant to their inherent sovereignty and Constitution and By-Laws of the Chippewa Cree Tribe, the Chippewa Cree Business Committee is charged with the duty to promote and protect the health, security, and general welfare of the Chippewa Cree Tribe; and

WHEREAS, the Chippewa Cree Tribal Community has been experiencing an alarmingly high rate of suicide among its people; and

WHEREAS, the Chippewa Cree Business Committee shall appoint the following individuals: Mike Geboe, Dustin Whitford, Jonathan Eagleman, Merle Tendoy, and Calvin Jilot to serve on the suicide prevention taskforce; and

WHEREAS, the Chippewa Cree Tribal Community continue to fight against this issue and continue to seek a prevention to this problem; and

WHEREAS, the tribal governmental and private organizations report that the Chippewa Cree Tribe is providing unique and innovative programs to address suicide, given inadequate resources; and

WHEREAS, these same organizations believe that the Chippewa Cree Tribe should lead the way for other tribes with a national suicide intervention program; and

WHEREAS, Stone Child College has placed its facility and programs at the disposal of the Chippewa Cree Tribe to seek funding resources, develop model programs, and supplement tribal resources in the battle against suicide; and

NOW THEREFORE BE IT RESOLVED: the Chippewa Cree Business Committee hereby supports the involvement of the Stone Child College and the Rocky Boy Health Board in the fight against suicide by establishing a suicide prevention taskforce.


